Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dependable Home Health Care, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024, December 31, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period January 1, 2024 through August 31, 2024 and for the year ended December 31, 2023, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024, December 31, 2023 and December 31, 2022, and for the period January 1, 2024 through August 31, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Basis for Opinion

As discussed in Note H to the financial statements, the trustees of Dependable Home Health Care, Inc. 401(k) Savings Plan resolved on October 7, 2023 to merge the Plan into the Team Public Choices 401(k) Savings Plan effective January 1, 2024. All plan assets were transferred to the control of the Team Public Choices 401(k) Savings Plan on August 31, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

The accompanying financial statements of Dependable Home Health Care, Inc. 401(k) Savings Plan (the Plan) have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

2. Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date.

Purchases and sales are recorded on the trade date. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

As described in the Accounting Standards Codification ("ASC"), 946, *Financial Services – Investment Companies*, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of August 31, 2024, December 31, 2023 and December 31, 2022.

4. Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investments of the balance in their accounts in the specific investment funds made available by the Plan administrator. At August 31, 2024, December 31, 2023 and December 31, 2022, all investments were participant directed.

5. Payment of Benefits

Benefits are recorded when paid.

6. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B – DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering eligible employees of Dependable Home Health Care, Inc. (the Employer). An employee is eligible to participate in salary reduction contributions and employer contributions upon reaching age 21 and completing one year of service. A year of service, as defined, is a consecutive 12-month computation period in which an employee has 1,000 or more hours of service. Each employee meeting minimum eligibility requirements can enter the Plan on January 1 or July 1 following satisfaction of eligibility requirements.

NOTE B – DESCRIPTION OF THE PLAN - CONTINUED

1. General - Continued

The Employer is responsible for appointing the Plan administrator and trustee of the Plan. The trustee has discretionary powers in executing investment transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The operating costs are shared by the Employer and participants. Reasonable administrative and investment expenses of the Plan may be paid by the Plan to the extent not paid by the Employer.

Effective January 1, 2024, the Plan was amended to merge into Team Public Choices 401(k) Savings Plan (Note H).

2. Contributions

The Plan allows participants to contribute up to 100% of their eligible compensation, as defined in the Plan, subject to limits imposed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

The Employer makes a Safe Harbor Matching Contribution equal to 100% on the first 3% of employee deferrals plus 50% on the next 2% of employee deferrals. The Safe Harbor Matching Contribution is paid each payroll. The Employer may also make a non-elective contribution to the Plan. The non-elective contribution is at the discretion of the Employer. Non-elective contributions are allocated to participants based on each participant's compensation in proportion to compensation for all participants. There were no non-elective contributions made during the period January 1, 2024 through August 31, 2024, and year ended and December 31, 2023.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's safe harbor matching and non-elective contributions, and (b) investment income or loss on investments less administrative expenses. Allocations are based on participant compensation or account balances, as defined.

Changes in a participant's deferral percentage for future contributions may be made each pay period during the Plan year. Reallocation of participant investments among the investment options available may be made at any time during the Plan year.

4. Vesting

Participants immediately vest in their employee contributions. They are also 100% vested in Employer safe harbor contributions. Participants vest in all other Employer contributions at a rate of 20% after two years of service, with an additional 20% per year vested thereafter until the employee is 100% vested after six years of service. A participant is 100% vested upon attainment of normal retirement age, death or disability.

5. Payment of Benefits

Upon termination of service, death, disability, retirement, or any reason permitted under the hardship regulations, a participant may elect to receive either a lump sum distribution or installment payments equal to the participant's vested account balance. Participants with balances of \$1,000 or less are subject to involuntary lump sum distributions. If the participant's account balance is between \$1,000 and \$5,000, the Plan requires the balance to be automatically rolled into a qualified IRA account. The Plan allows for in-service distributions upon attainment of age 59 1/2.

6. Notes Receivable from Participants

Notes receivable to participants are permitted up to the lesser of one-half of their vested balance or a maximum of \$50,000 for each participant. Participants are limited to have one outstanding loan at any given time. Loans bear interest at a rate of the prime rate of interest published by the Wall Street Journal plus 2% as of the date of the loan. Payments are made at least quarterly through payroll deductions over the loan term, not to exceed 5 years or up to fifteen years for the acquisition of a principal residence.

7. Forfeited Accounts

Forfeited accounts may be used to defray the cost of administrative expenses of the Plan or reduce future employer contributions. As of August 31, 2024, December 31, 2023 and December 31, 2022, the balance of unapplied forfeitures of non-vested accounts is approximately \$0, \$2,900 and \$7,100, respectively. Forfeitures used to reduce employer contributions and pay Plan expenses totaled approximately \$2,900 and \$4,200 during the period January 1, 2024 through August 31, 2024 and the year ended December 31, 2023, respectively.

8. Risks and Uncertainties

The Plan is comprised of a combination of investments. Investments are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE D – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024, December 31, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides an investment option issued by the Standard Insurance Company that simulates the performance of a guaranteed investment contract. The Standard maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The contract meets the FBRIC criteria and, therefore, is reported at contract value. Contract value is the relevant measure for a FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE F – FEDERAL INCOME TAXES

The Volume Submitter Sponsor obtained its latest advisory letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended to meet IRS requirements since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. There are no reconciling differences between the financial statements and the Form 5500 as of August 31, 2024, December 31, 2023 and December 31, 2022, and for the period January 1, 2024 through August 31, 2024 and year ended December 31, 2023.

The Plan's policy is to evaluate the likelihood that any uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS, generally for three years after they were filed.

NOTE G – PARTY-IN-INTEREST TRANSACTIONS

Standard Insurance Company is the custodian of the Plan, holds the Plan's investments, is the Plan's record-keeper, and executes the Plan's transactions. Tax Sheltered Compensation, Inc. is the third-party administrator. LPL Financial is the Plan's financial advisor.

NOTE H – PLAN MERGER

Dependable Home Health Care, Inc. was acquired by TEAM Public Choices in June of 2023, and as a result, the trustees of the Plan approved the merger of the Plan with Team Public Choices 401(k) Plan via a Plan amendment effective January 1, 2024. As a result, the Plan was frozen as of December 31, 2023.

Legal title and responsibility of all participant accounts and underlying assets of approximately \$2,144,400 were liquidated and transferred to the Team Public Choices 401(k) Savings Plan on August 30, 2024. As a result, the statement of net assets as of August 31, 2024, reflects \$0 remaining in asset holdings.

NOTE I – ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees to the custodians and third-party administrator. The Plan also pays all other administrative expenses, such as professional fees, to the extent not paid by the Employer on behalf of the Plan. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

NOTE J – SECURE ACT 2.0

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as “SECURE Act 2.0”. SECURE Act 2.0 contains over 90 new retirement provisions continuing the reforms that began with the 2019 SECURE Act. These provisions have varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan’s 2024 or 2023 financial statements.

NOTE K – SUBSEQUENT EVENTS

The Company has evaluated subsequent events through October 11, 2024, the date which the financial statements were available to be issued.
