Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ideal Ready Mix Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter—Plan Termination and Liquidation Basis

As discussed in Note 4 to the financial statements, the Board of Directors of Ideal Ready Mix Company, Inc., the Plan's sponsor, voted on February 20, 2024 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the year ended April 30, 2023 financial statements to the liquidation basis of accounting used in presenting the period ended November 30, 2024 and year ended April 30, 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of April 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Plan Description

The following brief description of the Ideal Ready Mix Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by Ideal Ready Mix Company, Inc. covering substantially all employees of Ideal Ready Mix Company, Inc. and its affiliated entity, L&W Quarries, Inc. (the Companies) who are 18 years of age or older and who have completed 60 days of service. Entry dates are the first of the month coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan including the selection and monitoring of the Discretionary Investment Manager. The Trustees have engaged Wilshire as a 3(38) Discretionary Investment Manager to manage the Plan's investment lineup by monitoring investment performance, reviewing investment offerings under the Plan and making changes to the offerings within the Plan.

Effective February 22, 2024, the Plan was terminated. See Note 4 to the financial statements for further details.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Participants may contribute a percentage of pretax annual compensation as defined in the plan document, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The deferral rate for those participants who are auto enrolled will be increased 1% each year on the first day of the Plan year up to a maximum of 10% of eligible compensation, unless they affirmatively elect otherwise. Effective May 1, 2023, the Plan was amended to increase the maximum deferral rate for the automatic increase to 12% of eligible compensation.

The Companies may also make discretionary matching and profit sharing contributions to the Plan. In order to be eligible for discretionary contributions, employees must complete one year of service with 1,000 hours of service. For the year ended April 30, 2024, the Companies elected to make discretionary matching contributions of \$1.00 per hour worked up to a maximum of 2,080 hours for eligible participants who made salary deferral contributions of at least \$1.00 per hour. The Companies also elected to make discretionary profit sharing contributions of \$0.20 per hour worked, up to a maximum of 2,080 hours, for all eligible participants for the year ended April 30, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Subsequent to the Plan's effective termination on February 22, 2024, no participant or employer contributions were allowed into the Plan.

Participant accounts: Each participant's account is credited with the participant's contributions, the Companies' discretionary matching and profit sharing contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' discretionary matching and profit sharing contribution portion of their account plus actual earnings thereon is based on years of continuous service as follows:

Further, a participant also becomes 100% vested upon attaining the early retirement age of 55, or if employment is terminated due to disability or death.

As a result of the decision to terminate the Plan during the Plan year ended April 30, 2024, all participants became fully vested in their account balance on February 22, 2024.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range from one to five years or up to 20 years for the purchase of a primary residence. Loans will bear a commercially reasonable rate of interest established by the Administrator that is based on the Prime Rate plus 1% at the time of loan issuance. The loans are secured by the balance in the participant's account. The interest rates applicable to outstanding notes as of April 30, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Participants may also make principal reduction payments outside of payroll deductions. There were no outstanding notes as of November 30, 2024.

Note 1. Plan Description (Continued)

Payment of benefits: Distributions may be made after a participant's retirement, termination of service, death, disability, reaching age 59½ or approved hardship. Distributions are made in the form of lump-sum payments or installments over a period of time as defined in the Plan equal to the value of their vested account. If the participant's vested account balance does not exceed \$1,000, then the participant will receive their benefit as a mandatory cash out lump-sum payment. Benefits are recorded when paid.

Distributions pursuant to the Plan termination will be paid at the participants' election by (a) cash distribution of the participant's account balance; (b) rollover distribution to an eligible retirement plan; or (c) a combination of cash distribution and rollover distribution to an eligible retirement plan; Distributions paid as a result of the plan termination effective February 22, 2024 totaled \$70,986 during the year ended April 30, 2024. The remaining assets of the Plan of \$10,035,268 were distributed to participants in the Plan during the period ended November 30, 2024.

Forfeitures: At April 30, 2024 and 2023, there was no ending balance in the forfeited nonvested accounts. Forfeitures of \$8,082 were used during the year ended April 30, 2024 to reduce discretionary matching contributions. The Plan did not have any forfeitures during the period ended November 30, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: Due to the decision to terminate the Plan during the Plan year ended April 30, 2024, management determined that liquidation of the Plan is imminent and the financial statements for the period ended November 30, 2024 and the year ended April 30, 2024 have been prepared using the liquidation basis of accounting. The Plan year ended April 30, 2023 financial statements were prepared as a going concern on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: All investments included in the year ended April 30, 2024 statement of net assets available for benefits are reported at liquidation value. For all investments, fair value and contract value approximates the amount the Plan expects to collect at liquidation.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

All investments included in the year ended April 30, 2023 statement of net assets available for benefits are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Administrative expenses: Certain administrative functions applicable to the Plan are performed by employees of the Companies. No such employees receive compensation from the Plan. Administrative expenses may be paid by the Companies or the Plan, at the Companies' discretion.

Subsequent events: Plan management has evaluated subsequent events through December 19, 2024, the date the financial statements were available to be issued.

Note 3. Information Certified by Plan Custodians

The following is a summary of the Plan's asset information as of and for the period ended November 30, 2024, and as of and for the year ended April 30, 2024 and as of the year ended April 30, 2023, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (collectively, Principal), the custodians, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodians that information provided to the Plan Administrator by the custodians related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and ERISA-required supplemental schedule, related to the following assets:

Note 4. Plan Termination

In February 2024, the Plan Sponsor adopted a formal Plan Amendment to terminate the Plan effective February 22, 2024. As a result, management determined that liquidation was imminent for the period ended November 30, 2024 and year ended April 30, 2024 financial statements. All participants became fully vested in their account balance as of February 22, 2024. All of the Plan assets were distributed by August 29, 2024, with substantially all checks clearing by November 30, 2024.

Note 5. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 6. Fair Value Measurements (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the period ended November 30, 2024, and the year ended April 30, 2024.

Mutual funds: Valued based on the quoted prices in the active markets on which they are traded.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan in the pooled separate accounts as determined by the third-party administrator based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Investments in Insurance Contracts

The Plan has a traditional investment contract (Fixed Income Guaranteed Option) with Principal, which is a guaranteed investment contract. Principal is contractually obligated to repay principal and interest at a specified interest rate that is guaranteed to the Plan, which was 4.65% and 4.05% as of April 30, 2024 and 2023, respectively. The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Companies or other events of the Companies (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

The termination of the Plan did not limit the Plan's ability to transact at contract value with participants. The impact is not material to the financial statements as of April 30, 2024.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 8. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by Principal. Principal is the custodian of the Plan and, therefore, transactions with these investments qualify as party-in-interest transactions. Fees paid by the Plan for investment management and member requested services and participant loan fees amounted to \$29,432 and \$25,610 for the period ended November 30, 2024 and year ended April 30, 2024, respectively.
