### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Avalon Precision Casting Company, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 25, 2022 (in liquidation) and December 31, 2021, and the related statement of changes in net assets (in liquidation) available for benefits for the period from January 1, 2022 to August 25, 2022, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Voya Retirement Insurance and Annuity Company, the custodian of the Plan, a qualified institution, as of August 25, 2022 and December 31, 2021, and for the period from January 1, 2022 to August 25, 2022, stating that the certified investment information, as identified in Note C to the financial statements, is complete and accurate.

### Opinion

### **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note G to the financial statements, the Board of Directors of Sigma Electric Manufacturing Corporation (the Company) of the Plan approved a plan termination effective January 1, 2022, and management determined liquidation is imminent in 2022. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the financial statements as of and for the period ended August 25, 2022. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### **NOTE A - DESCRIPTION OF PLAN**

The following brief description of Avalon Precision Casting Company, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The following description of the Plan represents information to the Plan termination date. Subsequent to the termination date, many of the features and options of the Plan became unavailable to participants.

#### **General**

The Plan was a defined contribution plan covering all employees of Avalon Precision Casting Company, LLC, a subsidiary of Sigma Electric Manufacturing Corporation (the Company, Plan Sponsor, and Plan Administrator) who completed three months of service as defined by the Plan and who were not covered by a collective bargaining agreement, were not leased employees, and were not non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Participants were able to elect to defer a minimum of 1% up to 100% of their compensation as defined by the Plan on either a pre-tax or after-tax basis. Employees who had not declined participation in the Plan or completed a salary deferral agreement to participate in the Plan were automatically enrolled in the Plan as of the date of their eligibility with a pre-tax deferral rate of 3% and their contributions were invested in a fund designated by the Plan Administrator until changed by the participant. Additionally, the deferral rate for those participants automatically enrolled increased by 1% per year on January 1, up to a maximum of 10%. The Plan provided for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code). The Plan also provided for catch-up contributions for participants who reach the age of 50 by the end of the Plan year.

The Plan also provided for a discretionary employer matching contribution, an additional matching contribution true-up, and a discretionary profit-sharing contribution. In order to receive an allocation of the profit-sharing contribution, the employee must have completed at least 1,000 hours of service during the Plan year and be employed by the Company on the last date of the Plan year. No discretionary profit sharing contributions were made to the Plan for the period ended August 25, 2022.

Participants directed the investment of their contributions into various options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account was credited with the participant's contributions and the Company's discretionary matching, additional qualified non-elective contributions, and true-up contributions, as well as an allocation of the Company's discretionary profit sharing contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based upon participant account earnings, account balances, specific participant transactions, or compensation, as defined. The benefit to which a participant was entitled to receive was the benefit that could be provided from the participant's vested account balance.

#### **Vesting**

Participants were immediately vested in their deferral and rollover contributions and qualified non-elective contributions, plus actual earnings thereon. Safe harbor employer matching contributions made prior to January 1, 2016 plus actual earnings thereon vested 100% upon completion of two years of continuous service. Vesting in the discretionary employer matching, true-up, and profit sharing contributions plus actual earnings thereon was based on years of continuous service at a rate of 20% per year. Due to the Plan termination disclosed in Note G, the participants became 100% vested in their account balances.

#### **Notes Receivable from Participants**

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance subject to certain Department of Labor and IRS requirements. Notes receivable terms ranged from 1 to 5 years or up to a maximum of 15 years for the purchase of a primary residence. Notes receivable were secured by the balances in the participants' accounts and bore interest at the prime rate plus 1.00%. Principal and interest were paid ratably through bi-weekly payroll deductions.

#### **Payment of Benefits**

Upon termination of service (for any reason other than death) or attainment of age 59½, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account balance. Upon the death of a participant, the participant's balance had to be distributed by December 31 of the calendar year of the fifth anniversary of the participant's death, unless the beneficiary elected another optional form of payment under the Plan such as annuity payments over the life expectancy of the beneficiary. If the value of the vested benefits credited to the participant's account was \$1,000 or less at the time of termination, the entire account would be automatically distributed to a participant without the participant's consent. In the event of a mandatory distribution of amounts greater than \$1,000 but not exceeding \$5,000, the entire amount would be distributed in the form of a direct rollover to an individual retirement account as designated by the Plan Administrator.

#### **Payment of Benefits (Continued)**

Active participants could elect hardship withdrawals from their pre-tax elective deferral account balances, subject to Plan provisions.

During 2020, the Plan elected to allow eligible participants to request coronavirus-related distributions and suspended required minimum distributions from the Plan between March 27 and December 31, 2020 in accordance with the provisions of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act). The coronavirus-related distributions could be repaid in one or more contributions to the Plan over a 3-year period commencing on the date the distribution was received.

#### **Forfeited Accounts**

Forfeitures were used to reduce future discretionary employer contributions or to pay Plan expenses. Unallocated forfeiture balances were \$-0- and \$14,926 at August 25, 2022 and December 31, 2021, respectively.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

As discussed in Note G, the Board of Directors of the Company terminated the Plan effective January 1, 2022. As a result, the Plan changed its basis of accounting for the period as of January 1, 2022 from the going concern basis to the liquidation basis.

The statement of net assets available for benefits as of December 31, 2021 was prepared using the accrual basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

#### **Investment Valuation**

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the custodian. See Note D for discussion of fair value measurements.

#### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. No allowance for credit losses was recorded as of August 25, 2022 and December 31, 2021. If a participant ceased to make repayments on a note receivable and the Plan Administrator deemed the note receivable to be uncollectible, the balance on the note receivable from the participant was reclassified to benefits paid to participants.

#### **Investment Income Recognition**

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

#### **Contributions**

Contributions were recorded and credited to each participant's account when received by the custodian from the Company. Any contributions attributable to the Plan period but not received by custodian by the last day of the Plan period were recorded as a receivable.

#### **Payment of Benefits**

Benefits were recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of benefits paid to participants and notes receivable from participants were charged directly to the participants' accounts and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments on the accompanying statement of changes in net assets (in liquidation) available for benefits.

#### **Income Taxes**

The Company adopted a volume submitter profit sharing plan with a cash or deferred arrangement which received an opinion letter from the IRS dated March 31, 2014 stating that the Plan was designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan was currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### **Subsequent Events**

The Plan has evaluated subsequent events through January 22, 2025, the date which the financial statements were available to be issued.

### **NOTE C - CERTIFICATION**

Investment information disclosed in the accompanying financial statements, including investments held at August 25, 2022 and December 31, 2021, and net depreciation in the fair value of investments for the period from January 1, 2022 to August 25, 2022 were obtained by management and agreed to or derived from information certified as complete and accurate by the custodian.

### **NOTE D - FAIR VALUE MEASUREMENTS**

The three levels of the fair value hierarchy, which are based upon the inputs used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities (for example, exchange quoted prices).

Level 2 - Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Pooled separate accounts (Note E) were valued at the net asset values of units held by the Plan at year end. The net asset values, as provided by the custodian, were used as a practical expedient to estimate fair values. The net asset values were based on quoted market prices of the underlying investments, net of insurance company fees and expenses less their liabilities. This practical expedient was not used when it was determined to be probable that the accounts would sell the investments for amounts different than the reported net asset values.

The guaranteed investment contract (Note F) was valued at fair value due to the pending liquidation of the contract at December 31, 2021. The fair value was estimated by discounting the related cash flows based on the weighted average of certain Barclays Fixed Income Indices as defined in the contract. The fair value measurement was sensitive to changes in the Barclays Fixed Income Indices.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in different fair value measurements as of the reporting date.

### **NOTE E - POOLED SEPARATE ACCOUNTS**

The Plan had investments in Voya Retirement Insurance and Annuity Company's (VRIAC) pooled separate accounts. There were no restrictions on transfers or withdrawals from these accounts. The investment strategies of pooled separate accounts with a balance in excess of 5% of total assets as of December 31, 2021 were as follows:

JPMorgan Equity Income Fund - Class R6 Shares seeks capital appreciation and current income by investing at least 80% of the fund's assets in the equity securities of corporations that regularly pay dividends, including common stocks and debt securities and preferred stock convertible to common stock.

PGIM Total Return Bond Fund - Class R6 seeks total return through a mix of current income and capital appreciation as determined by the fund's subadvisor. It invests, under normal circumstances, at least 80% of the fund's investable assets in bonds which include all fixed-income securities, other than preferred stock, with a maturity at date of issue of greater than one year.

T.Rowe Price Blue Chip Growth Fund - I Class seeks long-term capital growth with income as a secondary objective. The fund achieves this by investing at least 80% of its net assets (including any borrowings for investment purposes) in the common stocks of large and medium-sized blue chip growth companies.

Vanguard Target Retirement 2025, 2030, and 2035 Funds - Investor Shares seek to provide capital appreciation and current income consistent with their current asset allocation by investing in Vanguard mutual funds according to an asset allocation strategy designed for investors planning to retire and leave the workforce in or within a few years of the target years.

Fidelity 500 Index Fund - Normally investing at least 80% of assets in common stocks included in the S&P 500 Index, which broadly represents the performance of common stocks publicly traded in the United States.

### **NOTE F - GUARANTEED INVESTMENT CONTRACT**

The Plan had a traditional guaranteed investment contract with VRIAC in 2021 with a balance of \$382,506 at December 31, 2021. The contract was terminated in 2022. Contributions from the Plan were maintained in VRIAC's general account. Under the contract, the Plan owned a promise by the issuer to repay principal and interest at crediting rates which were announced in advance and declared on an annual basis. The crediting rate was based on a formula established by the contract issuer, but may not be less than 1 percent. The crediting rate was reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations to the Plan might have been affected by future economic and regulatory developments.

As of December 31, 2021, the contract was reported at fair value due to the pending liquidation of the contract which resulted in a market value adjustment upon liquidation.

Effective August 25, 2022, the contract with VRAIC was terminated and all Plan assets were merged into a qualified retirement plan sponsored by the Company. Upon termination, a market value adjustment of a \$7,224 decrease was incurred in 2022 under the terms of the contract.

Plan level transactions were subject to a restriction of 20% of the unallocated balance within the account as of January 1 of the calendar year. VRIAC could have terminated the contract at any time after 5 years from the date the contract became effective, which was November 5, 2013, with notice of 90 days.

### **NOTE G - PLAN TERMINATION**

On January 1, 2022, the Board of Directors of the Company adopted an amendment to terminate the Plan, effective June 30, 2022 (the Termination Date). As a result of this action, participants became 100% vested in their account balances. As of the Termination Date, no employees were eligible to enter the Plan, no further contributions were made to the Plan, and no further deferral contributions were deducted from employee paychecks. The Plan's assets were transferred to another plan sponsored by the Company upon liquidation as of August 25, 2022.

### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE I - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions included the investment in the funds of VRIAC, the related interest income, and the payment of administrative expenses by the Plan. Such transactions are exempt from being prohibited transactions.

VRIAC and LPL Financial, investment advisor, provided certain administrative services to the Plan. VRIAC received revenue for these services at crediting rates per investment ranging from 0.82% to 1.65% of the pooled separate accounts' balances. These fees reduced the rate of return credited to the Plan for these investments and were netted within net depreciation in fair value of investments on the statement of changes in net assets (in liquidation) available for benefits. This revenue was used to pay LPL Financial and any remaining amounts were periodically allocated to participants at the discretion of the Plan Sponsor.

Effective August 25, 2022, in connection with the termination further described in Note G, the Plan transferred \$5,785,642 of assets consisting of \$21,162 of notes receivable from participants, \$95,436 of employer contributions receivable, and \$5,669,044 of investments to a new plan sponsored by the Company.

### **NOTE J - DELINQUENT PARTICIPANT CONTRIBUTIONS**

As required by ERISA Section 2510.3-102, the Company was required to segregate participant contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which amounts are withheld from wages.

During 2017, the Company did not timely remit participant contributions totaling \$1,079 and did not remit an additional \$593 in participant contributions during 2017. As of August 25, 2022, \$1,630 in elective deferrals and also the lost earnings for these contributions have not been remitted to the Plan.

During 2018, the Company did not timely remit participant contributions totaling \$1,140. As of August 25, 2022, \$1,140 in elective deferrals and also the lost earnings for these contributions have not been remitted to the Plan.

During 2019, the Company did not timely remit participant contributions totaling \$310. As of August 25, 2022, \$310 in elective deferrals and also the lost earnings for these contributions have not been remitted to the Plan.

During 2021, the Company did not timely remit participant contributions totaling \$3,868. As of August 25, 2022, \$3,868 in elective deferrals and also the lost earnings for these contributions have not been remitted to the Plan.
