Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Employee Benefit Plan of Goodwill Industries of Dallas, Inc. (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022 (in liquidation), and the related statements of changes in net assets available for benefits for the years then ended (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

General

The Employee Benefit Plan of Goodwill Industries of Dallas, Inc. (Plan) is a noncontributory defined benefit pension plan covering employees of Goodwill Industries of Dallas, Inc. (Organization). The Organization serves as the Plan administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was amended effective December 31, 2020 to stipulate that no employee is eligible to become a new participant, benefit accrual service shall not be credited for any service or employment for any participant, no unvested participant will become 100% vested as a direct result of the particular amendment, and final average earnings shall not include any compensation earned by any participant after December 31, 2020.

Plan Termination

The Organization's Board of Directors approved a resolution on October 28, 2020 to freeze the Plan effective December 31, 2020, with the intent to terminate the Plan subject to certain conditions. The Plan was amended effective September 1, 2021 to facilitate the termination of the Plan. As a result of the plan amendment, participants became fully vested in their accounts. Participants will have the choice of receiving their benefit as an annuity, lump sum payment or a deferred benefit to be received upon retirement. If participants do not make a selection in the method of receiving their distribution, the net assets of the Plan will be distributed to the Plan's participants as a deferred benefit to be paid upon retirement. Effective March 1, 2023, the Plan liquidated the remaining assets of the Plan by purchasing annuity contracts totaling \$2,190,038, distributing lump sum payments totaling \$3,568,270, transferring \$642,853 to the Pension Benefit Guaranty Corporation (PBGC) for missing participants and returning excess assets to the plan sponsor totaling \$2,615,756.

Eligibility

Prior to the freeze of benefits described above, all employees of the Organization were eligible after one year of service, and there is no minimum age requirement to participate in the Plan.

Employer Contributions

The Organization makes contributions necessary to provide for retirement benefits on an actuarial basis, and to meet the future funding requirements of ERISA. Such contributions are designed to fund the Plan's current service costs together with the estimated accrued benefit cost arising from

qualifying service before the establishment of the Plan. The Plan has met the minimum funding requirements for the years ended December 31, 2023 and 2022.

Benefit Payments

Eligible employees are entitled to annual pension benefits beginning at normal retirement age (65) equal to 1½% of the average highest consecutive three-year annual compensation (during the last 10 years of service) for each year of participation plus ½% of the average highest consecutive three year annual compensation (during the last 10 years of service) in excess of the social security average annual taxable wage base for each year of participation up to 35 years.

Benefits are provided primarily through the purchase of annuities from Mutual of America Life Insurance Company (Mutual of America), the trustee of the Plan. Purchased annuities are contracts under which Mutual of America is obligated to pay benefits to named employees or their beneficiaries. If a vested participant dies before retirement benefits have begun, a monthly annuity is payable to an eligible spouse or, if there is no spouse and death occurs after age 55, an eligible child under the age of 19 in specified amounts as if the employee had retired on the date of death or early retirement age and elected the joint and survivor annuity with 10 years certain option (in the case of a spouse) or the 10 years certain annuity option (in the case of a child).

Vesting

A participant is credited with one year of vesting service for each Plan year in which they work 1,000 hours or more. A participant is 100% vested after completing five years of vesting service or upon attainment of age 65.

Administrative Expenses

To the extent not paid by the Plan, administrative expenses are paid by the Organization at its sole discretion.

2. Summary of Significant Accounting Policies

Basis of Accounting

As a result of the election to terminate the Plan, the accompanying financial statements have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Estimates and Assumptions

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the

changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits and changes therein at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statements of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants

Benefits are recorded when paid or when annuities are purchased.

Risks and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of market volatility resulting in changes in the value of investment securities, it is possible that changes in risks could materially affect amounts reported in the financial statements.

Contributions to the Plan and the actuarial present value of accumulated plan benefits are calculated and reported based on certain assumptions pertaining to interest rates, inflation rates and employee compensation and demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near-term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements.

3. Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

- Level 1 Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

- Level 2 Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

- Level 3 Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates or assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Fund

The money market fund is valued using \$1 for the net asset value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments held by the Plan are measured using Level 1 inputs and consist of money market funds at December 31, 2022 totaled \$9,288,979.

4. Tax Status

The Internal Revenue Service (IRS) issued a determination letter dated March 30, 2018 stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (Code) and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

5. Information Certified by the Plan's Trustee (Unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by Mutual of America, the trustee and party-in-interest as defined by ERISA, as of December 31, 2023 and 2022 and for the years then ended, except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule.

6. Actuarial Present Value of Accumulated Plan Benefits

Due to the Plan liquidating all assets of the Plan effective March 1, 2023, no valuation of the accumulated plan benefits was performed for the year ended December 31, 2023.

Accumulated plan benefits are those future periodic payments that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) terminated employees or their beneficiaries and (b) present employees or their beneficiaries.

Benefits payable under all circumstances – retirement, death and termination of employment – are included to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided by annuity contracts already purchased are excluded from accumulated plan benefits.

The actuarial present value of accumulated benefits is determined by an actuary from Mutual of America and is the amount which results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death or retirement) between the valuation date and the expected date of payment.

Actuarial valuations are determined at January 1 of each Plan year. Had the valuations been performed as of December 31, there would be no material differences.

The significant actuarial assumptions used in the valuation as of January 1, 2022 were (a) life expectancy of participants (IRS 2022 Static Distinct Mortality Table for males and females before retirement and 2022 Unisex Distinct Mortality Table specified in IRS notice 2020-85 for after retirement), (b) retirement age assumptions (age 65) and (c) an assumed effective rate of return on the Plan's assets of 5.59%. These actuarial assumptions are based on the presumption that the Plan will continue.

7. Related Party and Party-In-Interest

Certain Plan investments are managed by Mutual of America, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

8. Subsequent Events

Plan management has evaluated subsequent events through December 13, 2024, the date the financial statements were available to be issued, and concluded that no additional disclosures are required.
