Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Magnitude 7 Metals 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 22, 2024 (in Liquidation) and December 31, 2023 (Ongoing), and the related statements of changes in net assets available for benefits for the period ended May 22, 2024 (in Liquidation) and the year ended December 31, 2023 (Ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 22, 2024 and December 31, 2023, and for the period ended May 22, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Directors of Magnitude 7 Metals, LLC, the Plan's sponsor, voted on March 1, 2024, to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the December 31, 2023 financial statements to the liquidation basis used in presenting the May 22, 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1. Description of the Plan

General and Plan Termination

The following description of Magnitude 7 Metals 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

The Plan was a defined contribution plan sponsored by Magnitude 7 Metals, LLC (“Plan Sponsor”) for the benefit of its employees who had at least one month of service. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Capital Bank and Trust Company (“CB&T”) was the custodian. Empower Retirement, as outsourced from American Funds, was the recordkeeper.

On March 1, 2024, the Plan Sponsor approved the termination of the Plan, and Plan amendment became effective on that day. As of this date, no additional employees could become eligible, no further contributions were allowed, and all employees were fully vested in the Plan. The Plan was fully liquidated as of May 22, 2024.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions were also permitted. The Company could make discretionary matching contributions in an amount equal to a percentage determined by the Company.

The Company made matching contributions of 50% of employees’ salary deferral amounts on the first 8% from January 1, 2023 through September 30, 2023. Effective October 1, 2023 and through May 22, 2024, the Company stopped making matching contributions of employees’ salary deferral amounts.

Participant Investment Account Options

Investment account options available included various funds. Each participant had the option of directing their contributions into any of the separate investment accounts and could change the allocation daily.

Participant Accounts

Each participant’s account was credited with the participant’s contribution, the Company’s contribution and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefits to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company’s contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was fully vested after five years of continuous service. The nonvested balance was forfeited upon termination of service. Forfeitures were used to reduce Company contributions.

Payment of Benefits

Upon termination of service, an employee could elect to receive either a lump-sum amount equal to the value of his account, partial withdrawal, or installment, as defined. At May 22, 2024 and December 31, 2023, there were no amounts allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan but have not yet been paid.

Forfeited Accounts

At May 22, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$34,610, respectively. These accounts could have been used to reduce future employer contributions. During 2024, \$127,969 of forfeited nonvested accounts were used to pay plan expenses and remainder were reallocated to active employees. During 2023, employer contributions were reduced by \$130,650, from forfeited nonvested accounts.

Notes Receivable from Participants

The Plan Document included provisions authorizing loans from the Plan to active eligible participants. Loans were made to any eligible participant demonstrating a qualifying need. The maximum amount of a participant's loans was determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans were covered by demand notes and were repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant was paying the loan in full. Interest on the loans was based on local prevailing rates as determined by the Plan Administrator.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying 2023 financial statements were prepared on the accrual basis of accounting. Due to the termination of the Plan, the accompanying 2024 financial statements were prepared on the liquidation basis of accounting.

This change in basis had no impact on the Plan's financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Quoted market prices, if available, were used to value investments. Mutual funds and the stable value fund were valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants before March 15, 2024.

There were no excess contributions payable for the period ended May 22, 2024.

Note 3. Certification of Plan Custodian

The Plan Administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, CB&T, a qualified institution, certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of May 22, 2024 and December 31, 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended May 22, 2024 and the year ended December 31, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, a person who owned 50% or more of such an employer, or relatives of such persons.

Certain Plan investments were managed by American Funds; therefore, these transactions qualified as party-in-interest transactions. Certain fees incurred by the Plan for investment management services were included in administrative expenses and are netted with revenue sharing payments for the year ended December 31, 2023.

The Plan incurred expenses related to general administration and recordkeeping. The Company paid certain expenses and provided certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There had been no significant changes in the valuation techniques during the period ended May 22, 2024. The Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices were available in an active market, investments were classified within Level 1 of the valuation hierarchy. Level 1 investments included mutual funds. If quoted market prices were not available, then fair values were estimated by using pricing models, quoted prices of investments with similar characteristics or discounted cash flows. Such investments were classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs were not available, investments were classified within Level 3 of the hierarchy. There were no Level 2 or Level 3 investments held by the Plan at December 31, 2023 and no investments held by the Plan at May 22, 2024.

Note 6. Tax Status

The Plan operated under a non-standardized adoption agreement in connection with a prototype defined contribution plan and trust sponsored by American Funds Distributors, Inc. This prototype Plan Document had been filed with the appropriate agency and had obtained a determination letter dated March 31, 2014, from the Internal Revenue Service, stating that the prototype was qualified under Section 401 of the Internal Revenue Code. The Plan had been amended since the prototype received the determination letter. However, the Plan Administrator believed that the Plan and related trust were designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Note 7. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could have materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

Subsequent events have been evaluated through November 11, 2024, which is the date the financial statements were available to be issued.
