Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Bazooka 401(k) Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of July 31, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through July 31, 2024 (in liquidation) and for the year ended December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of July 31, 2024 and December 31, 2023, and for the period from January 1, 2024 through July 31, 2024, and for the year ended December 31, 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, B-TDS, Inc., the sponsor of the Plan, approved a plan of liquidation in February 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to Financial Statements

1. Description of the Plan

The following brief description of The Bazooka 401(k) Savings and Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions. Effective January 29, 2022, the Plan Sponsor name changed from Topps Company, Inc. to B-TDS, Inc. and the Plan name changed from The Topps Company 401(k) Savings and Investment Plan to The Bazooka 401(k) Savings and Investment Plan.

In February 2024, the B-TDS, Inc. (the Company) elected to terminate the Plan. Effective April 19, 2024, no new participants were allowed to enter the Plan and no additional contributions were allowed to be remitted to the Plan. All participants were fully vested in their account balances, and their account balances were liquidated and distributed to participants or rolled over into a qualified plan or Individual Retirement Account by June 10, 2024.

General

The Plan was a defined contribution savings plan covering substantially all employees of the Company. Employees who were: (a) residents of Puerto Rico, (b) covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations, and/or (c) a non-resident alien with no U.S. source income from the Company were not eligible to participate in the Plan. The Company controlled and managed the operation and administration of the Plan. Capital Bank and Trust (Capital Bank) served as the trustee of the Plan. American Funds Trust Company (the Recordkeeper) served as the recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was restated effective August 1, 2015, to incorporate the requirements of the Pension Protection Act and other legislation enacted since the Plan's prior effective date, November 15, 2010. The Plan was further restated effective August 1, 2019, such that new participants may participate in the Plan upon the first of the month on or following the 60th day after they are hired and are automatically enrolled into the Plan with 2% of eligible compensation contributed to the Plan, unless the participant elects otherwise. The Plan was further restated effective January 1, 2020, such that union employees whose employment is governed by a collective bargaining agreement may participate in the Plan. The Plan was further restated effective June 8, 2021 to incorporate certain legislative and regulatory requirements.

Effective October 6, 2023, employees under the confectionery division were terminated due to the sale of the division by the Company and became employees of the purchasing company. As these employees were no longer eligible, the contributions of these employees participating in the Plan will not be accepted to the Plan after the effective date. As a result of the sale, affected participants became participants in a new defined contribution plan, and their account balances amounting to \$10,398,205 were transferred to that plan in November 2023.

Contributions

Each year, participants could contribute a percentage or a flat dollar amount of their eligible compensation, as defined in the Plan, subject to certain Internal Revenue Service (IRS) limitations. Eligible participants may contribute to the Plan upon hire. Effective August 1, 2019, eligible participants could contribute to the Plan upon the first month on or following the 60th day after they were hired and were automatically enrolled into the Plan with 2% of eligible compensation contributed to the Plan, unless the participant elected otherwise. The Company could make a

discretionary matching contribution. The Company could also make other discretionary contributions, as defined in the Plan.

For the period ended July 31, 2024 and the year ended December 31, 2023, the Company elected not to make any contributions to the Plan.

Participant Accounts

Individual accounts were maintained for each Plan participant. Each participant's account was credited with contributions and investment earnings, and was charged with investment losses, withdrawals, and an allocation of expenses paid out of the Plan. Allocations were based on participant earnings, account balances, and specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Investment Options

Participants could direct contributions in any investment options of the Plan, which were investments in mutual funds.

Vesting

Participants were 100% vested in their rollover contributions, employee pre-tax contributions, qualified matching contributions, qualified non-elective contributions, and any earnings thereon.

Notes Receivable from Participants

Participants could borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance in their accounts during the prior 12-month period. All loans were required to be repaid within five years, unless the proceeds of the loans were used for the purchase of a principal residence, in which case, the loan repayment period may not exceed ten years from the date of the loan. Additionally, the period of loan repayments could be extended for up to one year. The minimum loan amount is \$1,000. The loans bear interest at rates commensurate with local prevailing rates at loan origination, as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

A participant was eligible to receive a distribution of their vested account balance under the following circumstances: (a) termination of employment, (b) retirement, (c) disability, or (d) death. A participant also is eligible for in-service withdrawals upon the approval of the Plan Administrator. Types of in-service withdrawals available under the Plan are: (a) hardship withdrawals, (b) withdrawals after age 59½, (c) withdrawals after age 70½, (d) withdrawals after normal retirement age, and (e) withdrawals of rollover contributions. A participant receives the value of their vested account balance in the form of a single lump-sum payment.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying 2023 financial statements of the Plan have been prepared on the accrual basis of accounting.

The 2024 financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update (ASU) 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on February 14, 2024. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of the Plan's financial statements, in conformity with accounting principles generally accepted in the United States of America (GAAP), requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for a discussion of fair value measurements.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes the Plan's gains or losses on investments bought and sold, as well as held, during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are recorded at the unpaid principal balance plus accrued interest. Delinquent notes receivable are reclassified as distributions, based on the terms of the Plan document. Fees charged by the trustee relating to notes receivable from participants are paid from the participants' accounts and are included in administrative expenses and expensed when incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses related to processing fees for loans and service fees are deducted from the respective participants' accounts. Other expenses incurred in the administration of the Plan, including recordkeeping and trust fees, are paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Other investment-related expenses are included in the net appreciation in fair value of investments.

Other Income

Other income represents income from Capital Research and Management Company, which represents revenue from an agreement with Capital Bank for the sharing of certain revenue derived from investment providers. Revenue from this agreement is applied to the Plan's recordkeeping and administrative service fees, and any excess revenue is allocated to participants.

3. Information Certified by the Trustee

Certain information disclosed in the accompanying financial statements, related to investments and notes receivable from participants held as of July 31, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, and other income for the period from January 1, 2024 through July 31, 2024 and for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and December 31, 2023.

Mutual Funds - These funds are valued at their daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no financial assets that were measured at fair value on a non-recurring basis during the period from January 1, 2024 through July 31, 2024 and the year ended December 31, 2023.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments were managed by the trustee. Any purchases and sales of these funds were performed in the open market at fair value and qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain officers and employees of the Company (who may also have been participants in the Plan) perform administrative services related to the operation, recordkeeping, and financial reporting of the Plan at no cost to the Plan, as the Company paid their salaries and other administrative expenses on behalf of the Plan.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan issued notes receivable to participants, which are secured by the vested balance in the participants' accounts. Notes receivables from participants also qualify as exempt party-in-interest transactions.

6. Plan Termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. As discussed in Note 1, in February 2024, the Company elected to terminate the Plan.

7. Tax Status

The Plan uses a prototype Plan document sponsored by the Recordkeeper. The Plan has been amended and the amended pre-approved plan received an opinion letter from the IRS dated June 30, 2020, which states that the amended pre-approved Plan satisfies the applicable provisions of the Internal Revenue Code (IRC). Plan management believes that the Plan is designed and was operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

For purposes of determining the effect of subsequent events on these financial statements, management has evaluated subsequent events requiring adjustment to the financial statements or disclosures as stated herein through January 21, 2025, the date the financial statements were available to be issued. No material subsequent events were noted.
