DECEMBER 31, 2023 AND 2022

NOTE A - DESCRIPTION OF PLAN

The following description of GSPANN Technologies, Inc. (“Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on October 1, 2007, and most recently amended and restated on June 1, 2022 to bring the Plan into compliance with regulatory changes set forth in IRS Notice 2017-37 and other legal requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provides benefits for all eligible employees of the Company.

Plan administration

The Company is the Plan Administrator and retains the services of third parties to assist in the administration of the Plan. Plan’s record-keeper and administrative service provider is ADP Retirement Services, and Plan’s custodian and trustee is Reliance Trust Company.

Eligibility

All employees of the Company receiving wages in the United States and 21 years old or older, were eligible to participate in the Plan starting from the pay period following employment start date. The Plan allows eligible employees to participate in the Plan on the first day, coincident with the start of employment.

Participant contributions

Participants may elect to contribute up to 80% of their eligible compensation, as defined in the Plan, subject to the maximum allowed under section 401(k) of the Internal Revenue Code (“IRC”). Participant contributions are withheld from pre-tax payroll deductions each payroll period. In accordance with the IRC, Participant contributions were limited to \$22,500 in 2023 and \$20,500 in 2022 Plan year and remain subject to periodic adjustment by the Internal Revenue Service (“IRS”).

Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions. Participants are also permitted to deposit into the Plan distributions received from other eligible retirement plans (rollovers). Plan does not permit Roth deferrals and after-tax contributions made by a Participant at his discretion. Participants direct the investment of their account balances into various investment options offered by the Plan.

Rollover Contributions

Generally, when a Participant receives a qualified total distribution from another qualified plan as defined in the IRC of 1986 as amended, the Participant is permitted to rollover those funds into the Plan. Participants get 100% vested in the amounts contributed through rollovers.

NOTES TO FINANCIAL STATEMENTS (Contd.)

Employer contributions

The Plan Administrators have elected the Plan to be Traditional Safe Harbor 401(k) Plan. The employer makes a safe harbor matching contribution equal to 100% of the Participant's salary deferrals that do not exceed 4% of participant's compensation. Participants are eligible to receive the safe harbor contribution as of first day of the month coinciding with or next following the date after completion of twelve months of service based on 1,000 actual hours of service. This safe harbor matching contribution is 100% vested. For the years ended December 31, 2023, and 2022, the Company made total safe harbor employers matching contributions of \$412,225 and \$338,994, respectively.

Participant accounts

Each participant's account is credited with the participant's contribution, employer's contributions, and allocations of Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

Both the employer and participant contributions are directed solely through each participant's election into investment alternatives offered by the Plan. At any time, participants may also elect to reallocate existing account balances between investment alternatives or to change their investment election for future contributions. When participants fail to give investment direction after having been provided the opportunity to do so, the Plan's Fiduciary invests contributions on participants' behalf in the Qualified Default Investment Alternative. Earnings of each investment fund are allocated to participant's accounts in proportion to each participant's share of that fund.

Vesting

Participants become immediately vested in their contributions, including rollovers of funds from other qualified retirement plans and earnings thereon. Since the Plan only allows Traditional Safe Harbor Matching Contributions, participants are also immediately vested in employer contributions.

Forfeitures

Participants account balances are always 100% vested, so they never have any contributions forfeited. Upon termination of employment participants are entitled to their entire account balance. The Plan did not have any forfeitures for the years December 31, 2023 and 2022.

Notes receivable from participants

Participants may borrow from their funds accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum note amount is \$500, and participants may have no more than one note outstanding at any particular time. The loans are secured by the balance in the participant's account and bear interest at the prime rate, as published on the 14th of each month of note issuance, plus 1%, with a maximum note term of five years for personal notes or 30 years for mortgage notes.

Payment of benefits

The Plan provides for the payment of benefits to the participants (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship (as defined in the Plan), or termination of employment. Participants may elect to receive a single lump sum payment equal to the value of the participant's vested interest in his or her account, or have the payment paid as a "direct rollover" to an individual retirement account or individual retirement annuity (an "IRA") or to another employer's tax qualified plan. Participants may also elect to receive installments, request a partial withdrawal, or defer receiving payments until normal retirement age. In-service distributions of a participant's vested account balance are permitted providing the participant has attained age 59½. Unless otherwise instructed by the participant, participants with vested account balances of \$1,000 or less upon separation will receive a lump sum cash payout and participants with vested account balances ranging from \$1,000 to \$5,000 will automatically be rolled over to an individual retirement account ("IRA").

Required minimum distributions

If an employee who is more than 5% owner continues working for the Company after age 70½, the employee must begin to receive benefits by April 1 following the year in which they reach age 70½. Other employees must begin to receive benefits by April 1 following the later of the year in which they reach age 70½ or terminate employment.

Changes to the plan were made due to the SECURE Act, which was placed in operation without amending the plan. The SECURE Act allowed retirees to delay taking required minimum distributions (RMDs) until age 72 for participants in 401(k) Plan.

Administrative expenses

The Plan permits payment of Plan expenses to be made from Plan assets. If expenses are paid using the Plan's assets, then the expenses will usually be allocated among the accounts of all participants in the Plan, either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants, depending on the nature of expenses itself. Separate fees for loan and distribution processing as specified in the service agreement, are charged to individual participant's accounts. Plan auditing fees may, at the election of the Employer, be paid from the Plan's assets.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and schedule. Actual results could differ from those estimates.

Investment valuation and income recognition

Reliance Trust serves as the Plan's custodian and holds all investments of the Plan. The Plan's investments are stated at fair value. The shares of registered investment companies (mutual funds) are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. The common collective trust is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of shares held by the Plan. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note C for discussion of fair value measurements.

Fair value measurements

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*. Refer to Note C for the fair value measurement disclosures associated with the Plan's investments.

Net appreciation (depreciation) in fair value of investments

The realized gains and losses, and unrealized appreciation (depreciation) in registered investment companies are recorded in the accompanying financial statements as net realized and unrealized gain or loss on investments.

Investment management fees and operating expenses

Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair value of investments.

Notes receivable from participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest are paid ratably through payroll deductions. In the event of default, foreclosure on the note and attachment of security will not occur until a distributable event occurs for the Participant.

Subsequent events

The Plan has evaluated subsequent events through the date that the financial statements were available to be issued, which is the date of the independent auditors' report.

NOTE C – FAIR VALUE MEASUREMENTS

The Plan performs fair value measurement in accordance with ASC 820. ASC 820 defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: quoted prices in active markets for identical assets or liabilities.
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2023.

Registered Investment Companies (Mutual Funds) - Valued at a readily determinable net asset value ("NAV") of shares held by the Plan at year end. Investments in this category can be redeemed immediately without notice at the current net asset value per share as published by the Trustee based on the fair value of the underlying assets. These funds were open-ended mutual funds that are registered with the Securities and Exchange Commission. They are valued at the daily closing price as reported by the fund which are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Accordingly, these investments have been classified as Level 1.

Common Collective Trusts - Invesco Stable Asset Trust is a Collective Trust of Invesco Trust Company. The Trust's primary investment objectives are to seek the preservation of principal and to provide interest income. The Trust's investment contracts are carried at contract value which is equal to principal balance plus accrued interest plus deposits and less withdrawals. The estimated value of the collective trust funds and insurance company separate accounts is net asset value, exclusive of the adjustment to contract value, and is considered Level 2. The use of net asset value as fair value is deemed appropriate as the collective trust funds and insurance company separate accounts do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

Participant loans – Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right at any time to amend the Plan document to discontinue future matching contributions or to terminate the Plan, subject to the provisions of ERISA.

NOTE F – PARTY-IN-INTEREST TRANSACTIONS

Investments in the Plan are held by Reliance Trust Company, which is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. ADP Strategic Plan Services LLC (an ADP broker dealer) receives indirect compensation for investment management services provided to the Plan. As the DOL allows financial institutions to utilize the alternative reporting method, the Plan has elected to reflect eligible indirect compensation on a service code basis rather than a dollar amount. The eligible indirect compensation is charged to the Plan as investment-related expenses and is included in net appreciation of fair value of investments.

A portion of the Plan's administrative expenses are paid for by GSPANN Technologies Inc, the principal Plan sponsor. Other than these, the Plan has no agreements or transactions with any other party-in-interest.

NOTE G – INCOME TAX STATUS

The prototype plan adopted by the Plan sponsor obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Subsequent to receiving this determination letter, the prototype plan was amended. The Plan has not received a separate determination letter however the Plan Administrator believes that the prototype plan, as adopted by the sponsor, is operating in compliance with the requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

NOTE H – PLAN ADMINISTRATION

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. Generally, administrative expenses, other than those expenses charged directly to the Plan by the custodian, are paid directly by the Company. For the years ended December 31, 2023 and 2022, the Plan auditing fees were paid by the Company.

NOTE I – RISKS AND UNCERTAINTIES

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.
