To IRS - Department of Labor,

We recently received a letter stating that we had not filed our Form 5500 for 2023 for Modern Care Endodontics (EIN/PN 45-4525004/001). I also see that there would be a \$750 late fee attached to filing this Form 5500 now. I would like to request that the fee of \$750 be waived. I have spoken with ADP who controlled was Company's 401K plan from January 2023 thru August 2023. When we closed our account with ADP in 2023, they stated that they would be responsible for sending out an email when they had completed the necessary information to file Form 5500. We never received any such email or notification that the information was ready to review and submit. We have checked all our emails on file with ADP (verified by them) and there was never an email sent out to us indicating that we could file our Form 5500. This is why we were unable to file the Form 5500 for 2023. I believe that we therefore have reasonable cause to request this fee be waived this one time.
