## Independent Auditor's Report

To the Plan Administrator  
403(b) Thrift Plan for Employees of the Arc of the South Shore, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the 403(b) Thrift Plan for Employees of the Arc of the South Shore, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### *Opinion*

### *Basis for Opinion*

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 

### **Notes to Financial Statements June 30, 2024**

#### **Note 1 - Description of the Plan**

The following description of the 403(b) Thrift Plan for Employees of the Arc of the South Shore, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all employees of The Arc of the South Shore, Inc. (the "Company"), except for non-resident aliens. There are no age or service requirements to participate in employee contributions. Participants must complete one year of service (1,000 hours) to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan administrator along with the custodian determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's management.

##### **Contributions**

Each year, participants may contribute up to the maximum percentage of compensation and dollar amount permissible, as defined by the Plan and limited by the Internal Revenue Code ("IRC"). Participants may designate all or a portion of their salary deferral contributions as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants are automatically enrolled to defer 1% of their eligible compensation upon hire, increasing 1% each year up to 3%. Participants direct the investment of their contributions into various options offered by the Plan.

The Plan may contribute a Company matching contribution according to a discretionary percentage. However, the Company made no discretionary matching contributions for the year ended June 30, 2024. Participants also direct the investment of the Company contributions. Contributions are subject to certain limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and Plan earnings. Additionally, participants are charged with an allocation of administrative expenses. Allocations are based on participant earnings, deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus their actual earnings. In the event of death, total and permanent disability or normal retirement, participants shall become 100% vested in the Company's discretionary matching contribution portion of their account. For all other participants, vesting in the Company's discretionary matching contribution portion of their account is based on years of service, as defined by the Plan, according to the following schedule:

#### Payment of benefits

On termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of his or her account. Participants with a vested account balance less than \$1,000 will receive a mandatory distribution. For participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator, unless an election is made by the participant to receive the payment directly. Participants with a vested account balance greater than \$5,000 may receive benefits in a lump sum or defer payment of benefits until a later date.

Withdrawals from a participant's deferral contributions account may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants who have attained age 59½ are eligible to make in-service withdrawals, in accordance with the provisions specified in the Plan.

#### Notes receivable from participants

Notes receivable from participants are not allowed under the Plan.

#### Forfeitures

Forfeited non-vested amounts may be used to pay administrative expenses or offset employer contributions in accordance with the Plan. At June 30, 2024 and 2023, there were \$1,141 and \$617, respectively, of forfeited non-vested amounts available. During 2024, \$20 was used to pay administrative expenses, and no forfeitures were used to offset employer contributions.

#### Note 2 - Summary of accounting policies

##### Basis of accounting

The financial statements of the Plan have been prepared on the accrual method in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Payments of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### Subsequent events

The Plan has evaluated subsequent events through January 27, 2024, the date the financial statements were available to be issued.

### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets liabilities in active markets that the Plan has the ability to access at the date.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation of other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Pooled separate accounts:* Valued at the unit value based on the net asset value ("NAV") of the underlying mutual fund at year-end. The NAV, as provided by the fund manager, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined that the fund will sell the investment for an amount different from the reported NAV.

*Insurance company general account:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The interest accumulation account is designed to be partially benefit-responsive, but not fully benefit-responsive. The interest accumulation account provides a fixed interest rate that changes periodically. Investments in the interest accumulation account are not under a contract between the interest accumulation account and a guarantor. For these reasons, Mutual of America Life Insurance Company, the contract issuer, believes that the contract would not be considered fully benefit-responsive. Accordingly, the interest accumulation account is reported at fair value.

#### Note 4 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 5 - Tax status

The prototype plan document, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter dated November 30, 2020 in which the IRC stated that the prototype plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving its latest opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6 - Related party transactions and party-in-interest transactions

Plan investments were invested in funds managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Total administrative fees paid directly by the Plan to Mutual of America Life Insurance Company were \$2,806.

#### **Note 7 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2024 and 2023, and investment income for the year ended June 30, 2024, that are disclosed in the accompanying financial statements and Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the custodian of the Plan.

#### **Note 8 - Risks and uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain participant contributions were not remitted to the Plan within the time frame specified by Department of Labor Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended June 30, 2023. The Company will work with the third party administrator to determine the proper corrections and intends to make corrective funding during 2025.
