**NOTE A – DESCRIPTION OF THE PLAN**

The following description of the C.M.A. Benefit Club (the “Club”) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan’s provisions.

General

The Club was established in 1937 for the purpose of providing group life insurance benefits for members of the Cincinnati Musicians’ Association, the plan sponsor.

The group permanent insurance policy is carried through the Union Labor Life Insurance Company, and the insurance company assumes the associated risks and obligation to pay benefits. The allocated contract amounts are excluded from the Club financial statements.

Contributions and Benefits

Effective January 1, 1961, every new or reinstated member under age 45 of the Cincinnati Musicians’ Association (the “Association”) automatically becomes a member of the C.M.A. Benefit Club. The membership fees are \$50.00 per member, paid in quarterly installments of \$1.25 for ten years for the following life insurance policies:

5 through 9	500
10 through 14	750
15 and over	1,000

The membership fees are not collectable by the Club in the event of resignation or expulsion of the member. Therefore, the fees are recognized as income of the Club when collected by the Cincinnati Musicians’ Association. The Association periodically transfers the fees to the Club.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Club are prepared using U.S. generally accepted accounting principles and the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Payment of Benefits

Plan benefits are recorded when due. Liabilities for claims incurred are paid to the members’ beneficiary promptly when the funds are received from the third-party insurance company. Amounts due for benefit payments to beneficiaries at June 30, 2024 and 2023, were \$9,006 and \$14,215, respectively.

Expenses

Certain expenses incurred maintaining the Club are paid directly by the plan sponsor and are excluded from these financial statements.

Experience Refunds

Experience refunds from the Union Labor Life Insurance Company are recorded when received. No refunds were received by the Club during the years ending June 30, 2024 and 2023.

Allowance for Credit Losses

As of June 30, 2024 and 2023, all receivables are considered collectable. Therefore, no allowance for credit losses is considered necessary.

Subsequent Events

Subsequent events have been evaluated through January 16, 2025, which is the date the financial statements were available to be issued.

New Accounting Pronouncements

Effective April 1, 2023, the Club adopted ASU 2016-13, *Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which modifies the measurement of expected credit losses on certain financial instruments. The Club adopted this new guidance utilizing the modified retrospective transition method. Topic 326 requires measurement and recognition of expected versus incurred losses for financial assets held. Financial assets held by the Union that are subject to ASU 2016-13 include accounts receivable. The adoption of this ASU did not have a material impact on the Club's financial statements.

**NOTE C – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Cincinnati Musicians' Association, the plan sponsor, provides to the Club certain accounting and administrative services for which no fees are charged.

The Cincinnati Musicians' Association transfers funds from its Insurance Reserve Fund to the Benefit Club to cover the payment of insurance premiums. The amounts transferred were \$9,430 and \$9,205 for the years ended June 30, 2024 and 2023, respectively, including membership dues collected. As of June 30, 2024 and 2023, \$18,783 and \$18,558 respectively, were due from the Cincinnati Musicians' Association.

**NOTE D – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Club's Board of Trustees has the right to terminate the Plan, subject to the provisions set forth in the Employee Retirement Income Security Act of 1974 (ERISA).

**NOTE E – INCOME TAX STATUS**

The C.M.A. Benefit Club has received a favorable determination letter from the Internal Revenue Service for recognition of exemption from federal income taxes under section 501 (c) (4) of the Internal Revenue Service Code. Management and the Club's trustees believe that the plan continues to qualify and to operate as designed. Therefore, no provision for income taxes has been included in the Club's financial statements.
