### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of St. George's School Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of St. George's School Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 DESCRIPTION OF PLAN**

The following description of the St. George's School Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Certain employees are eligible to make elective deferrals into the Plan upon employment with the School. Student employees as well as members of the clergy are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On July 1, 2016, the Plan switched active custodians from Teachers Insurance and Annuity Association and College Retirement Equities Fund (TIAA and CREF) to Wells Fargo Bank, whose retirement plan business was subsequently acquired by Charles Schwab Trust Bank in 2020. As part of this process, the School will no longer send contributions to TIAA and CREF. While TIAA and CREF is no longer an active custodian subsequent to July 1, 2016, certain participant balances remain at TIAA and CREF, unless the participant elects to transfer their balances to a subsequent custodian or withdraw their funds under a permitted transaction. In addition, certain Plan investments, such as the TIAA Traditional Annuity, also contain certain liquidity restrictions, which further prevents a participant from moving their balances over to a subsequent custodian or from the Plan.

**Contributions**

Participants may contribute up to 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). For the Plan year ended June 30, 2024, the School made a contribution to the Plan of 10% of compensation, as defined in the Plan agreement, for each eligible employee. Employees eligible to receive School contributions do not include adjunct faculty, nonresident aliens, employees covered under a collective bargaining agreement, and students, as defined in the Plan agreement. Employees are eligible to receive School contributions upon the attainment of 21 years of age and completion of two consecutive years of service. A year of service means a consecutive 12-month period during which an employee is credited with 1,000 or more hours of service and includes credit for prior service with another tax-exempt organization or public educational institution. The participant must also be employed by the School on the last day of the plan year. All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (the Code).

**Participant Accounts**

Each participant's account is credited with the participant's contributions and School contributions, and allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of School contributions, investment income, and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Investment Options**

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Charles Schwab Trust Bank. These investments include a variety of options with various objectives and degrees of financial risk.

**Vesting**

Participants are immediately vested in all contributions, including the earnings on those amounts.

**Plan Loans**

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 from balances held at TIAA and CREF. The maximum amount that a participant can borrow will be reduced by the amount of the participant's highest outstanding loan balance within the past 12 months. Such borrowings are limited to 90% of the participant's account value in the Group Supplemental Retirement Annuity (GSRA) TIAA Traditional Account. Thereafter, an amount equal to 110% of the loan must be in the participant's GSRA account to serve as collateral for such loan. Such loans are made between TIAA and CREF and the participant and are secured by the balance in the participant's GSRA TIAA Traditional Account. Accordingly, such loans are not included in the accompanying statements of net assets available for benefits. These outstanding loans were \$906 and \$3,105 at June 30, 2024 and 2023, respectively.

The loans bear interest at adjustable rates determined by TIAA and CREF. A participant's rate can only change once every 12 months. Principal and interest are paid by the participant directly to TIAA and CREF on either a monthly or quarterly basis as elected by the participant. Plan loans currently bear and interest at rate of 5.56%.

**Notes Receivable from Participants**

Participants may borrow from their accounts held at Charles Schwab Trust Bank a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participants' accounts at Charles Schwab Trust Bank and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The notes currently bear interest at rates ranging from 4.25% to 9.50%. Participants may have two loans outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid in a lump sum or in installments over a number of years, or by purchase of an annuity, based upon election of the participant or as defined in the Plan or the Code. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$5,000, the Plan administrator may distribute such amount in a lump-sum payment to the participant without the consent of the participant.

**Payment of Benefits**

The Plan also provides for in-service withdrawals by participants who have attained the age of 59½. Upon financial hardship, a participant is entitled to the value of his or her elective deferrals in accordance with the terms of the funding vehicles and the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution retirement plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Certain individual contracts included in the Plan's investment in the TIAA Traditional Annuity are considered to be fully benefit-responsive. The Plan's investment in the Standard Stable Asset Fund III is also considered fully benefit-responsive.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefit and Pension Committee of the School determines the Plan's valuation policies and procedures utilizing information provided by the Plan's custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the School. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**Risks and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term, and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events were evaluated through January 15, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATIONS BY THE INVESTMENT CUSTODIAN AND TRUSTEE**

TIAA and CREF and Charles Schwab Trust Bank, the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended June 30, 2024, and the supplemental schedule of assets (held at end of year) as of June 30, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

*Money Market and Mutual Funds:* Money market and mutual funds are valued at the quoted price of shares held by the Plan at year-end.

*Variable Annuity Contracts:* Variable annuity contracts invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. The accounts are primarily valued based on the fair value of the underlying assets of each investment using market quotations or values obtained from independent pricing services which may employ various pricing methods to value the investments including matrix pricing. The net asset value is used as a practical expedient to estimate fair value.

*Pooled Separate Accounts:* Pooled separate accounts are stated at their net asset value as reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. The net asset value is used as a practical expedient to estimate fair value.

*Fixed Annuity Contracts:* Following guidance provided by TIAA and CREF, management has determined that contract value approximates fair value for guaranteed annuity contracts that are not fully benefit-responsive. Therefore, non-fully benefit-responsive contracts included in the TIAA Traditional Annuity are reported at contract value. Contract value represents contributions made under the contract, plus guaranteed and additional interest, less funds used to pay benefits and administrative expenses of the contract.

The conclusion that contract value approximates fair value for non-fully benefit-responsive contracts included in the TIAA Traditional Annuity is supported by two approaches, 1) the theoretical transfer of assets owned by a pension plan, and 2) a quantitative model based on assumptions of future interest rates and related discounted cash flows.

Differences in the credit spreads from corporate bonds are assumed to represent the overall illiquidity of the TIAA Traditional Annuity, and those associated U.S. Treasury yields represent a credit spread for a highly rated insurance company. Thus, the interest rate used to discount future cash flows under a TIAA Traditional Annuity contract would approximate the contract's crediting rate, and the present value would, therefore, approximate current contract value.

Because participants transact at contract value, the fair value approaches and assumptions related to the TIAA Traditional Annuity are only reviewed annually for financial reporting purposes.

There have been no changes in the methodologies used at June 30, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 FIXED ANNUITY CONTRACTS**

The TIAA Traditional Annuity consists of guaranteed fixed annuity contracts that, during the accumulation phase, provide a guarantee of principal, a guaranteed minimum interest rate, and the potential for additional discretionary interest if declared by TIAA. Additionally, the discretionary rate applied to contributions received during a reporting period may differ from the discretionary rate applied to account balances at the end of the prior reporting period. Such contracts may be converted to an annuity based on the accumulation in the account. Participants who elect to direct their contributions to this account enter into individual contracts with TIAA that provide various options.

As a result, the TIAA Traditional Annuity consists of certain individual participant contracts that are considered to be fully benefit-responsive and others that are not considered to be fully benefit-responsive because provisions in the contract contain liquidity restrictions that can limit the participant's ability to make withdrawals from the contract. The portion of the TIAA Traditional Annuity that is fully benefit-responsive is presented on the face of the statements of net assets available for benefits at contract value. The portion of the TIAA Traditional Annuity that is not considered to be fully benefit-responsive is presented on the face of the statements of net assets available for benefits at fair value, which management has determined to approximate contract value.

**NOTE 6 GUARANTEED INVESTMENT CONTRACT**

The Plan has entered into a benefit-responsive guaranteed investment contract with Standard Insurance Company. As part of the contract, the Plan offers a fixed annuity option, the Stable Asset Fund III, which is a deposit contract with Standard Insurance Company. Deposits in this account are invested in Standard Insurance Company's general account. Prior to the first day of each quarter, Standard Insurance Company establishes an effective annual rate for the quarter. Interest will be credited with the same guaranteed interest rate, on a daily basis, at the rate of interest which is the daily equivalent of the effective annual rate of interest applicable for each quarter and there is no set maturity date. The account is charged for participant's withdrawals and administrative expenses.

Because the Stable Asset Fund III is fully benefit-responsive, contract value is the relevant measurement attribute for the Stable Asset Fund III. Stable Asset Fund III is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at June 30, 2024 and 2023 was \$435,823 and \$510,517, respectively, as reported by Charles Schwab Trust Bank. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with Standard Insurance Company. Such events include the following: 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary), that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by TIAA and CREF and Charles Schwab Trust Bank. TIAA and CREF and Charles Schwab Trust Bank are the custodian and trustee, respectively, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Certain employees of the School who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

**NOTE 8 INCOME TAX STATUS**

The Plan has adopted a 403(b) prototype plan document that received a favorable opinion letter in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes the Plan was compliant and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 10 SUBSEQUENT EVENTS**

The Plan was amended and restated effective July 1, 2024, to make the following changes to the Plan:

- To exclude employees who normally work less than 20 hours per week as eligible participants.
- To remove the service requirement and the requirement to be employed to the last day of the Plan year for purposes of being eligible to receive School contributions.
- To remove immediate vesting in School contributions and implement the following vesting schedule:
