**Note 1 – Description of Plan and Significant Accounting Policies**

The following description of the Auto Systems Centers, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan initially adopted in 1987 as a profit-sharing plan. The Plan covers all employees of Auto Systems Centers, Inc. (the Company), 1101 Monroe Street, Inc. and Max Auto Supply Company who have completed at least one year of service with 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer up to 100% of annual earnings, as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service (IRS) per year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make Rollover Contributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a safe harbor match of 100% of the participant's deferrals up to 3% of gross compensation plus an additional 50% of the participant's deferrals that are over 3% up to 5%. The Company may make additional profit-sharing contributions, to be determined at the discretion of the Company's management.

Plan Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from the financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statements of Changes in Net Assets Available for Benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, Trustees and/or insurance company. See Note 6 for discussion on fair value measurements.

Valuation of Investments and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Participant Accounts

Each participant's account is credited with their individual contribution and an allocation of: (a) the Company's contribution, (b) Plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the Trustees to invest his or her funds in the investment options established under the Plan.

Vesting

Participant contributions and safe harbor matching employer contributions are immediately fully vested for all participants. Vesting for other employer contributions is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to \$50,000, but in no case more than 50% of their vested account balance. Employees may only have one outstanding loan at any given time. The interest rate must be at least 1% above the prime rate at the time the loan is made. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Forfeitures

Terminated participants' non-vested account balances are first used to restore participant forfeitures, if they return to employment within a specified period of time stated in the Plan document, then used to reduce the employer match. At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$19,864 and \$18,889, respectively. These accounts will be used to reduce future employer contributions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment or partial payments.

Use of Management's Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Reclassification

Certain reclassifications have been made to the 2023 financial statements to conform with the 2024 presentation.

Subsequent Events

Management has evaluated subsequent events through January 7, 2025, the date the financial statements were available to be issued.

**Note 2 – Information Prepared and Certified by Trustees**

The Trustees of the Plan, State Street Bank & Trust Company and Transamerica Trust Company, hold the Plan's investments and execute all investment transactions. The related financial information included in the accompanying financial statements and schedule is based solely on information provided by the Trustees.

**Note 3 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer-contributed portion of their accounts.

**Note 4 – Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained by examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 – Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds, stocks and bonds held within collective trust accounts managed by Transamerica Retirement Solutions Corporation. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 1, the Plan made a direct payment to the third-party administrator of \$20,898 and \$17,794 for the years ended June 30, 2024 and 2023, respectively, which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

**Note 6 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date;

Level 2: Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability, and

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

- Collective trust accounts: Valued at the daily net asset value (NAV) of units of a collective trust. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.
- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Interest-bearing cash is recorded at cost, plus accrued interest.
