

### NOTE 1 - DESCRIPTION OF PLAN

The following description of The Joy Companies (“Company”) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of The Joy Companies, Inc. and its affiliates (collectively, the “Company”) who have attained age twenty one except for non-resident aliens, employees covered by a collective bargaining agreement, and leased employees. It is subject to the requirements of the Employee Retirement Income Security Act (“ERISA”) of 1974. The Plan has a 401(k) salary deferral provision as well as discretionary matching contributions. Employees must complete one year of service of at least 1,000 hours and be employed on the last day of the Plan year to be eligible to participate with respect to Company matching contributions. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a six percent withholding of pretax annual compensation. This withholding will increase by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of fifteen percent of compensation. The Plan’s assets are held by Fidelity Management Trust Company, the Plan trustee. The trustees also retained Fidelity Management Trust Company as the third-party administrator which provides administrative, compliance, and record keeping services.

#### **Contributions**

The maximum dollar amount each participant may contribute annually on a pre-tax basis is \$19,500 in 2021 as defined in the Plan. Additional contributions of up to \$6,500 in 2021 are allowed for participants who are over age fifty by December 31, 2021. The Company made Employer matching contributions for the years ended December 31, 2021 and 2020 of \$4,499 and \$38,701 respectively.

Participants may also contribute rollover amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### **Participant Accounts**

- Employer matching - Each participant’s account is credited with the allocation of (a) the Company’s contribution, if any and (b) Plan earnings. Allocations are based on participant earnings, as defined in the Plan document. Each participant’s account is segregated and self-directed as to the investment vehicle. Gains and losses of segregated accounts are credited to that account only.
- 401(K) & Roth salary deferrals and rollovers - Each participant’s account is credited with the employee contribution, if any. Each participant’s account is segregated and self-directed as to the investment vehicle. Gains and losses of segregated accounts are credited to that account only.

#### **Vesting**

- Matching - Vesting is based on years of continuous service. A participant becomes fully vested on completion of three years of service.
- 401(K) & Roth salary deferrals and rollovers - Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

A participant becomes fully vested automatically, regardless of the vesting schedule, upon attainment of normal retirement age, upon retirement due to disability, upon death, and upon termination of the Plan.

The Plan defines normal retirement age as the date a participant reaches age 59 1/2. Disability is defined as having been determined disabled by a physician.

#### **Withdrawals and Benefits**

Benefits are distributed upon termination, death, or disability in a single-sum cash payment or installment payments equal to the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

#### **Notes Receivable from Participants**

Participants may take out a loan against their outstanding participant balance. Loans will be limited to the lesser of \$50,000 reduced by the excess of the highest outstanding balance of loans from the Plan to the participant, or 50% of the present value of the non-forfeitable accrued benefit of the participant. The loans shall be made available to all participants and beneficiaries on a reasonable equivalent basis. Loans shall not be made to highly compensated employees in an amount greater than the amount made available to other participants and beneficiaries. Loans shall bear a reasonable rate of interest, be adequately secured, and provide repayment over a reasonable period of time.

#### **Forfeited Accounts**

Forfeited non-vested accounts may be used to reduce future employer contributions or to restore forfeitures. As of December 31, 2021 and 2020, forfeited non-vested accounts totaled \$6,638 and \$35,511, respectively. During 2021, \$35,576 from forfeiture account were used to reduce employer contributions.

### NOTE 2 - ACCOUNTING POLICIES AND PROCEDURES

#### **Date of Management's Review**

Subsequent events were evaluated through January 27, 2025 which is the date the financial statements were available to be issued.

#### **Basis of Accounting**

The accompanying financial statements and supplemental schedule have been prepared in conformity with the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted under such rules and in accordance with the Trust agreements, the accounting records maintained by the custodian are on the accrual basis.

#### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative expenses**

All expenses of administration may be paid out of the Plan unless paid by the Company.

### NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring the fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the assets or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at the daily net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2018.

#### NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of Plan termination, participants would become fully vested in their accounts.

#### NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTION

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, Inc. Fidelity Management Trust Company, Inc is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing rather than direct payment. For the year ended December 31, 2021, the Plan paid additional fees for the investment management services of \$74,802 to the trustee. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### NOTE 7 - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements available for benefits.

**NOTE 11 - CORRECTIVE CONTRIBUTIONS**

As of December 31, 2021 and 2020, the Statements of Net Assets Available for Benefits reflect an employer corrective contribution receivable of \$105,087 and \$92,086 respectively to be made for selected participants to remediate an administrative error in calculating their elected contribution through salary reduction. The Company is currently working with their service provider to make corrective contributions, including associated lost earnings, and those amounts will be credited to the affected participants' accounts as soon as possible.

**NOTE 12 – SUBSEQUENT EVENTS**

Management has evaluated subsequent events for disclosure in these financial statements through January 27, 2025 which is the date the financial statements were available to be issued.
