### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Lightning eMotors, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 3, 2024 (in Liquidation) and December 31, 2023 (Ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through June 3, 2024 (in Liquidation), and the related notes to the financial statements.

Our opinion is not modified with respect to this matter.

### Note 1 – Description of the Plan

The following description of the Lightning eMotors, Inc. 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan Document for a more complete description of the Plan's provisions.

**General.** The Plan was a defined contribution plan, which went into effect January 1, 2017, that was generally available to all employees of Lightning eMotors, Inc. (the "Company", "Employer", "Plan Administrator", or "Plan Sponsor"). The Plan excluded nonresident aliens, an individual who became an employee of the Employer as a result of a recent merger, acquisition, or similar transaction, a leased employee, and interns. Employees became eligible after attainment of age 18. Eligible employees were able to enter the Plan on the first of the month coincident with or following the date they meet the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan were not guaranteed by the Pension Benefit Guaranty Corporation.

**Plan Termination.** Effective January 29, 2024, the Plan document was amended to terminate the Plan. In connection with the Plan's termination the following occurred:

- No further contributions will be made to the Plan;
- The Plan's termination created a distributable event for all the Plan's participants and the Plan was fully liquidated on June 3, 2024; and
- As further discussed in Note 2, the Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting.

**Contributions.** The following types of contributions were allowable under the Plan:

- **Salary Deferral Contributions** - Participants had the option to contribute up to a maximum of 100% of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Participants also had the option to contribute a percentage of their after-tax compensation and designate it as a Roth deferral contribution. The Plan had an automatic contribution arrangement ("ACA") such that newly eligible participants, unless they elected otherwise, were automatically enrolled at a 5% pre-tax salary deferral contribution percentage rate. A participant's total salary deferral contributions cannot exceed \$23,000 (\$30,500 if age 50 or over) in calendar year 2024.
- **Safe Harbor Employer Matching Contributions** - The Employer made a safe harbor Employer matching contribution each Plan year equal to 100% of the participant's salary deferral contributions up to 3% of compensation, plus 50% of the participant's salary deferral contributions greater than 3% of compensation but that does not exceed 5% of compensation.
- **Discretionary Employer Nonelective Contributions** - The Employer had the option to make discretionary Employer nonelective contributions each plan year to eligible participants using the new comparability formula whereas each participant will constitute a separate allocation group. For the period ended June 3, 2024, the Employer did not make a discretionary Employer nonelective contribution.

### Note 1 – Description of the Plan (continued)

- Discretionary Employer Matching Contributions - The Employer had the option to make discretionary Employer matching contributions each plan year to eligible participants. For the period ended June 3, 2024, the Employer did not make a discretionary Employer matching contribution.
- Rollover Contribution - Certain amounts distributed to participants from other qualified employee benefit plans were able to be rolled into the Plan.

**Participant Accounts.** Each participant's account was credited with the participant's contributions (salary deferrals and rollovers), the Employer's contributions (safe harbor matching, discretionary nonelective, and discretionary matching, if any), and Plan earnings, and charged with payments of benefits and an allocation of administrative expenses and Plan losses. Allocations were based on participant earnings, account balances, as defined by the Plan Document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

**Investment Options.** Participants were able to direct their investments into various registered investment companies and an investment contract with insurance company.

**Notes Receivable from Participants.** Participants had the option to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms ranged from 1 month up to a maximum of 5 years (a longer term, up to 15 years, was available if used for the purchase of a principal residence). The loans were secured by the balance in the participant's account and bore a reasonable rate of interest as determined by the Plan administrator at the date the loan was granted. Principal and interest payments were paid ratably through payroll deductions.

**Vesting.** Participants were vested immediately in all contributions plus actual earnings thereon.

**Unallocated Accounts.** The Plan maintained an unallocated suspense account and administrative fee account (collectively, "unallocated accounts"). During 2024, \$8,768 from the unallocated suspense account were used to reduce Employer contributions of the Plan. As of June 3, 2024 and December 31, 2023, the balance in the unallocated accounts totaled \$0 and \$1, respectively.

**Payment of Benefits .** Benefits to participants or beneficiaries were payable as a lump-sum payment equal to the value of their vested account balance upon retirement, termination, death or disability of the participant. A terminated employee with a balance of less than \$5,000 had the option to be automatically paid out by the Plan upon termination. Additionally participants had the option to request an in-service withdrawal of their rollover contributions account, upon attainment of age 59 1/2, for a qualified reservist distribution, a deemed severance distribution, or upon incurring a financial hardship, as defined, if certain criteria were met.

### Note 2 – Summary of Significant Accounting Policies

**Change in Basis of Accounting.** As further discussed in Note 1, the Plan was terminated effective January 29, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used to present the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition .** The Plan's investments are reported at fair value, except for the Plan's investment in an investment contract with insurance company which is stated at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Contributions.** Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 3, 2024 or December 31, 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payments of Benefits.** Benefit payments to participants are recorded when paid.

**Administrative Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses paid by the Plan also include fees paid for recordkeeping, distributions, investment advisory, and other expenses. Additionally, certain investment related expenses are included in investment income.

### Note 3 – Fair Value Measurements

Topic ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described below:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at June 3, 2024 and December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies are valued at the quoted NAV of shares held by the Plan at year or period end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4 – Investment Contract with Insurance Company

On January 1, 2022, the Plan entered into a traditional benefit-responsive investment contract, the Standard Stable Asset Fund, with Standard Insurance Company ("Standard"). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measurement attribute for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at June 3, 2024 and December 31, 2023, was \$0 and \$91,342, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply.

### Note 4 – Investment Contract with Insurance Company (continued)

Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by Standard, a market value adjustment or other withdrawal restrictions may apply.

The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, was probable.

### Note 5 – Certified Information

The following information disclosed in the accompanying financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company and Newport Trust Company, LLC, the trustee of the Plan:

- Notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of June 3, 2024 (in Liquidation) and December 31, 2023 (Ongoing);
- Investment amounts, as shown in Notes 3 and 4;
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through June 3, 2024 (in Liquidation); and
- Interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through June 3, 2024 (in Liquidation).

### Note 6 – Tax Status

The Plan Sponsor has adopted an Ascensus LLC Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of June 3, 2024 and December 31, 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 6 – Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 3, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

### Note 7 – Party-In-Interest Transactions

The Company provided to the Plan certain accounting and administrative services for which no fees were charged.

The Plan's trustee, Ascensus Trust Company; the Plan's recordkeeper, Ascensus; the Plan's investment advisor; the Plan's auditors; the Employer; and Plan participants were all parties-in-interest to the Plan. Additionally, the Plan maintained notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 8 – Concentrations

As of December 31, 2023, there were two investments which individually represented more than 10% of net assets available for Plan benefits.

### Note 9 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through January 15, 2025, which is the date the financial statements were available to be issued.
