Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Maryhurst, Inc. (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 403(b) Thrift Plan of Maryhurst, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the 403(b) Thrift Plan of Maryhurst, Inc. provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Maryhurst, Inc. (Employer) who satisfy the Plan's eligibility requirement. There is no minimum age or service requirement to make salary reduction contributions to the Plan. Employees must be 18 years of age to receive the employer matching contribution and are immediately eligible to receive the employer match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Contributions:

The Plan is funded by participant salary reduction contributions and a discretionary employer matching contribution. Participants may elect to defer up to 100% of their compensation, as defined in the plan document, up to the maximum permitted by the Internal Revenue Code. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced portfolio until changed by the participant. Automatic enrollments are increased by 1% per plan year up to a maximum of 7%, based on completion of service as noted in the plan document and subsequent plan amendment. Participants are also permitted to make Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified or 403(b) plans.

The discretionary employer match was 100% of the first 3% of base compensation that the participant contributed to the Plan during the years ended June 30, 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

NOTES TO FINANCIAL STATEMENTS

Participant accounts:

Each participant's account is credited with the participant's contributions and employer matching contributions, as well as an allocation of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined in the plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in all employee contributions, as well as actual earnings thereon. Participants hired prior to July 1, 2019 were also immediately vested in all employer contributions, as well as actual earnings thereon. Effective July 1, 2019, vesting in the discretionary employer matching contributions and earnings on those contributions is based on years of service for those employees hired or rehired on or after July 1, 2019, as outlined in the following table:

Loans to participants:

Participants with funds held by Mutual of America Life Insurance Company or in the Lincoln National Life Insurance Company Multi-Funds may request a loan based on the vested balance of their individual accounts. These loans are issued directly by Mutual of America Life Insurance Company or Lincoln National Life Insurance Company to the participant. The loans are secured by the balance in the participant's general account. No funds are withdrawn from the participant's account unless the participant defaults on the loan and a distributable event occurs.

The loan may range from a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding loan balance in the last 12 months or 50 percent of the vested account balance reduced by the outstanding balance of all loans. Loan terms range from 1 - 5 years but may be longer if the loan is made for the purchase of the participant's primary residence. The loans bear interest at prime plus one percent and are repaid by coupon payment directly to Mutual of America Life Insurance Company or the Lincoln National Life Insurance Company.

As of June 30, 2024 and 2023, \$56,205 and \$39,079 of investments in the general accounts served as security for the outstanding loans to participants.

NOTES TO FINANCIAL STATEMENTS

Payment of benefits:

On termination of service due to death, disability, retirement, or termination of employment, the vested balance in the participant's account is paid to the participant or his or her beneficiary in a lump-sum payment or installment payments based on the selected form of annuity. In the event of financial hardship, the Employer may allow a participant to withdraw from his or her account. The amount may not exceed the amount contributed by the participant, excluding Roth deferrals, or the participant contribution account, if less.

Forfeited accounts:

Forfeitures are used to reduce future employer contributions. Employer contributions were reduced by \$61,622 and \$51,526 from forfeited non-vested accounts during the years ended June 30, 2024 and 2023, respectively. Unallocated forfeitures were \$1,659 and \$4,517 for the years ended June 30, 2024 and 2023, respectively, which resulted from employer corrective contributions, compliance testing adjustments, and employee terminations.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

Investment valuation and income recognition:

Investments are held in group annuity contracts and are stated at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance companies of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions:

Contributions from Plan participants and the contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Fees related to the administration of the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through January 21, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended June 30, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by TIAA-CREF, the custodian; and The Lincoln National Life Insurance Company and Mutual of America Life Insurance Company, the insurance companies.

NOTES TO FINANCIAL STATEMENTS

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Fixed rate annuity account - fair value is equal to contract value. Contract value is based on the contributions made to the account, plus interest at the contract rate, less benefits paid to participants and administrative expenses charged by the custodian.

General account – fair value is determined by the insurance company as of the close of business on each valuation day based on the contributions made to the account, plus interest at the contract rate, less benefits paid to participants and administrative expenses charged by the insurance company.

Separate accounts – valued at the net asset value (NAV) of units held. The NAV is based on the changes in the net asset values of the underlying funds, depending on investment experiences and expenses of the underlying funds, and separate accounts charges under the contract.

Mutual funds – valued at the daily closing price as reported by the fund.

NOTES TO FINANCIAL STATEMENTS

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

The transfer in is an inter-fund transfer from separate accounts to the general account fund option offered by Mutual of America Life Insurance Company. The transfer out is a transfer from TIAA-CREF to a separate account held by Mutual of America Life Insurance Company.

Investments Measured Using Net Asset Value per Share Practical Expedient

All separate accounts have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' NAV. The NAV is updated daily.

A description of the investment strategies for separate accounts whose value is derived using NAV are as follows: emerging markets, growth, growth and income, international equity and value funds seek long-term growth through capital appreciation; government/corporate debt and real estate funds seek a long-term rate of return with capital preservation; balanced and global debt funds seek a long-term rate of return; fixed income option funds seek a total return with current income and capital preservation; blended funds seek to maximize performance and minimize risk; specialty funds seek long-term capital growth and current income; and index funds seek investment returns consistent with stock indexes.

Note 5. Fully Benefit-Responsive Investment Contracts

The Plan entered into fully benefit-responsive guaranteed investment contracts with The Lincoln National Life Insurance Company (Lincoln) and TIAA-CREF (TIAA) totaling \$18,029 and \$17,515 as of June 30, 2024 and 2023, respectively. Lincoln and TIAA maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTES TO FINANCIAL STATEMENTS

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln and TIAA, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The plan administrator believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

A plan sponsor-initiated termination of the contract is an event that could limit the ability of the Plan to transact at contract value paid within 90 days (Lincoln) or 120 days (TIAA). In this instance, contract value could be paid over time, or at the plan sponsor's discretion, paid over, at most, a one-year period after the application of market value adjustments. There are not any events that allow Lincoln or TIAA to terminate the contracts and which require the plan sponsor to settle at an amount different than contract value paid either within 90 or 120 days or over time.

Note 6. Related Party and Party-in-Interest Transactions

The Plan invests in group annuity contracts sponsored by TIAA-CREF, the custodian, and The Lincoln National Life Insurance Company, the insurance company, and other investments managed by Mutual of America Life Insurance Company, the insurance company, as defined by the Plan and, therefore, these transactions qualify as party in interest transactions.

Fees paid by the Plan to the custodians and insurance companies for administrative services are deducted from participant accounts in accordance with the plan document. These fees totaled \$6,414 and \$1,966 for the years ended June 30, 2024 and 2023, respectively. Fees incurred for investment management services are included in net appreciation in fair value of investments.

NOTES TO FINANCIAL STATEMENTS

Certain administrative functions are performed by officers or employees of the Employer. No officer or employee receives compensation from the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants are 100 percent vested in the value of their accounts.

Note 8. Income Tax Status

Currently, 403(b) plans are not required to submit plans to the Internal Revenue Service (IRS) for determination. However, the Plan is required to operate in conformity with the Internal Revenue Code (Code) to maintain the tax exclusion for plan participants. The plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Reconciliation of Financial Statements to Form 5500

The Plan holds investments in separate accounts, which are not direct filing entities. As such, per Form 5500 instructions, the Plan's interest in the underlying assets of the separate accounts must be allocated and reported in the appropriate categories on Schedule H. Therefore, these investments are reflected as mutual funds on Form 5500, but as separate accounts for financial statement purposes.
