Independent Auditor's Report

To the Plan Administrator and Participants of RentalMax 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of RentalMax 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits - in liquidation as of December 31, 2024, the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits - in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RentalMax 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of RentalMax 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the plan sponsor of the Plan terminated the Plan effective May 31, 2024. As a result, the Plan has changed its basis of accounting for periods subsequent to December 31, 2023 from the going-concern basis of accounting to the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about RentalMax 401(k) Retirement Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the RentalMax 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Plan termination

By action of the Members and Board of Directors, the Plan was terminated effective May 31, 2024. Upon termination, all participant accounts became 100 percent vested. All assets of the Plan were distributed to participants by December 31, 2024.

General

The Plan was a defined contribution plan established effective January 1, 1988, as restated January 1, 2022. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The 401(k) Plan Committee was responsible for oversight of the Plan. The Plan's 401(k) Plan Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

Eligibility

The Plan covered all employees, excluding nonresident aliens with no U.S. earned income, leased employees, employees regularly scheduled to complete less than 1,000 hours of service until completion of 1 year of service, and student intern employees, of RentalMax, LLC (the Employer).

Contributions

Each year, participants were able to contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants were able to designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants also were able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants directed the investment of their contributions into various investment options offered by the Plan.

The Plan included an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3 percent of eligible compensation, as defined, and their contributions invested in a designated balanced fund until changed by the participant.

Notes to Financial Statements

The Employer was able to make a discretionary matching contribution to the Plan equal to a percentage of the elective contributions made by participants to the Plan. For the year ended December 31, 2024, the Employer contributed 20 percent of a participant's salary deferrals up to 5 percent of eligible compensation, as defined.

Additional profit-sharing amounts were able to be contributed at the option of the Plan Management. In order to participate in the profit-sharing contributions, participants had to be employed on the last day of the plan year, unless the termination was due to death, disability or retirement. For the year ended December 31, 2024, there were no profit-sharing contributions to the Plan.

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account was credited with the participant's contributions, allocations of the Employer's discretionary contributions, if any, and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that was provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Prior to the Plan's termination date on May 31, 2024, vesting in the Employer's contribution portion of their accounts was based on years of continuous service. A participant was 20 percent vested after 1 year of credited service and continued to vest in increments of 20 percent until 100 percent vested after 5 years of credited service.

Notes receivable from participants

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined at time loan was taken, was set at 2 percent above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions. Terms ranged up to 5 years or greater for the purchase of a primary residence.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant was able to elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant was able to receive the value of the vested interest in his or her account as a lump-sum distribution. If a terminated participant's vested balance was less than or equal to \$7,000, the amount could be automatically distributed in the form of lump sum cash payment or a transfer to an Individual Retirement Account, depending upon balance. In addition, the Plan allowed for hardship distributions if certain criteria were met.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$1,356, respectively. Forfeitures could have been made available to reinstate previously forfeited account balances of participants, if any. Remaining forfeiture balances could have been used to satisfy any contribution that may have been required pursuant to satisfy any contribution required pursuant to Section 3.7 or 6.10 of the plan document, or pay any administrative expenses of the Plan. Any then remaining forfeitures should have been used to reduce Employer contributions. During 2024, Employer contributions were reduced by \$3,253, from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

As discussed in Note 1 to the financial statements, the plan sponsor terminated the Plan effective May, 31, 2024. As a result, the Plan changed its basis of accounting for the year ended December 31, 2024 from ongoing basis to the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred in the liquidation process.

The 2023 financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Plan Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and were expensed as incurred.

Excess Contributions Refundable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that were paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through January 28, 2025, the date the financial statements were available to be issued.

3. Information Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Charles Schwab Trust Bank, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing basis), and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits - in Liquidation for the year ended December 31, 2024.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trust fund: Value based on the NAV of units of the common/collective trust. The NAV, as provided by the Custodian, was used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probably that the fund will sell the investment for an amount different than the reported NAV.

5. Related-Party and Party In Interest Transactions

Certain plan investments were held by the Custodian, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Employer. No such officer or employee received compensation from the Plan.

6. Plan Termination

On May 31, 2024, the Members and Board of Directors of the Employer, as permitted by the plan document, made a decision to terminate the Plan as of May 31, 2024. Participants became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and Employer contributions into the Plan and ceased new participant notes receivables from the Plan. During 2024, the plan assets were fully liquidated, and final distributions were made to participants according to participant's directives.

7. Tax Status

The Plan adopted a pre-approved plan offered by FIS Business Systems, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan was qualified, and the related trust was tax exempt.

Plan management was required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
