1. DESCRIPTION OF PLAN:

The following description of Physicians Medical Center, LLC 401(k) Plan (formally known as Physicians Medical Center Retirement Plan), (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Physicians Medical Center, LLC (the "Plan Sponsor" or "Company") who have attained the age 21. Participation is not permitted for employees covered by collective bargaining agreements, non-resident aliens, leased employees or employees hired on an as-needed basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On November 30, 2022, the Plan Sponsor, elected to terminate the Plan effective December 1, 2022. All unvested accounts became fully vested as of December 1, 2022. All participant plan assets were distributed, and the Plan ceased to exist as of May 26, 2023.

Contributions

Effective December 1, 2022, the plan was frozen to employee or employer contributions. Prior to December 1, 2022, participants could contribute up to 100% of their compensation (through pre-tax or Roth contributions), as defined in the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company could make discretionary matching contributions to each participant with one year of service equal to 100% of the first 3% of eligible compensation that a participant contributed to the plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account was credited with the participant's contributions, Company discretionary matching contributions, as well as allocations of plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in employee contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their account was based on years of credited service. A participant was 100% vested after six years of credited service. Participants became fully vested in all unvested accounts as of the Plan termination date, December 1, 2022.

Notes receivable from participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes were secured by the balance in the participant's account and bear interest at current prime rate plus 2%. Principal and interest were paid ratably through bi-weekly payroll deductions.

Payment of benefits

Distributions were payable upon termination of employment, death, disability, or retirement. Participants could elect to receive a lump sum payment equal to the value of the participant's vested interest in his or her account. Participants could also make withdrawals of vested account balances prior to termination upon attainment of age 59 ½ or in the event of financial hardship, as defined by the Plan.

Forfeited accounts

At May 26, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0- and \$354 respectively. These accounts may be used to reduce future Company contributions or pay administrative expenses. During 2022, no forfeitures were used to reduce administrative expenses or Company contributions. During 2023, forfeitures were used to reduce administrative expenses or Company contributions in the amounts of \$2,010 and \$-0-, respectively.

2. SUMMARY OF ACCOUNTING POLICIES:

Basis of accounting

The financial statements for the Plan have been prepared under the liquidation basis of accounting as required by a terminating plan (see Note 1).

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022.

Payment of benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Certain investment related expenses were included in net appreciation (depreciation) of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through January 21, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AND CUSTODIAN:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustee and custodian, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of May 26, 2023 and December 31, 2022 and the supplemental schedule of assets (held at end of year) as of December 31, 2022 the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the period January 1, 2023 through May 26, 2023 and the year ended December 31, 2022.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

5. GUARANTEED INVESTMENT CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA:

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by National, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for certain investment services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

7. TAX STATUS:

The Plan operates under a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, that stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan did not obtain its own determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.
