Please be advised that this submission does not include an Independent Qualified Public Accountant’s (“IQPA”) opinion due to the facts and circumstances surrounding this Plan, as described below.

On July 25, 1996, Larry Lefoldt was appointed as the substitute Independent Fiduciary for the Professional Staffing Services, CA Money Purchase Pension Plan (the “Plan”) by federal court order at the request of the U. S. Department of Labor to make reasonable and prompt efforts to marshal the assets of the Plan (including collecting any restitution ordered by the Court, if possible), to distribute the assets of the Plan, and to proceed with an orderly termination of the plan. Several years before Larry Lefoldt’s appointment as substitute Independent Fiduciary for the Plan, the company was considered no longer operational.

Since the appointment, efforts have been focused on the following areas:

- Safeguarding the assets of the Plan.
- Identifying and locating participants and beneficiaries of the Plan eligible to receive payment and paying partial distributions to them from asset collections, in accordance with their authorization.
- Ensuring that all of the reporting and compliance requirements of the Plan have been met (e.g. Forms 5500, 1099-R/1096, 945, etc.).
- Locating missing participants and their beneficiaries. Approximately 110 plan members out of a total Plan count of 233 were missing.
- The former Trustee had assigned his ten percent interest in a partnership to the Plan which consisted of undeveloped land in Houston, Texas. The partnership sold the last parcel of undeveloped land on July 28, 2015 and received \$159,345.00. The proceeds from the sale of this last parcel were allocated to the plan participant’s accounts.
- The Plan has received all funds owed as of May 2019 and paid out the remaining funds to the plan members / beneficiaries in 2020.

Based on the circumstances with the Plan, we have marked “No” to the independent audit of the Plan by an independent certified public accountant for the year ended December 31, 2020. All costs to the Plan would impose an undue hardship on the plan participants since they would have to pay for the additional costs of an audit from Plan assets.
