### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of CompuGain 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 30, 2022 (in liquidation) and December 31, 2021 (in liquidation), the related statement of changes in net assets available for benefits for the period ended December 30, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 30, 2022 and December 31, 2021, and for the period ended December 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As discussed in Note 1 of the financial statements, management of the Company signed an amendment on February 28, 2022 to terminate the Plan effective December 13, 2021, and management determined that liquidation is imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis used in presenting the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in accordance with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



#### **Note 1 - Description of Plan**

The following description of the CompuGain 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan was a defined contribution pension plan covering all employees of CompuGain Holding Corporation and CompuGain LLC (collectively, the Company). To be eligible to participate in the Plan, employees would have been age 21 or older and would have completed one month of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In December 2021, management agreed to the sale of the Company to a third party. On February 28, 2022, management of the Company signed an amendment to terminate the Plan effective on December 13, 2021. The full liquidation and dissolution of the Plan was completed during the period January 1, 2022 through December 30, 2022.

##### **Contributions**

Each year participants could contribute up to 100% of pre-tax annual compensation, as defined in the plan document. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants were automatically enrolled in the Plan on the Plan entry date, as defined in the plan document, unless they elected to opt out. Participants who were automatically enrolled would have 6% of their eligible compensation withheld and remitted by the Plan. Automatically enrolled participants had their contributions invested in the age appropriate American Century Target date funds based upon projected retirement age, until changed by the participant. The Plan did not accept contributions from participants in 2022 due to the Plan termination.

The Company could make a discretionary matching or profit sharing contribution. There were no Company discretionary matching or profit sharing contributions during the period ended December 30, 2022. Contributions were subject to certain IRS limitations.

##### **Participant Accounts**

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

##### **Vesting**

As a result of the decision to terminate the Plan, all participants became fully vested in their account balances, effective December 13, 2021.

Prior to the Plan termination, participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their accounts was based on years of service. A participant was 100% vested after four years of credited service, based on the following vesting schedule:

#### Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years, unless the loan was to acquire the participant's principal residence, in which case the loan could be for up to 15 years. The loans were secured by the balance in the participant's account and bore interest at prime plus 1%. Principal and interest were paid ratably through payroll deductions or through direct payment by the participant outside of payroll. As of December 31, 2021, participants were no longer able to take new loans.

#### Payment of Benefits

Due to the Plan termination, a participant could elect to receive a lump-sum amount, or rollover their account to an individual retirement account (IRA) or to another qualified defined benefit or defined contribution plan equal to the value of the participant's vested interest in his or her account.

For distributions not made by March 31, 2022, the participant's balance will be rolled into an IRA at The Newport Group.

#### Forfeited Accounts

As of December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$-0- and \$4,487, respectively. These accounts would first be used to pay administrative expenses. Any remaining amounts would be used to reduce future employer contributions. During 2022, forfeited nonvested accounts were used to pay administrative expenses.

#### Note 2 - Summary of Significant Accounting Policies

##### Basis of Accounting

Due to the decision to terminate the Plan in December 2021, management determined that liquidation of the Plan was imminent and the financial statements for 2022 and 2021 have been prepared using the liquidation basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments were reported at liquidation value. Fair value approximates the amount the Plan expected to collect at liquidation. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income and dividends were recorded on the liquidation basis. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred.

##### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2021 excess contributions to the applicable participants by March 15, 2022.

##### **Payment of Benefits**

Benefits were recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to payments of benefits were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments.

#### **Note 3 - Information Certified and Provided by PNC Bank, National Association**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 30, 2022 and December 31, 2021, and net depreciation in fair value of investments and interest and dividends, for the period ended December 30, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by PNC Bank, National Association (the trustee of the Plan).

#### Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provided the framework for measuring fair value. That framework provided a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 were described as follows:

Level 1 - Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 - Inputs to the valuation methodology included:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability; and
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input had to be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Due to Plan termination, there were no plan assets as of December 30, 2022.

The following were descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2021.

Registered investment companies were valued at the net asset value (NAV) of shares held by the Plan at year end.

The common collective trust fund was valued at NAV of units held. The NAV was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Changes in Fair Value Levels

The availability of observable market data was monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques might require the transfer of financial instruments from one fair value level to another.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the period ended December 30, 2022 and for the year ended December 31, 2021, there were no significant transfers in or out of Level 3.

#### Note 5 - Tax Status

The Company adopted a prototype nonstandardized profit sharing plan (prototype plan) that was sponsored by PNC Bank, National Association and was administered by The Newport Group. The prototype plan had received an opinion letter from the IRS, dated March 31, 2014, stating that the prototype plan was qualified under the appropriate section of the Internal Revenue Code (IRC). The prototype plan opinion letter had been relied upon by the Plan. The Plan had been amended since receiving the opinion letter. The Plan Administrator believed that the Plan was designed and operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Note 7 - Related Party Transactions and Party-In-Interest Transactions

Fees paid directly by the Plan for investment management and custody services amounted to \$30,313 for the period ended December 30, 2022.

The Plan receives revenue sharing credits from PNC Bank, National Association, which may be used to pay Plan expenses. Revenue sharing credits received during the period ended December 30, 2022 were immaterial.
