Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Employee Savings and Investment Plan of Friend Tire Company (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 14, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statements of changes in net assets available for benefits for the period ended December 14, 2023 (in liquidation) and the year ended December 31, 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Employee Savings and Investment Plan of Friend Tire Company's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 14, 2023 and December 31, 2022, and for the period ended December 14, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Employee Savings and Investment Plan of Friend Tire Company and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 6, the governing body of Employee Savings and Investment Plan of Friend Tire Company approved a plan of liquidation on August 1, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the financial statements for the year ended December 31, 2022 to the liquidation basis used in presenting the financial statements for the period ended December 14, 2023. Our opinion is not modified with respect to that matter.


Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

Note 1 – Plan Description

The following description of the Employee Savings and Investment Plan of Friend Tire Company (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering all employees of Friend Tire Company (the “Company”) who had completed at least one year of service. The Plan did not cover Japanese expatriate employees and seasonal employees. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective August 1, 2023, the Plan was terminated. See Note 6 for discussion of Plan termination.

Contributions

Prior to Plan termination, participants could contribute from 1% to 50% of pretax annual compensation, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company had the discretion to provide a matching contribution, determined by the Company, not to exceed 6% of the participants’ compensation. During 2023, the Company made discretionary contributions of 100% of the participants’ contributions (not to exceed 6%). Contributions were subject to certain limitations.

Participant Accounts

Prior to Plan termination, each participant’s account was credited with the participant’s contributions, the Company’s contributions, and an allocation of Plan earnings and charged with an allocation of administrative fees. Allocations were based on compensation or account balances, as defined. Forfeited balances of terminated participants’ non-vested accounts were used to reduce future Company contributions. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Prior to Plan termination, vesting in the Company’s contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. A participant was 100% vested after six years of credited service. Participants would become 100% vested upon normal retirement, death, or disability while employed by the Company. Effective with the termination of the Plan, participants became 100% vested in all contributions.

Payment of Benefits

Prior to Plan termination, a participant could elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account upon termination of employment for any reason. Upon plan termination, the participants could elect to have their distribution paid as a lump sum, direct rollover to another eligible retirement plan, or direct rollover to an IRA.

Administrative Costs

Plan fees and administrative expenses were paid by the Company and the Plan on a discretionary basis.

Forfeited Accounts

At December 14, 2023 and 2022, forfeited non-vested accounts totaled \$-0- and \$25,663, respectively. These accounts could be used to reduce future employer contributions or to pay Plan expenses. During 2023, \$33,989 in forfeitures were used to pay Plan expenses.

Notes from Participants

Prior to Plan termination, participants could borrow from their accounts a minimum of \$1,000 up to the maximum of \$50,000 or 50% of their vested account balance, whichever is less. Note terms ranged from one year to five years. The notes were secured by the balance in the participant's account and bore interest at the prime rate plus one percent determined at the time the note was consummated. During the year, interest rates on outstanding notes ranged from 4.25% to 7.75%. Principal and interest were paid through payroll deductions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to determine the amounts at which investments are stated, from an ongoing Plan basis to the liquidation basis for periods after December 31, 2022. See Note 6 for discussion of Plan termination.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through January 29, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's mutual fund and collective investment trust investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The collective investment trust fund issued by Galliard (Galliard Stable Return Fund C) (formerly Wells Fargo Stable Value Fund C) and owned at December 31, 2022 is invested 100% in Galliard Stable Return Fund Core (formerly Wells Fargo Stable Return Fund G) which is composed primarily of a variety of guaranteed investment contracts, security-backed contracts, and short-term investment funds and are valued at the net asset value of units of Galliard (formerly Wells Fargo) collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is no notice period if the Plan initiates a full redemption of the collective investment trust.

Due to Plan liquidation, there are no investments held by the Plan at December 14, 2023.

Note 4 – Investment Contracts

At December 31, 2022, the Plan had investments in Galliard Stable Return Fund C. Included in this fund are certain guaranteed investment contracts and wrapper contracts. These contracts are considered to be benefit-responsive and since those contracts were not purchased directly from Fidelity Management Trust Company, but in the open market, are presented at fair value. The average yield for this fund was approximately 2.65% and 1.91% for 2023 and 2022, respectively. The yield earned by these funds with an adjustment to reflect the actual interest rate credited to participants at December 14, 2023 and December 31, 2022 was 4.92% and 4.95%, respectively. The objective of the fund is to provide stability of principal and consistency of returns with minimal volatility. The fund invests primarily in guaranteed investment contracts, security-backed contracts, and short-term investment funds. Prior to Plan termination, the percentage of contributions allocated to this fund was determined by the participants.

Note 5 – Related Party Transactions

Prior to Plan termination, certain administrative functions were performed by officers or employees of the Company. These employees were also Plan participants. No such officer or employee received compensation from the Plan.

Prior to Plan termination, Plan participants could choose to invest in funds held and managed by the Plan's Trustee. Investments in funds issued and managed by the Trustee are considered related party transactions. Fees paid by the Plan to the Trustee for investment management and record-keeping services for 2023 and 2022 were \$46,703 and \$17,623, respectively.

Note 6 – Plan Termination

Effective August 1, 2023, the Board elected to terminate the Plan and cease all employee deferrals, employer matching contributions and loan payments. All assets were effectively distributed to participants as of December 14, 2023.

Note 7 – Tax Status

The Plan is an adoption of a prototype plan sponsored by Fidelity Management & Research Company. The Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Company has obtained the most recent favorable opinion letter from the IRS dated June 30, 2020. The Company believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 14, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
