Subject: Reasonable Cause for 2024 Form 5500 Filing – SVEA Enterprise Management, Inc. (Dissolved)

To Whom It May Concern,

I am writing in my capacity as the former Chief Executive Officer of **SVEA Enterprise Management, Inc.** ("SVEA"), which formally **ceased operations** and filed for dissolution following the settlement of all outstanding tax obligations. This letter serves to address any potential filing requirement for **Form 5500 for the 2024 plan year** and to request relief from any associated penalties due to reasonable cause.

Reason for Filing Delay & Company Dissolution

- SVEA's **401(k) retirement plan (#292543)** was fully terminated following the **finalization of my personal rollover on January 3, 2024**.
 - As of **January 17, 2024**, all remaining plan assets had been disbursed, marking the completion of all plan-related activities.
 - Given that the plan had **no assets or participants beyond early January 2024**, I was unaware of any continued obligation to file a **2024 Form 5500**.
 - The company had already been **dissolved** upon completion of tax settlements, further reinforcing the understanding that no additional compliance filings were necessary.

Request for Clarification and Penalty Relief


Given the unique circumstances of SVEA's **corporate dissolution and the full distribution of 401(k) assets at the beginning of 2024**, I respectfully request:

1. **Confirmation of whether a 2024 Form 5500 is required** under these circumstances.
2. **Relief from any potential late filing penalties**, as the delay was due to my lack of awareness of the filing requirement considering the company's closure and plan termination.

I appreciate the Department of Labor's guidance and consideration in this matter. I remain fully committed to resolving any outstanding compliance concerns and will provide any necessary documentation upon request.
