## **Statement of Actuarial Assumptions/Methods**

### **Summary of Methods**

This summary of plan provisions as of November 1, 2023 has been prepared for valuation purposes only. It outlines the major plan provisions used to perform the actuarial valuation.

- Withdrawal Benefits: The vested portion of the participant's accrued benefit shall be a percentage of such participant's accrued benefit determined on the basis of the participant's periods of service. Periods of service are elapsed time from date of hire. According to the following schedule:
