

## REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of  
Highgate Hotels 1081.01(d) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Highgate Hotels 1081.01(d) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Highgate Hotels 1081.01(d) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Highgate Hotels 1081.01(d) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

### 1. Description of Plan

The following description of the Highgate Hotels 1081.01(d) Plan (the Plan) provides only general information. Participants should refer to the Summary of the Plan Description for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution profit sharing plan covering all full-time employees of Highgate Hotels LLC (the Plan Sponsor, the Company, or the Employer) who have completed six consecutive months of service and are age 21 years or older. The original effective date of the Plan was August 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan Administration

Effective February 1, 2020, the plan's Trustee appointed Oriental Bank as non-discretionary directed trustee for purposes of ERISA section 403(a)(1), and will have no discretionary control over, nor any other discretion regarding the investment or reinvestment of the Trust assets.

The recordkeeper and custodian of assets was John Hancock Retirement Plan Services LLC until March 15, 2020, when John Hancock made the decision to leave the Puerto Rico retirement plan market. The Plan Sponsor contracted Massachusetts Mutual Life Insurance Company to be the new recordkeeper and custodian of assets.

On January 1, 2021, Great-West Life & Annuity Insurance Company (Empower Retirement LLC) became the recordkeeper and custodian after the acquisition of the retirement business of Massachusetts Mutual Life Insurance Company.

#### Contributions

A participant may contribute not less than 1% of pre-tax annual compensation as defined in the Plan and shall not exceed the pre-tax contribution limit allowed under Puerto Rico Internal Revenue Code section 1081.01(d) (\$15,000). Participants who have attained age 50 or over are eligible to make catch-up contributions up to \$1,500 per Plan Year. Participants direct the investment of their total contributions into various investments options offered by the Plan.

The employer will make matching pre-tax contributions equal to \$0.25 for each dollar of pre-tax contributions made to the plan by an eligible employee up to the first 4% of his/her compensation contributed to the plan throughout the Plan year.

#### Rollover Contributions

Participants may rollover their funds previously held for their account in another employee benefit plan on a tax-free basis.

#### Participants accounts

Each participant's account is credited with the participant's and Company contributions and a pro-rata allocation of the Plan's earnings, net of administrative expenses. The pro-rata allocation is based upon the proportion of individual account balances to total participants' accounts balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions and/or after-tax contributions and actual earnings thereon. Also on qualified matching and/or qualified non-elective contributions and earnings thereon, made by the Plan Sponsor.

Vesting in the Plan Sponsor's profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants

Active employees who participate in the Plan may request loans from their fully vested accounts. The minimum loan amount that a participant may request is \$1,000. The maximum loan amount that a participant may request is \$50,000 or 50% of the vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear an interest rate of 1% over the prevailing prime rate. As of December 31, 2023, the notes receivable had an interest rate which range from 5.00% through 9.50%. Participants loan installments of principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed in the form of a lump sum distribution equal to the value of the participant's vested interest in his/her account or monthly, quarterly, semiannual or annual installments over a period of years certain.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of his retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The balance on these accounts will be used by the Plan's Sponsor to reduce future employer profit sharing and matching contributions or plan administrative expenses. As of December 31, 2023 and 2022, forfeited non-vested accounts totaled \$867 and \$1,805, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contributions of their account.

## **2. Summary of Significant Accounting Policies**

### **Basis of Presentation**

The accompanying financial statements of Highgate Hotels 1081.01(d) Plan have been prepared on the accrual basis and have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### **Investments Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contracts are reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and funds used to pay administrative expenses. Interest income is recorded on an accrual basis.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Use of Estimates**

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Benefit Payments**

Benefit payments are recorded when paid. Benefit payments are recorded when paid. For the year ended on December 31, 2023 the benefits paid amounted to \$31,881.

### **Administrative Expenses**

The Company provides certain administrative and accounting services to the Plan at no cost. Administrative expenses including audit fees and legal fees are paid directly by the Company. Other administrative expenses directly incurred by the Plan include investment management and distributions fees charged directly to the participant's accounts. These administrative expenses are presented as a deduction to net assets on the Statement of Changes in net Assets Available for Benefits.

### **Risk and Uncertainties**

The Plan provides for various investment options that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

### 3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

Financial Accounting Standard Board (FASB) established the Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which provides a framework for defining and measuring fair value under generally accepted accounting principles. This codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. In some cases where market prices are not available, observable market-based inputs are used to calculate fair value, in which case the measurements are classified within Level 2. If quoted or observable market prices are not available, fair value is based upon internally developed models that use, where possible, current market-based parameters such as interest rates, yield curves and currency rates. These measurements are classified within Level 3.

The assets of the Plan are under a group annuity contracts which invests its assets in a Variables Annuities (Annuities). The Annuities' principal is not guaranteed. Contract holders are allocated units of the annuity contract, not specific securities. The value of the Annuities units is the net fair value of the underlying assets on the last day of the Plan's reporting period. The fair market value of the securities in the Annuities includes reinvested dividend and interest income (received and accrued) realized gains and losses, and unrealized gains and losses on a valuation date minus any outside custodial service provider fee of the underlying assets. The underlying investments' performance (interest, dividends, and realized and unrealized gains and losses) is reflected in the unit value. The Annuities Fair Value of each annuity contract is determined by computing the value of the total assets held in such annuity contract and deducting total liabilities, including accrued liabilities, similar to a mutual fund NAV calculation.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with FASB guidance the Annuities have not been classified in the fair value hierarchy as they are measured at fair value using NAV as a practical expedient.

### 4. General Account Fixed Annuity Contract

The Plan has a general account fixed annuity contract with MassMutual Life Insurance Co. that invests contributions in a guaranteed contract with fixed annuity options (the Contract). The Contract is a stable value investment with a guaranteed rate of return and a guaranteed principal that is backed by MassMutual Life Insurance Co. general investment account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Contract value is the relevant measurement attributed to that portion of the net assets available for benefits attributable to the contract which was determined to be fully benefit responsive. The contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

**4. General Account Fixed Annuity Contract (continued)**

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent. Such interest rates are reviewed on a semi-annual basis for resetting.

Participants may ordinarily direct the withdrawal and/or transfer of all or a portion of their account balance at contract value. The Contract issuer is contractually obligated to repay the principal, and a specified interest rate guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan),
- b) removal from the plan one or more groups or classifications of participants,
- c) partial or complete plan termination,
- d) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or
- e) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

1. Puerto Rico Department of Treasury determines that the Plan no longer meets the requirements of Code section 1081.01(a) or any other applicable Code provision
2. a breach of material obligation under the contract
3. a termination or partial termination of the Plan
4. a material amendment to the agreement without the consent of the issuer

**5. Information Prepared and Certified by Empower Retirement**

The following information included in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 and 2022, net appreciation in fair value of investments and interest and dividends for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Custodian:

**6. Tax Status**

On September 21, 2018, the Plan Administrator received the determination letter approving the participation on the new prototype retirement plan and establishing that the established new Trust is exempt under Section 1081.01 of Puerto Rico Internal Revenue Code of 2011. On February 20, 2020, the Plan was amended to change the Trustee.

Accounting principles generally accepted in the United States of America requires to the management of the Plan to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**7. Related-Party Transactions and Party in Interest Transactions**

The Plan has a general account fixed annuity contract with Great-West Life and Annuity Insurance Company. Great-West and its subsidiaries provide administration, custodial and recordkeeping services. These specific investments are issued and managed by Great-West Life and Annuity Insurance Company and qualified as party-in-interest transactions. On December 31, 2020, Great-West acquired the retirement business of Massachusetts Mutual Life Insurance Company (MassMutual), the Plan use insurance products of MassMutual and qualify as a party-in interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for these services of the employees to the Plan.

**8. Subsequent Events**

Subsequent events were evaluated through February 3, 2025, which is the date of the financial statements were available to be issued. Except for the following event no other events have occurred subsequent to the balance sheet date, and the date the financial statements were available to be issued that would require additional adjustment, to or disclosure in the financial statements.

On July 31, 2024, the Plan Sponsor decided to change recordkeeper and custodian of assets from Empower to Principal, which is the recordkeeper and custodian of assets of Highgate Hotels LLC for their other properties in the United States.

**9. Non-exempt Transactions**

As required by ERISA Section 2510.3-102, the Company is required to segregate employee contributions to the Plan from its general assets as soon as practicable but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. During the years 2023, and 2022, the Company did not remit employee contributions as soon as they are able to remit the contributions to the custodian. The Company is able to remit five days after payroll payment and they remit in an average of 4 to 165 days. Total participant contributions considered late amount to \$66,968 in 2023, and \$119,799 in 2022.

# IRS provides relief to Ernesto victims throughout Puerto Rico; various deadlines postponed to Feb. 3, 2025

IR-2024-221, Aug. 23, 2024

WASHINGTON — The Internal Revenue Service announced today tax relief for individuals and businesses throughout Puerto Rico affected by Tropical Storm Ernesto that began on Aug. 13, 2024.

These taxpayers now have until Feb. 3, 2025, to file various federal individual and business tax returns and make tax payments. The IRS is offering relief to any area designated by the [Federal Emergency Management Agency \(FEMA\)](#) .

This means that individuals and households that reside or have a business in any of Puerto Rico's 78 municipalities qualify for tax relief. The current list of eligible localities is always available on the [Tax relief in disaster situations](#) page on IRS.gov.

## Filing and payment relief

The tax relief postpones various tax filing and payment deadlines that occurred from Aug. 13, 2024, through Feb. 3, 2025 (postponement period). As a result, affected individuals and businesses will have until Feb. 3,

2025, to file returns and pay any taxes that were originally due during this period.

This means, for example, that the Feb. 3, 2025, deadline will now apply to:

- Any individual, business or tax-exempt organization that has a valid extension to file their 2023 federal return. The IRS noted, however, that payments on these returns are not eligible for the extra time because they were due last spring before the storm occurred.
- Quarterly estimated income tax payments normally due on Sept. 16, 2024, and Jan. 15, 2025.
- Quarterly payroll and excise tax returns normally due on Oct. 31, 2024, and Jan. 31, 2025.

In addition, penalties for failing to make payroll and excise tax deposits due on or after Aug. 13, 2024, and before Aug. 28, 2024, will be abated, as long as the deposits are made by Aug. 28, 2024.

The [Disaster assistance and emergency relief for individuals and businesses](#) page has details on other returns, payments and tax-related actions qualifying for relief during the postponement period.

The IRS automatically provides filing and penalty relief to any taxpayer with an IRS address of record located in the disaster area. These taxpayers do not need to contact the agency to get this relief.

It is possible an affected taxpayer may not have an IRS address of record located in the disaster area, for example, because they moved to the disaster area after filing their return. In these unique circumstances, the affected taxpayer could receive a late filing or late payment penalty notice from the IRS for the postponement period. The taxpayer should call the number on the notice to have the penalty abated.

In addition, the IRS will work with any taxpayer who lives outside the disaster area but whose records necessary to meet a deadline occurring during the postponement period are located in the affected area.

Taxpayers qualifying for relief who live outside the disaster area need to contact the IRS at [866-562-5227](tel:866-562-5227).

This also includes workers assisting the relief activities who are affiliated with a recognized government or philanthropic organization. Tax preparers located in the disaster area with clients located outside the disaster area can choose to use the [bulk requests from practitioners for disaster relief](#) option, described on [IRS.gov](https://www.irs.gov).


## Additional tax relief

Individuals and businesses in a federally declared disaster area who suffered uninsured or unreimbursed disaster-related losses can choose to claim them on either the return for the year the loss occurred (in this instance, the 2024 return normally filed next year), or the return for the prior year (the 2023 return filed this year). Taxpayers have extra time – up to six months after the due date of the taxpayer’s federal income tax return for the disaster year (without regard to any extension of time to file) – to make the election. For individual taxpayers, this means Oct. 15, 2025. Be sure to write the FEMA declaration number – **3610-EM** – on any return claiming a loss. See [Publication 547, Casualties, Disasters, and Thefts](#), for details.


Qualified disaster relief payments are generally excluded from gross income. In general, this means that affected taxpayers can exclude from their gross income amounts received from a government agency for reasonable and necessary personal, family, living or funeral expenses, as well as for the repair or rehabilitation of their home, or for the repair or replacement of its contents. See [Publication 525, Taxable and Nontaxable Income](#), for details.

Additional relief may be available to affected taxpayers who participate in a retirement plan or individual retirement arrangement (IRA). For example, a taxpayer may be eligible to take a special disaster distribution that would not be subject to the additional 10% early distribution tax and allows the taxpayer to spread the income over three years. Taxpayers may also be eligible to make a hardship withdrawal. Each plan or IRA has specific rules and guidance for their participants to follow.


The IRS may provide additional disaster relief in the future.

The tax relief is part of a coordinated federal response to the damage caused by this storm and is based on local damage assessments by FEMA. For information on disaster recovery, visit [DisasterAssistance.gov](#) .

## Reminder about tax return preparation options
