Dear Staff, we are filing our Form 5500 late this year with our apologies. The Bensinger Group, Inc. is closely held with only two employees: my wife and myself. And, as such, The Bensinger Group, Inc. Profit Sharing Plan only has two participants: my wife and myself.

We have had the same tax and plan advisor for our Profit Sharing Plan for the past 10 years. We paid our fees and provided all the information last fall for them to prepare our 5500 as usual. On January 14, 2025 (two weeks ago) I wrote them to get status knowing we were approaching the deadline. Their automated email said that they were busy, but should take their automated email as a sign they have all our materials. They have always filed on time or filed an extension and filed on time for us, so I trusted the matter to them.

This past Thursday, January 30, 2025 I emailed again not having heard from them. I copied three people that I knew was in their company. Automated emails came back that they had left the company. So within the past two weeks, it appears they have closed their shop. I could not reach anyone after leaving emails and voicemails.

Therefore, over the weekend and today, I began looking at past filings, reading the DOL and IRS instructions for Form 5500, and prepared this filing myself. Please accept my sincere apologies for the late filing.
