## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
**Sexing Technologies 401(k) Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2023 Financial Statements

We have performed an audit of the financial statements of the Sexing Technologies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2023 financial statements).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2023 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2023 Financial Statements section:

### Note 1 - Description of the Plan

The following description of the Sexing Technologies 401(k) Plan (the Plan) is provided for general information purposes only and is as of December 31, 2023 unless otherwise noted. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Inguran, LLC dba Sexing Technologies and its participating employers: XY, LLC; AcuFast, LLC (formerly Fast-Sexing Technologies USA, LLC); Genetic Visions-ST, LLC; Acuity Genetics; Cytonome, LLC; and Cytonome Verity, LLC (collectively, the Employer or Company). The Plan commenced effective January 1, 2012, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following description of the Plan provides only general information and is as of December 31, 2023 unless otherwise noted. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### Administration

Voya Retirement Insurance and Annuity Company (VRIAC or the Custodian) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan's participant account balances, and providing recordkeeping services to the Plan. Among other duties, the Custodian receives contributions, holds, and invests the fund assets in accordance with participant direction, and makes distributions as directed by the Plan Administrator. Certain appointed officers of the Company serve as Trustees of the Plan.

#### Eligibility

Employees of the Company are eligible to participate in the Plan upon completion of two months of service. Eligible employees are permitted to enter the Plan upon the first day of each month coincident with, or next following, satisfaction of the eligibility requirement.

#### Participant Contributions

Participant contributions may be in the form of pre-tax or Roth elective deferrals, up to 100% of eligible compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan may also accept rollover contributions of retirement benefits that originate from another qualified retirement plan or from a "conduit" IRA.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their salary deferral contributions set at 3% of eligible compensation.

### Employer Contributions

The Company may elect to make discretionary matching contributions. The Employer may make a different discretionary matching contribution for each designated location or entity. Discretionary matching contributions are made each pay period and the period for determining the amount of an allocation of discretionary matching contributions is the end of the Plan year. Discretionary matching contributions for 2023 were equal to 50% of the first 6% of plan compensation that a participant contributes to the Plan for all employees of the Company with the exception of AcuFast, LLC employees, which discretionary matching contributions for 2023 were equal to 50% of the first 8% of plan compensation that a participant contributes to the Plan. The total Employer discretionary matching contribution was \$1,377,745 for the year ended December 31, 2023.

The Plan also provides a year end true up matching contribution to allow participants to receive the maximum matching contribution available by making up any loss in matching contributions resulting from participant individual savings strategies. The total Employer true up matching contribution was \$42,345 for the year ended December 31, 2023.

Employer contributions are subject to the limits established annually per the IRC.

### Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions (deferrals and rollovers) and earnings thereon. Vesting in Company contributions is based on years of continuous service at a rate of 20% per year after one full year of credited service. A participant is 100% vested after five years of credited service. Participants also become 100% vested upon death, disability, or attainment of normal retirement age.

### Forfeitures

Forfeitures attributable to terminated participants' non-vested accounts are allocated to a forfeiture account and are used to either pay for certain Plan expenses or reduce employer contributions. For the year ended December 31, 2023, forfeitures of \$5,886 were used to reduce employer matching contributions. Forfeitures available for use as of December 31, 2023 and 2022, respectively, were \$116,069 and \$94,983.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance less the participant's highest outstanding loan balance during the preceding 12 months. Loans are secured by the balance in the participant's account. The maximum number of loans outstanding at any one time is limited to one general purpose loan and one residential purpose loan. The maximum term of a loan is five years, unless the loan is for the purchase of a primary residence, in which case the maximum loan term is fifteen years. The interest rate, determined monthly, is set at 2% above Prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

### Payment of Benefits

On termination of service due to death, disability or retirement or other reasons, a participant may elect to receive a lump sum payment from the vested portion of their account balance. Required minimum distributions are made in accordance with IRS requirements. Distributions may be in the form of a lump sum payment or partial withdrawals. A terminating participant with an account balance of \$5,000 or less automatically receives a distribution from the Plan. If the vested portion of the terminating participant account is less than or equal to \$1,000, the vested account will be distributed in cash. If the vested portion of the terminating participant account is more than \$1,000, but does not exceed \$5,000, the Plan Administrator will transfer the vested account to an IRA established in the name of the participant.

In-service withdrawals are allowed upon reaching age 59½. Hardship withdrawals are allowed as provided under the terms of the Plan adoption agreement and provisions of the IRC.

### **Note 2 - Summary of Significant Accounting Policies**

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefits-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan agreement.

#### Payment of Benefits

Benefits are recorded when distributed.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees and expenses relating to the day-to-day Plan operations are paid by the Plan. Certain investment related expenses are included in the net appreciation in fair value of investments.

### Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 3, 2025, which is the date the financial statements were available to be issued.

### **Note 3 - Unaudited Information Certified by Custodian**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Voya Retirement Insurance and Annuity Company as to its completeness and accuracy and was not subject to any auditing procedures performed by the Plan's independent auditor:

- Investments and notes receivable from participants reflected in the statements of net assets available for benefits as of December 31, 2023 and 2022 and notes to financial statements,
- Investment interest and dividend income, net appreciation in fair value of investments, and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2023, and
- All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2023.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2023 and 2022.

*Pooled Separate Accounts:* Valued at the underlying price per unit held by the Plan as provided by Voya Retirement and Insurance Company. The pooled separate accounts used net asset value (NAV) as the practical expedient for measuring fair value. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fees. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require twelve months notification in order to ensure that security liquidations will be carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily. There are no significant restrictions on participant redemptions or any unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5 - Fully Benefit-Responsive Investment Contract**

The Voya Fixed Account is a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (VRIAC) and as such, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Recordkeeper represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2023 and 2022, the contract value of this investment was \$844,048 and \$750,519, respectively.

VRIAC maintains the contributions in a general account. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for the credit risk of the issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value with VRIAC. Such events include termination of the contract, merger, layoffs, bankruptcy, the creation of a new competing fund, partial or total plan termination and retirement incentive programs. Upon occurrence of any of these events, a market value adjustment may apply. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value are remote.

### **Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all their employer contributions.

### **Note 7 - Tax Status**

The Plan is utilizing a non-standardized pre-approved plan document sponsored by Economic Group Pension Services (the non-standardized plan). The non-standardized plan has been filed with the IRS and has received a favorable opinion letter dated June 30, 2020. The Plan Sponsor has elected not to apply for an individual IRS Determination Letter upon adoption of the Plan nor on any subsequent amendments. Although the Plan has been amended since receipt of the favorable opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified under Section 401(a) and that the related trust is tax-exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2023 and 2022, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

The Plan adopted mandatory provisions of the SECURE Act 2.0 during the year ended December 31, 2023. Written amendments to the Plan document to reflect these operational changes will be executed at a later date in accordance with deadlines pursuant to applicable laws and IRS guidance.

### **Note 8 - Related Party and Party-in-Interest Transactions**

Certain Plan investments are managed by the Custodian. Transactions involving these investments qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. For the year ended December 31, 2023, the Plan paid fees to Voya Retirement Insurance and Annuity Company of \$130,694. Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

### **Note 9 - Risks and Uncertainties**

The Plan invests in investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
