### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

# COKER UNIVERSITY 403(b) DEFINED CONTRIBUTION RETIREMENT PLAN

## NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED JUNE 30, 2024 AND 2023

---

### NOTE 1. DESCRIPTION OF PLAN

The following description of the Coker University (the "University") 403(b) Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General:**

The Plan is a defined contribution plan covering all eligible employees of the University. Each employee is eligible to participate immediately upon beginning employment, but the participant must complete one year of service and attain age 21 to meet the service requirement for eligibility for an employer matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is also subject to the provisions of Section 403(b) of the Internal Revenue Code. The Board of Trustees is responsible for oversight of the Plan. The Fiduciary Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

#### **Contributions:**

Each year, participants may contribute up to the maximum percentage allowable of pretax annual compensation and/or after-tax (Roth) annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and fixed annuity contracts as investment options for participants. The University contributes a discretionary match determined annually at the University's sole discretion. The University's discretionary contribution is 100 percent (100%) of the first one percent (1%) of compensation that a participant contributes to the Plan.

The Plan records employer and employee contributions receivable when compensation is paid, and deferrals are withheld. The Plan adopted ASC 326, *Financial Instruments - Credit Losses*, effective July 1, 2023, using the modified retrospective method. In accordance with ASC 326, no allowance for credit losses has been recorded at June 30, 2024, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

#### **Participant Accounts:**

Each participant's account is credited with the participant's contributions and University matching contributions, if any, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

#### **Vesting:**

Participants are vested immediately in their voluntary contributions plus actual earnings. Participants must work three years to vest in employer contributions.

#### **Payment of Benefits:**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a set number of years. The individual agreements governing the investment options selected may further restrict payout options. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan had no forfeitures in 2024 or 2023.

#### **Notes Receivable from Participants:**

The participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balances reduced by their current outstanding loan balance. Loan terms range up to five years unless the loan is used to acquire the principal residence of the participant, in which case the loan may be repaid over a period up to 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. A participant may have no more than three outstanding loans. The loan interest rates range from 4.25% to 9.50%. The outstanding loan balance for 2024 and 2023 was \$71,398 and \$18,996, respectively.

### NOTE 2. SUMMARY OF ACCOUNTING POLICIES

#### **Basis of Accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### NOTE 2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

#### **Use of Estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Payment of Benefits:**

Benefits are recorded when paid.

#### **Investment Valuation and Income Recognition:**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Administrative Expenses:**

Transaction-related and administrative fees of the Plan are paid by the Plan. A proportionate share of fees and expenses paid by the Plan is charged to each participant's account. Certain administrative expenses of the Plan are paid by the University, including audit fees.

### NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Non-benefit Responsive Fixed Annuity Contracts:* Reported at contract value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Transactions in similar investment instruments are not observable. Certain contract types contain liquidity restrictions on the redemption of annuity accumulations, which could impact the value realized upon exiting the contract. The contract value approximates fair value.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Pooled Separate Accounts:* Valued at the NAV of units of the pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals can be executed any time but are generally limited to one per calendar quarter. Were the Plan to initiate a full redemption of a pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the account in order to ensure that the securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to the pooled separate account.

### NOTE 4. INVESTMENT INFORMATION CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by TIAA-CREF, the Custodian of the Plan, except for comparing such amounts to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certification from the Custodian that such information is complete and accurate.

### NOTE 5. BENEFIT-RESPONSIVE FIXED ANNUITY CONTRACTS

The Plan has entered into benefit-responsive investment contracts with TIAA-CREF. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investments contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. At June 30, 2024 and 2023, the Plan held traditional investment contracts of \$2,178,404 and \$1,428,035, respectively.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contracts cannot be terminated before the scheduled maturity.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### **NOTE 5. BENEFIT-RESPONSIVE FIXED ANNUITY CONTRACTS (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreements without the consent of the issuer.

### **NOTE 6. PLAN LOANS**

Participants may borrow from TIAA-CREF using a portion of their plan account as security for the loan. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 45 percent (45%) of the combined TIAA Traditional and CREF Group Supplemental Retirement Annuity account balances. The loans bear interest of 4.22%, which is commensurate with local prevailing rates as determined periodically by TIAA Insurance Company. The Plan Administrator has concluded that these loans are not Plan assets and that such arrangements are exempt transactions.

The balances as of June 30, 2024 and 2023 are \$0 and \$1,839, respectively. Under the borrowing terms, \$0 and \$2,023 of Plan assets serve as collateral to these loans. Interest paid by participants on such loans during the plan year ended June 30, 2024, was \$52.

In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. There are no loans in default at June 30, 2024 or 2023.

### **NOTE 7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

### **NOTE 8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds, fixed annuity contracts, and pooled separate accounts managed by TIAA-CREF. TIAA-CREF is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in administrative expenses and net appreciation in fair value of investments.

### **NOTE 9. INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program.

The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **NOTE 11. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through December 17, 2024, the date on which the financial statements were available to be issued.
