The reason that I'm filling form 5500SF for the tax year 2021 late, is that I was unaware the form was not filed in 2022. I thought that Paychex had filed the form once the plan was liquidated, and the funds were distributed to the employees. Synergy Logistics Inc. closed in August of 2021. When the company closed, I no longer had the credentials to log in to E-Fast. Paychex completed form 5500SF annually and emailed it to me for submission. Once Synergy Logistics closed, we did not have access to our work email. Our Paychex account was also closed and they never mailed me any follow-up letter stating that I had to file the form.

I hope that you can understand the reason why the form was not filed. I would have gladly filed the form on time if I was aware that it had to be done.
