To the Plan Administrator and Participants of the
LTIMindtree Limited 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LTIMindtree Limited 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of January 26, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period January 1, 2024 through January 26, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of LTIMindtree Limited 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of January 26, 2024 and December 31, 2023 and for the period January 1, 2024 to January 26, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of LTIMindtree Limited 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, during 2024, the plan administrator approved the merger of the Plan into the 401(k) plan of the plan sponsor's parent company, and as of January 26, 2024, all assets of the Plan had been transferred. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements, to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

1. DESCRIPTION OF THE PLAN

The following brief description of the LTIMindtree Limited 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan which was established effective January 1, 2013. The Plan is sponsored by LTIMindtree Limited (the “Company”). Principal Life Insurance Company (“Custodian”) is the custodian of the Plan’s investments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 22, 2024, the Company approved the merger of the Plan into LTIMindtree LTD 401(k) Plan, and as of January 26, 2024, all the Plan’s assets have been transferred to the LTIMindtree LTD 401(k) Plan. Voya Retirement Advisors will be the custodian of the new plan.

The amount transferred to the LTIMindtree LTD 401(k) Plan was as follows:

Eligibility – Prior to January 26, 2024, the Plan covered all employees of the Company who were not members of a collective bargaining unit in which retirement benefits are the subject of good faith bargaining agreement or nonresident aliens. Any eligible employee of the Company who had attained age 18 was eligible to participate in the Plan beginning on the first day of employment. An employee was eligible for employer contributions after completing at least three months of service.

Contributions – Prior to January 26, 2024, employees who were eligible and elect to participate in the Plan could contribute up to the maximum percentage of pre-tax annual compensation allowable under the Internal Revenue Code (“IRC”). From time to time the pretax contributions of certain employees, designated as highly compensated employees under IRC rules, were limited so that the Plan could satisfy various non-discrimination tests required under applicable Federal regulations. Participants could elect to contribute up to 100% of their regular compensation (subject to certain limitations), as defined by the Plan. Also, in accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 for 2024. Eligible employees could make an additional employee contribution known as a “catch-up” contribution in accordance with the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024. Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company contributed to the Plan, on behalf of each participant, an amount equal to 100% of the first 3% and 50% of the next 2% of his or her base compensation that the participant contributed to the Plan.

The Plan allowed for the Company to make a discretionary profit-sharing contribution. Contributions were subject to certain limitations. No profit-sharing contribution was made for the period January 1, 2024 through January 26, 2024.

Rollovers – Prior to January 26, 2024, rollover contributions were permitted into the Plan in accordance with IRS regulations and Plan provisions.

1. DESCRIPTION OF THE PLAN (continued)

Participant Accounts - A separate account was maintained for each participant. Each participant's account was credited with his or her contribution, the Company's matching contributions, and an allocation of the Plan's earnings or losses. Allocations of earnings or losses were based upon the investment performance of the individual funds in which each participant's account balance was invested. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations of expenses were based upon account balances, as defined in the Plan agreement. Participants could change their investment elections at any time through the Plan's record-keeper. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Notes Receivable from Participants - Participants could borrow from their individual account balances in accordance with the Plan's provisions. The maximum amount of any loan was the lesser of (a) \$50,000 or (b) one-half the value of the participant's vested account but not less than \$1,000. Loans were collateralized by the participant's vested account. All loans were charged an interest rate as determined by the Plan administrator and had to be repaid in five years. The interest rates of loans ranged from 4.25% to 9.50%, maturing through November 2028. Interest and principal were paid ratably through payroll deductions. Upon termination of employment, the participant could either repay any outstanding balance in full or incur a tax liability on the unpaid balance. As a result of the merger of the Plan into the LTIMindtree LTD 401(k) Plan, all outstanding participant loan balances were transferred to the LTIMindtree LTD 401(k) Plan on January 26, 2024.

Vesting - Plan participants were fully vested in their rollover contribution and elective deferral contributions, employer matching contributions, plus actual earnings thereon.

Vesting in the Company's profit-sharing contributions and related earnings or losses was based on years of continuous service as follows:

Less than 1 year of service	0%
After 1 year of service	15%
After 2 years of service	35%
After 3 years of service	65%
After 4 years of service	100%

A participant became 100% vested in the Company's contributions if he or she attained normal retirement age of 65, incurred a total and permanent disability or died while employed by the Company.

Distributions - Participants could withdraw their funds from the Plan upon termination of employment with the Company, death or achievement of normal retirement age of 65. Distributions were paid out as a single sum, partial payments, and distributions in kind. Employees could defer distribution only if the account balance was greater than \$5,000. If the account balance exceeded \$1,000 but was less than \$5,000, the Plan administrator could direct the Custodian to distribute the amount to an Individual Retirement Account or Annuity ("IRA"). If the participant's account was \$1,000 or less, the Plan administrator was authorized to direct the Custodian to issue a lump-sum distribution without the participant's written consent.

Forfeited Accounts - Forfeited balances of participants' non-vested accounts were first used to pay for Plan expenses, then used to reduce future employer contributions. For the period January 1, 2024 through January 26, 2024, no forfeitures were used to pay Plan expenses. At December 31, 2023 there were unallocated forfeitures of \$3. As a result of the merger of the Plan into the LTIMindtree LTD 401(k) Plan, unallocated forfeitures totaling \$3 were transferred to the LTIMindtree LTD 401(k) Plan on January 26, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – As a result of the resolution in 2024 to merge the Plan into the LTIMindtree LTD 401(k) Plan, the Plan’s financial statements are presented using liquidation basis of accounting for the period January 1, 2024 through January 26, 2024 in accordance with accounting principles generally accepted in the United States of America (“GAAP”). No adjustments to the financial statements were required to present the liquidation basis of accounting. The statement of net assets available for benefits as of December 31, 2023, is presented using the going concern basis of accounting in accordance with GAAP.

Use of Estimates – The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of asset and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Valuation of Investments and Income Recognition – Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for descriptions of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant’s account and were included as administrative expenses when incurred. As of January 26, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant did not make loan repayments and the Plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based upon the terms of the Plan agreement.

Administrative Expenses – Certain expenses of maintaining the Plan were paid by the Company and were therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant’s account and were included in administrative expenses. Expenses attributable to the administration or operation of the Plan were allocated pro rata on the basis of account balances of all participants. Investment related expenses were included in the net appreciation of fair value of investments.

Payment of Benefits – Benefit payments to participants were recorded when paid.

3. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The Plan’s management has elected the method of compliance permitted by 29 CFR 2520:103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan’s management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except for comparing such information certified by the Custodian with information included in the Plan’s financial statements.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during 2024 and at December 31, 2023.

Pooled Separate Accounts – The Plan has investments in participation units held in pooled separate accounts (“PSA”) through sub-accounts of an insurance company. The net asset value (“NAV”) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The underlying securities in the pooled separate accounts trusts are listed on national securities exchanges and valued on the basis of year end closing prices. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits, administrative maintenance charges and other items) and reported by the insurance

company approximates fair value of the investments. The investments are redeemable at the adjusted NAV under agreements with the insurance company.

Common Collective Trusts – The Principal Stable Value Fund, Principal Trust Income Fund, and Principal Target Funds are held in common collective trust funds, which consist of investments in mutual funds, collective trusts and PSAs. The stable value fund, held in a common collective trust fund, invests 100% of its’ funds in The Morley Stable Value Fund (“Morley”). Morley invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. Characteristics of these contracts allow for their principal value to remain stable regardless of the volatility of the financial markets. For liquidity purposes, Morley may have a portion of its assets invested in high quality money market instruments, investment companies and collective investment trusts.

These investments are valued at NAVs per share as of the close of business on the valuation date. The NAV is quoted on a private market that is not active; however, the unit price is based on the value of the underlying investment assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. These investments are valued at NAV of the units held by the Plan.

NAV would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Due to the merger and transfer of all plan assets during 2024, the Plan held no investment assets at January 26, 2024.

5. PLAN TERMINATION

Pursuant to the plan of merger executed in 2024, participants were notified that the Plan would be merged into the LTIMindtree LTD 401(k) Plan. As of January 26, 2024, all of the Plan's assets were transferred to the aforementioned plan and the Plan was terminated.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were shares of pooled separate accounts and common collective trusts with or managed by Principal and affiliates. Principal was the custodian as defined by the Plan. Loans to the participants were secured by balances in the respective participant accounts. These transactions qualify as party-in-interest transactions and are exempt from prohibited transaction rules. Administrative fees and investment advisory fees paid to Principal totaled \$22,865 for the period January 1, 2024 through January 26, 2024.

7. RISK AND UNCERTAINTIES

The Plan invested in various securities including pooled separate accounts and common collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances that were transferred to the LTIMindtree LTD 401(k) Plan during 2024.

8. FEDERAL INCOME TAX STATUS

The Plan adopted a prototype non-standardized profit-sharing plan with cash or deferral arrangement, which received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan and related trust were designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan was qualified, and the related trust was tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 26, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up For Retirement Enhancement Act ("SECURE Act 2.0"). The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Given the resolution to merge the Plan into the LTIMindtree LTD 401(k) Plan during 2024 (see Note 1) these provisions had no material effect on the Plan.

10. SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through January 17, 2025, the date which the financial statements were available to be issued. Based upon that evaluation, the Plan's management has determined that no subsequent events have occurred which would require disclosure in or adjustment to the financial statements.

11. RECONCILIATION TO FORM 5500

No material differences exist between the financial statements and Form 5500.


