Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Counseling Center of Mercer County 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

FOR THE PLAN YEARS ENDED JUNE 30, 2024 AND 2023

1. Description of Plan

The following description of Community Counseling Center of Mercer County (Organization) 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Organization is a Pennsylvania non-profit organization formed to provide a variety of professional mental health services to individuals primarily in western Pennsylvania. The Plan was established for the purpose of providing retirement benefits to the employees of the Organization. The accompanying financial statements include only the activity and financial position of the Plan and are not intended to reflect the Organization as a whole.

General

The Plan is a defined contribution plan covering substantially all hourly and salaried employees of the Organization. The Plan was established July 1, 1991 and restated on July 1, 2019.

As of July 1, 2019, the Organization also implemented automatic enrollment at a 3% deferral rate for new employees. Entrance to the Plan is the first day of the month coinciding with 30 days after becoming employed by the Organization.

Effective January 1, 2023, the Organization amended the Plan to include a provision for an annual automatic salary deferral increase of 1% to the employee's current contribution percentage not to exceed 10%. This provision does not apply to those employees that contribute 10% or greater. Employees may revise their percent contribution or opt-out at any time.

Upon attaining one year of service, a person becomes eligible to participate in the employer discretionary contribution. Entry dates for the employer discretionary contribution is the first day of the first month or the first date of the seventh month of the Plan year.

Contributions

Participants may elect to contribute to the Plan, on a salary-deferral basis, the maximum amount of their pretax compensation permitted by law. Additionally, the Plan allows for a Roth contribution option for participants. Participants may contribute 100% of their compensation subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Organization's profit-sharing contribution is discretionary, determined annually, and approved by the Organization's Board of Directors. The Organization's discretionary contributions are allocated based on a percentage of compensation to participants, which was five percent for June 30, 2024 and 2023. The employer discretionary contribution for the years ended June 30, 2024 and 2023 was \$157,739 and \$145,183, respectively. The Plan also provides for discretionary matching contributions; however, no such contributions were made for the years ended June 30, 2024 and 2023. During June 30, 2024, the employer identified and corrected through self-correction a participant that was eligible for the employer discretionary contribution for prior years in the amount of \$4,887 that is included in employer contributions on the statements of changes in net assets available for benefits.

Participant Accounts

Participants direct the investment of their contributions and the Organization's contributions into various investment options offered by the Plan.

Each participant's account is credited with an allocation of the Organization's discretionary contributions, Plan earnings and losses, forfeitures, and administrative expenses. The participant's account is also credited with any salary deferral and Roth contributions. Allocation of the Plan's earnings and losses are based on the proportion that each participant's account bears to the total of all participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

Vesting

Participants are vested immediately in their elective deferral contributions plus actual earnings thereon. Plan participants become fully vested in employer discretionary contributions according to the vesting schedule below or at the earliest of the following dates: a) the date of the participant's death, or b) the date the participant incurs total disability. The vesting schedule is as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts for any reason. Participants may not receive a loan of less than \$1,000 nor greater than \$50,000. Loans are generally limited to 50% of the participant's vested account balance. Participants are only permitted one loan during any twelve-month consecutive period and may have only one loan outstanding at a time. The Internal Revenue Code also provides certain limitations. Loans are secured by the balance in the participant's account and bear interest that ranges from 4.25% to 9.50% and 4.25% to 9.25% for the Plan year end June 30, 2024 and 2023, respectively. Principal and interest is paid ratably through payroll deductions. All loans are governed by the provisions of the Plan Loan Policy Statement. In the event of default, participants are considered to have received a distribution and are subject to income taxes on the distributed amount. Also, participants may be subject to an additional 10% penalty tax on their taxable withdrawal if it

occurs prior to age 59 ½. Repayment terms may not exceed five years unless the loan is granted for the purpose of acquiring the participant's principal residence.

Benefit Payments

Plan benefits are generally paid to participants at retirement, death, or disability. Normal retirement is at age 65; however, participants may take in-service distributions when they are 59.5 years old. The Plan also permits participants to take hardship distributions. Participants or their beneficiaries may elect to receive an amount equal to the value of the participant's vested account in either a lump sum amount or in annual installments over a fixed period of time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

If a participant is not vested upon termination, the nonvested portion of their account balance contributed by the employer and the earnings thereon are forfeited. Forfeited amounts are re-allocated to the account balances of the remaining participants based upon the ratio of the employees' eligible compensation to the compensation as a whole for all eligible participants. At June 30, 2024 and 2023, forfeited amounts re-allocated to remaining participants totaled \$17,259 and \$4,365, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining fair value, the Plan considers the principal and most advantageous market in which it would transact and considers the assumption that market participants would use when pricing the asset or liability. See Note 3 for a discussion of fair value measurements

The cost of investments sold or distributed is determined using the specific identification method. Investment purchases and sales of securities are accounted for on a trade-date basis. Interest and dividends are recorded when earned.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Management Fees and Operating Expenses

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value investments in the accompanying statements of changes in net assets available for benefits.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction in contributions revenue.

Benefit Payments

Benefits payments are recorded when paid. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of June 30, 2024 and 2023.

Administrative Expenses

Certain administrative and recordkeeping expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. At any time, the Plan may elect to have all such expenses paid by the Plan participants.

Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than quoted market prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable for the asset or liability and can be corroborated by observable market data for substantially the full term of the asset or liability.

Level 3 – Inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of

unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at June 30, 2024 or 2023.

Mutual funds are valued at the closing price reported on the active market on which the individual securities are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of the future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certification of Financial Information by the Plan's Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net (depreciation) appreciation in fair value of investments and dividends and interest for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the custodian of the Plan.

5. Income Tax Status

The Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the prototype sponsor and the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. In addition, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

6. Related-Party and Party-In-Interest Transactions

Certain Plan investments in the mutual funds accounts are managed by Vanguard. Vanguard has an agreement with Ascensus Trust Company for Ascensus Trust Company to provide certain recordkeeping and administrative services on behalf of Vanguard. As such, Ascensus Trust Company is the custodian and Vanguard is the recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administration fees

paid by the Plan to Ascensus Trust Company amounted to \$13,266 and \$11,513 for the years ended June 30, 2024 and 2023, respectively. The Organization provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

7. Reconciliation of Financial Statements to Form 5500

Although the third-party administrator of the Plan uses the accrual basis of accounting to prepare the Form 5500, the Form 5500 does not reflect the excess contribution as a reduction to employee contributions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

9. Plan Termination

Although it has not expressed an intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.


