## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of American Guardian Warranty 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the American Guardian Warranty (“the Company”) 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who are age twenty-one or older and have completed six months of service with the Company. Once eligibility requirements are met, employees may begin participating in the Plan on the first day of each quarter. The Plan requirements are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

Contributions

Each year, participants may contribute up to the maximum percentage allowable, not to exceed the limits of Code Sections 401(k), 402(g), 404 and 415 of pretax annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a tiered discretionary matching contribution to the Plan. In 2024 and 2023, the Company made a single-tier matching contribution equal to 50% of the first 6% of eligible compensation that a participant contributed to the Plan. Participants direct the investment of their contributions and Company contributions into one or more investments offered by the Plan.

**NOTE 1 – DESCRIPTION OF THE PLAN (CONT'D)**

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are permitted to allocate contributions between the available investment funds. Each fund provides different investment objectives and degrees of risk. Income from the funds is allocated based on participant account balances adjusted for contributions, distributions, and fund transfers in the current year.

Vesting

Participants are immediately vested in their contributions and the employer's safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings, is based on continuous years of service according to the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. The interest rates on these loans are established by the administrative record keeper in a nondiscriminatory manner and range from 2.54% to 4.60%. Principal and interest is paid ratably through payroll deductions and automatic withdrawals from the participant's bank accounts. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

**NOTE 1 – DESCRIPTION OF THE PLAN (CONT'D)**

Payment of Benefits

Upon separation from service with the Company due to death, disability, retirement or termination, a participant whose vested account balance exceeds \$1,000 may elect to receive either a lump-sum or may elect substantially equal installment payments. A participant whose vested account balance is \$1,000 or less and has not commenced receiving installment payments will automatically receive an immediate lump-sum distribution equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Excess Contributions

At February 29, 2024 and December 31, 2023, amounts payable to participants totaling \$0 and \$27,652, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability and are reported as corrective distributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Forfeited Accounts

At February 29, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$25,988, respectively. The forfeited accounts will be used to reduce employer contributions. During 2024 and 2023, a total of \$25,988 and \$8,669 in forfeitures were used to reduce the employer matching contribution, respectively. The employer matching contribution as of, and for, the year ended February 29, 2024 and December 31, 2023 is shown net of \$0 and \$25,988, respectively in forfeitures used when it was settled in 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)**

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

New Accounting Pronouncements

While FASB regularly issues new Accounting Standards Updates (ASUs), the Plan did not apply any new ASUs in 2024 or 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants totaling \$27,652 for contributions in excess of amounts allowed by the IRS are recorded as a liability with the corresponding reduction in 2023 contributions. The Plan distributed the 2023 excess contributions prior to March 15, 2024.

Payment of Benefits

Benefits are recorded when paid.

##### Administrative Fees

Administrative fees consisting of distribution fees and fees for terminated participants with vested balances are paid by the Plan, from participant accounts. All other expenses of maintaining the plan are paid by the Company.

##### Date of Management Review

The plan has evaluated subsequent events through January 30, 2025, the date the financial statements were available to be issued.

#### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONT'D)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 29, 2024 and December 31, 2023.

**Pooled Separate Accounts:** The fair value of mutual funds in pooled separate accounts is determined by each fund's custodian based on the fair value of the underlying securities within the fund, which represent the net asset value of shares held by the plan at year end. The investment in the fund is carried at fair value based on the closing price of the National Association of Securities Dealers Automated Quotations (NASDAQ). Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

Based on the above definition, all plan assets have been classified as Level 2 at February 29, 2024 and December 31, 2023. There have been no changes in the methodologies used as of February 29, 2024 and December 31, 2023.

The plan's policy is to recognize transfers between levels as of the end of the reporting period. There were no significant transfers between levels during 2024 and 2023.

**NOTE 4 – GROUP ANNUITY CONTRACT WITH MINNESOTA LIFE INSURANCE COMPANY**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company ("Minnesota Life") totaling \$0 and \$1,625,058 at February 29, 2024 and December 31, 2023, respectively. Minnesota Life maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.50%. The credit rate is reviewed regularly for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

COMPANY (CONT'D)**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST  
TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is the trustee and administrative record keeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$60 for the year ended February 29, 2024. These fees were deducted from participant accounts. Munninghoff, Lange & Co. is the independent auditor for the Plan. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 – PLAN MERGER**

On March 1, 2024, the Plan was merged into The Reynolds and Reynolds Company 401k Plan. Prior to the merger, the Plan covered eligible employees at the American Guardian Warranty Services, Inc. The transferred net assets have been recognized in the accounts of The Reynolds and Reynolds Company 401k Plan as of March 1, 2024, at their balances as previously carried in the accounts of the American Guardian Warranty 401(k) plan. **NOTE 7 – PLAN AMENDMENTS**

There were no amendments in 2024 or 2023.

**NOTE 8 – TAX STATUS**

Effective June 30, 2020, the Plan adopted a volume submitter profit sharing plan with a cash-or-deferred arrangement, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving this opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 8 – TAX STATUS (CONT'D)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) for any uncertain position that more likely would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of February 29, 2024 and December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 12 – CORRECTIVE CONTRIBUTIONS**
