## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of the  
Lucky Eagle Casino 401(k) Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Lucky Eagle Casino 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C)[ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net position available for benefits as of the transfer date, August 15, 2023 and December 31, 2022, and the related statements of changes in net position available for benefits for the period from January 1, 2023 through August 15, 2023 (the transfer date) and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 15, 2023 and December 31, 2022, and for the period from January 1, 2023 through August 15, 2023, and for the year ended December 31, 2022, stating the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for twelve months beyond the financial statements date, including any currently known information that may raise substantial doubt shortly thereafter.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1: Description of the Plan**

The following description of the Lucky Eagle Casino 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan was a defined contribution plan covering employees of the Lucky Eagle Casino (the "Casino"), who had attained the age of 18 and completed three months of service. The Plan had two features: a salary deferral feature and an employer match feature. The Plan became effective on January 1, 1999, and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective May 1, 2016, the Plan elected to offer a Roth 401(k) feature. Effective March 1, 2017, the Plan elected to remove suspension of elective deferrals for hardship distributions. The Casino was the Plan's sponsor and served as plan administrator.

**Contributions** - Each year, participants could contribute a percentage of their annual compensation, up to established Internal Revenue Service (IRS) limits. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan included an automatic salary deferral feature in which 3% of the participant's compensation was automatically withheld and contributed to the Plan once the participant met the eligibility requirements. A participant could elect not to participate in the Plan upon notification to the Plan sponsor. The Plan allowed for the Casino to make employer matching contributions up to 3% of participant compensation.

**Investments** - Participants directed their elective contributions into various investment options offered by the Plan and could change their investment options anytime throughout the year. The Plan offered several investment choices through investments held with The Standard Insurance Company. If a participant did not elect an investment option at the time of enrollment, their contributions were invested in the applicable lifecycle fund based on the participant's age until the participant changed their election. The Casino's contributions were allocated in the same manner as that of the participant's elective contributions.

**Participant Accounts** - Each participant's account was credited with the participant's salary deferral contribution, the Casino's matching contribution, and the allocation of the Plan earnings (losses). The benefit to which a participant was entitled to was the vested portion of the participant's account.

**Vesting** - Participants were immediately vested in their voluntary contributions and earnings thereon. The Casino's matching contributions and actual earnings thereon become vested as follows:

**Notes Receivable from Participants** - Participants could borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans were secured by the balance in the participant's account and charged interest at the prime rate. Principal and interest were paid ratably through bi-weekly payroll deductions.

**Payment of Benefits** - Upon disability, retirement, death, or termination of employment, a Plan participant or beneficiary could elect to receive either a lump-sum amount equal to the value of the account, equal installments over a period of time, or a different form of commercial annuity.

**Forfeitures** - At August 15, 2023 and December 31, 2022, forfeited amounts available to offset employer contributions totaled \$0. During the period from January 1, 2023 through August 15, 2023, and for the year ended December 31, 2022, the Casino utilized \$0 and \$3,948, respectively, in forfeitures to offset Plan expenses. During the period from January 1, 2023 through August 15, 2023, and for the year ended December 31, 2022, the Casino utilized \$0 and \$0, respectively, in forfeitures to fund the employer match.

**Note 2: Summary of Significant Accounting Policies**

The following significant accounting policies were used to prepare the financial statements in accordance with generally accepted accounting principles.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Generally accepted accounting principles include statements from the Governmental Accounting Standards Board (GASB), as well as other guidance provided by the American Institute of Certified Public Accountants Audit and Accounting Guide, *Employee Benefit Plans*.

In April 2022, GASB issued Statement No. 99, *Omnibus 2022*. The objectives of this statement are (1) to enhance comparability in accounting and financial reporting and (2) to improve the consistency of authoritative literature by addressing practice issues that have been identified during implementation and application of certain GASB Statements and accounting and financial reporting for financial guarantees. GASB Statement No. 99 becomes effective as follows: (a) the requirements in paragraphs 26-32 of this statement were effective upon issuance, (b) the requirements in paragraph 11-25 of this statement became effective for the Plan for the 2023 reporting period, (c) the requirements in paragraphs 4-10 of this statement would have become effective for the Plan for the 2024 reporting period. Implementation of the requirements in paragraphs 11-25 of this statement did not have a significant impact on the Plan's financial statements.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therewith, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, except for the fully benefit-responsive investment contracts, which was reported at contract value, as certified by the Plan's custodian, The Standard Insurance Company. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Fully benefit-responsive investments were reported at contract value. Contract value was the most relevant measurement attribute because it was the amount that participants in a plan would receive in a permitted participant-initiated transaction.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represented participant loans that were recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded when was received. No allowance for credit losses was recorded as of December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payment of Benefits

The Plan recognized benefit payments in the period the benefits were actually paid.

Administrative Expenses

The Plan's administrative expenses were paid by either the Plan, through forfeitures, or by the Casino, as provided by the Plan's provisions. Administrative expenses paid by the Plan included recordkeeping and trustee fees. Expenses related to the purchase, sale, or transfers of the Plan's investments were charged to the particular investment fund to which the expenses relate. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative fees. All other administrative expenses of the Plan were paid by the Casino.

Date of Management's Review

Subsequent events were evaluated through October 30, 2024, which is the date the financial statements were available to be issued.

**Note 3: Fair Value Measurements**

The Plan's investments, excluding the fully benefit-responsive investment contract, were reported at fair value in the accompanying statements of net position available for benefits. The methods used to measure fair value could produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

GASB Statement No. 72, *Fair Value Measurement and Application*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under GASB Statement No. 72 are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date; and Level 3 inputs are unobservable and have the lowest priority. The Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measured fair value using Level 1 inputs because they generally provided the most reliable evidence of fair value. The Plan used Level 2 inputs when Level 1 inputs were not available to the Plan. There were no Level 1 or 3 inputs required to be used by the Plan.

Level 2 Fair Value Measurements

The fair value of the mutual funds held in the pooled separate accounts were based on inputs other than quoted prices included within Level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs included quoted prices for similar assets or liabilities in active or non-active markets. Fair value of the investments was based on the net asset value of the fund as reported by the investment advisor. Net asset valuation was computed by dividing the total assets minus liabilities, allocated to each share class by the number of shares outstanding for that class at the close of each business day that the New York Stock Exchange is open. Level 2 inputs also includes insignificant adjustments to market inputs.

For the period from January 1, 2023 through August 15, 2023, and for the year ended December 31, 2022, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$854,350 and \$(1,767,758), respectively.

**Note 5: Fully Benefit-Responsive Investment Contracts**

The Plan invested in a fully benefit responsive investment contract with The Standard Insurance Company. The Standard Insurance Company maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

The guaranteed investment contract met the fully benefit-responsive criteria and, therefore, was reported at contract value. Contract value, as reported to the Plan by The Standard Insurance Company, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value of the fully benefit-responsive investment at August 15, 2023 and December 31, 2022, was \$0 and \$899,257, respectively.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain information disclosed in the accompanying financial statements, including investments, fully benefit-responsive investment contract, at contract value, and notes receivables from participants held at August 15, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest income, interest income on notes receivables from participants, and administrative expenses for the period from January 1, 2023 through August 15, 2023, and for the year December 31, 2022, was obtained by management and agreed to information certified as complete and accurate by The Standard Insurance Company (the custodian of the Plan).

The Plan's independent certified public accountants did not perform auditing procedures with respect to the above information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets.

**Note 9: Related Party/Party-in-Interest Transactions**

Certain Plan investments were shares of mutual funds managed by The Standard Insurance Company. The Standard Insurance Company was the custodian as defined by the Plan. Certain investment advisory services were provided by Financial Advocate Investments, while certain record keeping services were performed by StanCorp Financial Group. These transactions qualify as related party/party-in-interest transactions. Fees paid by the Plan for these services amounted to \$28,263 and \$40,964 for the period from January 1, 2023 through August 15, 2023, and for the year ended December 31, 2022, respectively. Also, certain administrative functions were performed by employees of the Plan sponsor on behalf of the Plan.

**Note 10: Tax Status**

The trust established under the Plan to hold the Plan's assets was qualified pursuant to the appropriate section of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income was exempt from income tax. The Plan obtained a favorable tax determination letter dated March 31, 2008, from the Internal Revenue Service, covering the Plan offered by the trustees. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan sponsor believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC, and therefore believed that the Plan was qualified and the related trust is tax-exempt.

The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 11: Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net position available for benefits.

**Note 12: ERISA Fidelity Bond**

ERISA requires that employee benefit plans obtain a fidelity bond to protect the Plan against theft of Plan assets by fiduciaries and other Plan officials. The amount of the bond is fixed at the beginning of the Plan year, in an amount that is not less than 10% of the Plan assets as of the beginning of the Plan year, up to a maximum bond requirement of \$500,000. Bonds were in place during the period from January 1, 2023 through August 15, 2023, and for the year ended December 31, 2022.

**Note 13: Transfer of Plan Assets**

On August 15, 2023, all Plan assets and participants of the Plan were transferred into the Choice Pooled Employer Plan I. The amount transferred into the Choice Pooled Employer Plan I was \$10,308,309.


