### Report on the Audit of the Financial Statements

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Allen-Chase Foundation dba: Eaglebrook School Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established to provide retirement benefits in compliance with the Internal Revenue Code (IRC) under Section 403(b) for all eligible employees of Allen-Chase Foundation dba: Eaglebrook School (the School). Eligible employees may begin to make salary deferral contributions on the first day of employment. Students, leased employees, nonresident aliens, employees who are eligible to participate in another qualified plan, and employees who normally work less than 20 hours per week are excluded from participation in the Plan. The Plan is subject to the provisions of ERISA and the IRC. The trustees of the School are responsible for oversight of the Plan. The Retirement Plan Fiduciary Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the trustees of the School.

**Plan Amendments**

Effective December 31, 2023, the Plan was amended to allow for mandatory distributions following severance of employment for participant accounts under \$5,000. All other plan provisions remain substantially the same.

**Contributions**

Each year, participants may contribute to the Plan a percentage of their pre-tax annual compensation, as defined by the Plan. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. The Plan has also elected to allow participants to make qualified organization catch-up contributions provided they have completed at least 15 years of service, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The School makes nonelective contributions equal to 8% of base compensation, as defined by the Plan, for employees classified as Day Care, Maintenance and Kitchen Employees. The School also makes matching contributions equal to 8% of base compensation for all other eligible employees provided that each participant makes salary deferral contributions to the Plan of at least 5% of their eligible compensation. A participant who is age 21 or older becomes eligible for the School's contribution after two years of service (minimum 1,000 hours of service), as defined in the Plan document. Additional discretionary contributions may be contributed at the option of the School; however, there were no additional discretionary contributions made for the year ended June 30, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and School's nonelective or matching contributions, as well as allocations of any School discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Participants may direct their contributions into any funds offered by the Plan, which are held by Teachers Insurance and Annuity Association and College Retirement Equities Fund (TIAA and CREF). These accounts include a variety of investment options with various objectives and degrees of financial risk.

**Vesting**

Participants are immediately vested in their deferral, nonelective, matching and rollover contributions, including the earnings on those amounts.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a longer term. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The notes currently bear interest at rates ranging from 4.25% to 9.50%. Generally, principal and interest are paid ratably by the participants through electronic funds transfers.

**Plan Loans**

Participants may borrow funds based on their pre-tax deferral accounts from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loans may be further limited based on a participant's account balances and restrictions included in annuity contracts and Plan provisions. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term of up to 10 years. The loans are secured by the balances in the participant's accounts. Loans bear interest at rates that may be fixed or variable depending on the TIAA and CREF contract. The loans currently bear interest at rates ranging from 4.00% to 5.56%. Loans are issued directly from funds owned by Teachers Insurance and Annuity Association (TIAA) and are administered by TIAA directly with the participant outside of the Plan. Therefore, these loans are not included as assets of the Plan.

**Plan Loans (Continued)**

These outstanding loans were \$30,982 and \$49,248 at June 30, 2024 and 2023, respectively. Included in these amounts are loans in default at June 30, 2024 and 2023 totaling \$5,636 and \$5,355 respectively. These balances represent situations where the participant has defaulted on the terms of the loan agreement but has not yet incurred a distributable event. Therefore, the investments securing these loans remain Plan assets until a distributable event occurs and TIAA may act on the collateral.

**Payment of Benefits**

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid by lump sum, installments over a number of years, or purchase of an annuity, based upon election of the participant as defined in the Plan or the IRC. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$5,000, the Plan administrator may distribute such amount in a lump-sum, installments or annuity payment to the participant without consent of the participant.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59½ from pre-tax deferral accounts only. In addition, upon financial hardship, a participant is entitled to the value of his or her deferral accounts, but not the earnings thereon, which is payable immediately in a lump-sum distribution.

**Revenue Sharing**

The Plan holds assets in a Plan expense account which receives deposits as a result of a revenue sharing arrangement with TIAA and CREF. During 2024, deposits to the account totaled \$47,697, which are included in other income on the statement of changes in net assets available for benefit. Funds in the account are used to pay qualified Plan expenses. For the year ended June 30, 2024, no revenue sharing credits were used to pay Plan expenses. The revenue sharing account totaled \$254,793 and \$197,690 as of June 30, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution retirement plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Certain individual contracts included in the Plan's investment in the TIAA Traditional Annuity are considered to be fully benefit-responsive.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Other income represents income received from plan servicing credits with TIAA and CREF.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**Risks and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events were evaluated through January 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION BY THE CUSTODIANS**

Information presented in the accompanying statements and schedule as of June 30, 2024 and 2023, and for the year ended June 30, 2024 for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Teachers Insurance and Annuity Association and College Retirement Equities Fund, the insurance carriers of the Plan as of June 30, 2024 and 2023, and for the year ended June 30, 2024. The certification extends to TIAA Trust, N.A., a national trust bank, held as a directed trustee or custodian that were record kept by TIAA for the period after July 14, 2024 and for the year ended June 30, 2024 and TIAA, FSB, a federal saving association, held as a directed trustee or custodian that were record kept by TIAA prior to July 14, 2024 and for the year ended June 30, 2023. The certification is provided by the custodians, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Fixed Annuity Contracts:* Following guidance provided by TIAA and CREF, management has determined that contract value approximates fair value for its fixed annuity contracts that are not fully benefit-responsive. Contract value represents the accumulation of contributions made under the contract, plus guaranteed and additional interest, less funds used to pay benefits and administrative expenses of the contract.

The conclusion that contract value approximates fair value for the TIAA Traditional Annuity is supported by two approaches, 1) the theoretical transfer of assets owned by a pension plan, and 2) a quantitative model based on assumptions of future interest rates and related discounted cash flows.

Differences in the credit spreads from corporate bonds are assumed to represent the overall illiquidity of the TIAA Traditional Annuity and those associated U.S. Treasury yields represent a credit spread for a highly rated insurance company. Thus, the interest rate used to discount future cash flows under a TIAA Traditional Annuity contract would approximate the contract's crediting rate and the present value would, therefore, approximate current contract value.

Because participants transact at contract value, the fair value approaches and assumptions related to the TIAA Traditional Annuity are only reviewed annually for financial reporting purposes.

*Mutual Funds:* Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

*Variable Annuities:* Variable annuities are valued at the unit value as reported by the account. The unit values are listed on the National Association of Securities Dealers Automated Quotations (NASDAQ) website and updated overnight for each day that the NASDAQ is open.

*Pooled Separate Accounts:* Pooled separate accounts are valued at the unit value as reported by the account. The unit values are listed on the NASDAQ website and updated overnight for each day that the NASDAQ is open.

There have been no changes in the methodologies used at June 30, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 FIXED ANNUITY CONTRACTS**

The TIAA Traditional Annuity consists of guaranteed fixed annuity contracts that, during the accumulation phase, provide a guarantee of principal, a guaranteed minimum interest rate and the potential for additional discretionary interest if declared by TIAA. Additionally, the discretionary rate applied to contributions received during a reporting period may differ from the discretionary rate applied to account balances at the end of the prior reporting period. Such contracts may be converted to an annuity based on the accumulation in the account. Participants who elect to direct their contributions to this account enter into individual contracts with TIAA that provide various options.

As a result, the TIAA Traditional Annuity consists of certain individual participant contracts that are considered to be fully benefit-responsive and others that are not considered to be fully benefit-responsive because provisions in the contract contain liquidity restrictions that can limit the participant's ability to make withdrawals from the contract. The portion of the TIAA Traditional Annuity that is fully benefit responsive is presented on the face of the statements of net assets available for benefits at contract value. The portion of the TIAA Traditional Annuity that is not considered to be fully benefit-responsive is presented on the face of the statements of net assets available for benefits at fair value, which management has determined to approximate contract value.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1% - 3%. Such interest rates are reviewed on an annual basis for resetting.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF are the insurance entities that hold certain investments in the Plan, and TIAA is also the recordkeeper as agent for TIAA, FSB, the custodian of other investments in the Plan. Therefore, these transactions qualify as party-in-interest transactions. Indirect fees of \$177,405 incurred by the Plan for TIAA and CREF investment management and other administrative services for the year ended June 30, 2024 are included in the net appreciation in fair value of investments. The Plan Sponsor pays directly any other fees related to the Plan's operations. Notes receivable from participants are also party-in-interest transactions.

**NOTE 7 INCOME TAX STATUS**

The Plan has adopted a preapproved plan that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
