Notes to Financial Statements

1. Description of Plan

General

The following description of the Glidefast Consulting LLC 401(k) Profit Sharing Plan & Trust (the Plan) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan, which became effective on April 1, 2021, is a restatement of an existing Plan which originally started on January 1, 2016 and is a defined contribution plan under Internal Revenue Code (IRC) Section 401(k). The Plan is available to all employees of Glidefast Consulting LLC (the Company) who have met the eligibility requirements stipulated by the Plan.

The Plan is administered by the management of the Company, the Plan Administrator, and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

On February 10, 2022, Pharicode LLC merged with the Company. On this date, all plan assets and participant loans were transferred to the Plan.

Effective July 5, 2022 the Company merged with Apex Systems, LLC, a subsidiary company of ASGN Incorporated and on this date the Plan participants became fully vested in their balances and were active in the named Apex Systems, LLC 401(k) Plan. On this date there were no further contributions to the Glidefast Consulting LLC 401(k) Profit Sharing Plan & Trust. Apex Systems, LLC terminated the Plan and transferred all assets to the Apex Systems, LLC 401(k) Plan in 2024.

Eligibility

In accordance with the provisions of the Plan, all full-time employees of the Company who were age 21 or older became eligible immediately to participate in the Plan and completed three months of service during a 12-month period beginning on the employee's date of hire.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan within 30 days of eligibility. Automatically enrolled participants had their deferral rate set at 1% of eligible compensation.

Effective July 5, 2022, when the Company merged with Apex Systems, LLC, no new employees are eligible to enroll in the Plan.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Contributions

Participant contributions were subject to limitations imposed by the Internal Revenue Code (IRC), which were \$23,000 for the period from January 1, 2024 to closing date of April 30, 2024 and \$22,500 for year ended December 31, 2023 (plus \$7,500 for eligible catch-up contributions made by participants of the age of 50 and older). Participants also had the option to designate any portion of their contributions as Roth contributions, which are taxable to the participant at the time of deferral.

The Company had matched 100% up to the first 4% of base compensation, as defined in the Plan. Participants directed the investment of participant and employer contributions into various investment options offered by the Plan.

Effective July 5, 2022, when the Company merged with Apex Systems, LLC, participants were no longer able to contribute to the Plan.

Participant Accounts

Each participant's account was credited with the participant's elective deferrals (pre-tax and/or Roth segregated), rollover contributions, employer matching contributions, and Plan earnings (losses). Participant accounts may also have been charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant directed transactions, as defined. The benefit to which a participant is entitled was the benefit that can be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options available under the Plan. All of the assets of the Plan are held by Voya Financial, the Plan's Trustee.

Vesting

Participants were immediately vested in their salary deferrals, including Roth 401(k) deferrals and catch-up contributions, and rollovers, plus actual earnings thereon. Participants were 100% vested in their employer match contributions after one year of credited service and 1,000 hours worked. Effective July 5, 2022 plan participants became fully vested in their balances and were active in the Apex Systems, LLC 401(k) Plan.

1. Description of Plan (continued)

Notes Receivable from Participants

Notes receivable from participants represented participant loans that were recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowances for credit losses have been recorded as of and for the period from January 1, 2024 to April 30, 2024 and year ended December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Participants were able to borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and a minimum of \$500, and may only have one loan outstanding at a time. Loans must be repaid over a period of no more than 5 years except in the case of a loan used to acquire a principal residence, in which case the Plan Administrator may permit a longer repayment term, up to 30 years. Payments of principal and interest are made through payroll deductions over the loan period. A loan is secured by the vested balance in the participant's account. The interest rate on participant loans outstanding as of December 31, 2023 ranged from 5.25% to 6.75%. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan documents. Related fees are recorded as administrative expenses and are expenses when they are incurred.

Effective July 5, 2022, when the Company merged with Apex Systems, LLC, participants were no longer able to take out new loans within the Plan. All loans issued prior to July 5, 2022, balances were continually being paid through December 31, 2023 and transferred out during 2024.

Payment of Benefits

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the vested value of their account or through installments over a certain period at the participant's election not to exceed the joint life expectancy of the participant and their beneficiary. Active participants may also withdraw funds from their accounts under certain hardship conditions.

Administrative Expenses

Substantially all expenses, with the exception of fees related to notes receivable from participants and distributions, incurred in connection with the administration of the Plan, are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Plan Termination

As a result of a Company merger in July 2022 with Apex Systems, LLC all Plan assets have been transferred into the Apex Systems, LLC 401(k) Plan in 2024, terminating the Plan.

2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year, which is presented in the statement of changes in net assets available for benefits.

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

3. Information Prepared and Certified by Trustee

The Plan's investments are held and administered by the Trustee, Voya Financial, as of and for the period from January 1, 2024 to closing date of April 30, 2024 and year ended December 31, 2023. All investment information disclosed in the accompanying financial statements, including investments held at the period from January 1, 2024 to closing date of April 30, 2024 and year ended December 31, 2023 and notes receivable from participants held at the period from January 1, 2024 to April 30, 2024 and year ended December 31, 2023, and interest income, dividends and net appreciation in fair value of investments for the period from January 1, 2024 to April 30, 2024 and year ended December 31, 2023, was obtained and certified as complete and accurate by Voya Financial.

4. Fair Value Measurements

The Plan uses a framework that provides for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include; quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value; there have been no changes in the methodologies used at December 31, 2023. Mutual funds and money market funds are valued at the value of such shares as of the close of business at the end of the year based on quoted active market prices of the underlying investments, and as such, are classified as Level 1 investments. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different

5. Party-in-Interest and Related Party Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are shares of mutual funds which are managed by The Retirement Advantage Group, the Recordkeeper as defined by the Plan, and Voya Financial, the Trustee as defined by Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

6. Income Tax Status

The Plan adopted a Defined Contributions Basic Plan Document. In accordance with Revenue Procedure 2005-16, the Company has chosen to rely on the advisory opinion letter dated June 30, 2020. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to opinion letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021 to maintain its qualification. The Plan has been amended since receiving the advisory.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

The Plan has evaluated events occurring through December 5, 2024, the date the financial statements were available to be issued.
