I am filing for 5500SF at your request, this was a one-person plan that was terminated and the funds were rolled over to my qualified plan. I was the only employee and I was the employer.

The problem is this entity was set up in correctly and never got launched properly, I operated the business in 2020 but was forced to file as a sole proprietor due to errors with setting up the entity. The entity was supposed to be dissolved so I am confused as to why this is happening. I used Paychex, they administered the plan and the plan was terminated 2/21.
