## INDEPENDENT AUDITOR'S REPORT

To the Participants and Those Charged with Governance  
The New School 403(b) Defined Contribution Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The New School 403(b) Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended July 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of July 31, 2024 and 2023, and for the year ended July 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## NOTES TO FINANCIAL STATEMENTS

July 31, 2024 and 2023

### Note 1 – Description of the Plan

The New School (the School or Employer) sponsors The New School 403(b) Defined Contribution Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established for the benefit of the School's employees, except employees who normally work less than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan administrator is responsible for the oversight of the Plan. The Plan's investments are managed by Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF). TIAA and CREF issue the investments. TIAA is an insurance company, and CREF is a registered investment company, as well as an insurance company. TIAA processes and maintains the records of the participant data.

#### School operations and management plans

The School has suffered recurring losses from operations that has raised a substantial doubt about the School's ability to continue as a going concern for the year following the issuance of these financial statements. Management has implemented plans intended to mitigate the conditions. However, due to the uncertainty of continuation of operating losses, management cannot predict, with certainty, the outcome of their actions to improve operations.

#### Eligibility

Nonexcluded employees are eligible to participate in the Plan upon the first day of employment with the School.

#### Contributions

Participants may contribute up to 100% of their compensation, as defined in the Plan document, as pretax deferrals. Participants who have completed at least 15 years of service or have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan also provides for Employer matching contributions for participants who complete 1,000 hours of service in the Plan year. For the year ended July 31, 2024, the Employer matching contributions were 100% of participant deferrals up to 3% of a participant's compensation.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations of the Internal Revenue Code (the Code).

### Participant accounts

Each participant's account is credited with participant contributions, Employer contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in Employer contributions and their own contributions plus any earnings thereon.

### Notes receivable from participants

Participants generally may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the participant's highest outstanding balance of all loans on any day during the 12-month period ending on the day before the loan is made over the outstanding balance of loans on the date the loan is made, or 50% of their vested account balance. Loans taken from the TIAA Traditional Annuity have additional limitations. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which is based on prime rate plus 1% on the date of origination. Participants may have three loans outstanding at any given time. Terms range from one to five years or up to ten years for the purchase of a primary residence. Principal and interest are paid ratably by the participants directly to TIAA.

### Payment of benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive benefits in any of the forms of benefit available from the relevant funding vehicle. Forms of benefit available under the Plan, but not necessarily from all funding vehicles, include a lump-sum amount, a partial payment, installment payments over a period not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and their designated beneficiary, or applied to the purchase of an annuity contract or converted to an income option. Participants who have invested in the TIAA Traditional Annuity are limited in their ability to elect a lump-sum distribution depending upon the year in which contributions were made; however, they may receive the value of their accumulated benefits over a ten-year period. Additionally, participants may take in-service distributions upon reaching age 59½. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

### Forfeitures

Forfeitures are first used to pay Plan administrative expenses, then to reduce Employer contributions. For the year ended July 31, 2024, there were no forfeitures utilized, and the Plan had no unallocated forfeitures as of July 31, 2024 and 2023.

### Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup. The Plan participates in an agreement with the TIAA, where excess revenue may be returned and deposited into an unallocated fee leveling credit account. The amounts in the unallocated fee leveling credit account may be used to pay reasonable and necessary Plan expenses or may be allocated to participants. For the year ended July 31, 2024, there were no credits utilized, and the Plan had no unallocated funds in the fee leveling credit account as of July 31, 2024 and 2023.

## **Note 2 – Summary of Significant Accounting Policies**

### Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by TIAA and CREF. See Note 4 for discussion of fair value measurements and Note 5 for contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for delinquent notes receivable from participants has been recorded as of July 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

### Contributions

Participant contributions, and the related Employer matching contributions, are recorded in the year in which the participant deferrals are withheld from compensation.

### Payment of benefits

Benefit payments are recorded when paid. There were no benefits requested before year-end that were not paid.

### Subsequent events

The Plan administrator has evaluated subsequent events through February 4, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, long-term part-time employees who worked 500 hours of service in the previous two consecutive years are eligible to participate in the Plan.

### Note 3 – Information Certified by TIAA and CREF

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF have certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of July 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended July 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of July 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

### Note 4 – Fair Value Measurements and Quantitative Information about Significant Unobservable Inputs Used in Level 3 Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of July 31, 2024 and 2023. During the year ended July 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

*Fixed annuity contracts - nonfully benefit responsive* – The TIAA Traditional Annuity is reported at contract value and segregated between nonfully benefit responsive and fully benefit responsive contracts based on the terms of the individual contracts. The participant owns the nonfully benefit responsive TIAA Traditional Annuity through the Retirement Choice (RC) Annuity contract. This

account is valued at contract value, which equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Contract value approximates fair value.

The School has selected TIAA as a vendor to provide funding vehicles under the Plan and has selected the TIAA Traditional Annuity as an investment account to be offered under the TIAA funding vehicles. TIAA has provided information to Plan management regarding TIAA's assumptions and analysis on which TIAA has based the valuation of the TIAA Traditional Annuity. This information includes but is not limited to a) TIAA's analysis of how, in the absence of a principal market, participant investment allocation decisions support the conclusion that contract value approximates fair value; and b) TIAA's application of a discounted cash flows model to conclude that the present value of future accumulations would reasonably approximate current contract values. Plan management has utilized and relied on the information provided by TIAA to determine the Plan's valuation policy for the TIAA Traditional Annuity.

*Variable annuities in mutual funds* – Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end. These funds have no unfunded commitments, no defined remaining life, offer daily liquidity (pending market conditions) and are not subject to any redemption restrictions at the measurement date, except as described below. Trades within these funds generally settle daily with no required redemption notice period. A full redemption of the fund could be temporarily delayed based on ordinary market conditions.

With the exception of the CREF Money Market Account, variable annuities in mutual funds are subject to certain restrictions. The units in the TIAA variable annuity funds are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange is open for business. In an effort to reduce market timing and excessive trading, shareholders will be locked out of an account for 90 days if a purchase, sale and repurchase within that account is made within a 60-day period.

*Variable annuity in pooled separate account* – Valued at quoted market prices, which represent the NAV of units held by the Plan at year-end, based on the underlying real estate holdings which are valued principally using external appraisals. Unit value is calculated daily. Transfers and distributions are allowed once per calendar quarter unless set up as part of a systematic distribution or transfer. There were no unfunded commitments as of July 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Note 5 – Fully Benefit Responsive Investment Contracts with TIAA

The Plan holds traditional guaranteed investment contracts issued by TIAA. These contracts meet the fully benefit responsive investment contract criteria, and therefore, are reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. TIAA maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value represents contributions under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The participant owns the TIAA Traditional Annuity through either the Supplemental Retirement Annuities (SRA) or the Retirement Choice Plus (RCP) contracts. The type of contract held determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional amounts paid, the degree of liquidity of the participant's account and the options for receiving income upon retirement. The guaranteed annual interest rate is 3% for all premiums remitted since 1979 under SRA contracts. For the RCP contracts, the guaranteed rate is between 1% and 3%. Plan withdrawals from the RCP are allowed over a 60-month period with a 30-day advance notice. The crediting interest rate is calculated on a daily basis. The crediting rates are declared annually and are in effect from March 1 of the year until the end of February the following year. New contributions have a crediting rate set monthly and are in effect until the end of February the following year.

The Plan's ability to receive amounts due in accordance with the fully benefit responsive contracts is dependent on TIAA's ability to meet its financial obligations. TIAA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with TIAA. These events may be different under each contract. Examples of such events include, but are not limited to the following:

1. The Plan's failure to qualify under Section 401(a) of the Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example divestures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow TIAA to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Examples of such events include:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that also would limit the ability of the Plan to transact at contract value with the participants.

### **Note 6 – Related Party and Party-in-Interest Transactions**

Certain administrative functions are performed by officers and employees of the School. No officer or employee receives compensation from the Plan for these services. Certain administrative expenses, totaling \$19,000, were paid by the School on behalf of the Plan for the year ended July 31, 2024. The School does not expect reimbursement from the Plan for these expenses.

Certain investments are managed by TIAA and CREF. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 8 – Tax Status**

The School adopted a Volume Submitter 403(b) Plan (the VSPP Plan) sponsored by TIAA. The Internal Revenue Service has determined and informed the VSPP Plan sponsor by a favorable opinion letter dated August 7, 2017, that the VSPP Plan is designed in accordance with the applicable sections of the Code. The VSPP Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. The Plan administrator has indicated that it will take the necessary steps, if any, to maintain the Plan's compliance with the Code.

### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

TIAA and CREF issue various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of the contract accumulations, which could impact the value realized upon exiting the contract.
