Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Spencer Technologies, Inc. 401(k) and Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Spencer Technologies, Inc. 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Spencer Technologies, Inc. 401(k) and Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and profit sharing plan covering substantially all employees of Spencer Technologies, Inc. (the "Company"), who elect to contribute to the Plan and meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During 2023, the Employer entered into an agreement to change vendors from Empower Trust Company, LLC to Reliance Trust Company effective January 1, 2024. On December 29, 2023 the assets of the Plan excluding the group annuity contract (Key Guaranteed Portfolio Fund) were transferred from Empower Trust Company, LLC to Reliance Trust Company. These funds were received by Reliance Trust Company on January 2, 2024. The Plan initiated the put period and terminated the contract on the group annuity contract on October 30, 2023. The contract termination is irrevocable. The assets will be transferred to Reliance Trust Company on October 30, 2024.

Eligibility

Eligible employees who are 21 years of age or older are eligible to participate and are automatically entered into the Plan, through automatic enrollment (unless the employee elects to opt out of the Plan), once they have reached 60 days of employment at the Company.

Contributions

Participants may elect to contribute a percentage of their annual pre-tax compensation to the Plan, subject to certain limitations as allowable under Section 401(k) of the Internal Revenue Code ("IRC"). These contributions and earnings thereon, are not subject to federal income taxes until withdrawn from the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans. The Plan provides for discretionary profit sharing contributions from the Company. All contributions to a participant's account are allocated among the various investments based on each participant's elections.

Participants may also elect to contribute after-tax contributions (Roth). These contributions are subject to eligibility requirements and to the same IRC contribution limitations as employee pre-tax deferrals.

The Company may make discretionary matching contributions and discretionary profit sharing contributions. The Company elected to make a discretionary profit sharing contribution of \$100,000 for the year ended December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, if any, and allocations of Plan earnings (and losses) thereon. Each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings (and losses) or account balances, as defined.

Vesting

Participants are immediately vested in their pre-tax and Roth contributions and any amounts rolled over or transferred into the Plan. Vesting for employer contributions, if any and associated earnings is based on a graded schedule based on years of service. A participant's account attributable to employer discretionary matching and discretionary profit sharing contributions become 100% vested after five or more years of credited service as defined. A year of service requires a minimum of 1,000 hours worked during the Plan year. Participants also become fully vested upon death, disability (as defined) or attainment of normal retirement age.

Notes Receivable from Participants

A participant may elect to take out a loan subject to the rules and limitations of the Plan. A participant may have up to two loans outstanding at any given time. Principal and interest payments on an outstanding loan are paid in level payments through weekly payroll deductions. A default in a participant's loan is treated as a distribution at the time of default against the participant's account.

The Plan's loan policy allows for a participant (borrower) enrolled in the Plan to borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Each loan shall bear interest at the prime rate in effect at the time of its issuance plus 1%. The loan must be repaid within a five year period, unless such loan is used to acquire a principal residence of the borrower.

Payment of Benefits

Upon retirement from service, total and permanent disability, termination of employment or death, a participant will receive the value of their vested account balance in a lump sum distribution, in accordance with the provisions of the Plan. If the value of the distribution exceeds \$5,000, the participant may elect to defer such lump-sum payment until April 1st of the calendar year following the year the participant attains age 70 ½ if they reach 70 ½ before January 1, 2022 and age 72 for eligible employees who reach the age of 72 after January 1, 2022. In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. At any time, a participant may also elect to receive all or a portion of his or her rollover contributions.

Plan Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other expenses are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Forfeitures

Any balance in the employer contribution account of a participant who has separated from service, to which he or she is not entitled, shall be used to reduce employer contributions or pay Plan expenses. At December 31, 2023 and 2022, forfeited nonvested accounts remaining totaled \$76,415 and \$15,139. During the plan year ended December 31, 2023, \$1,000 was used from the forfeiture account to pay Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets.

Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2022, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs. There were no investments valued at fair value held by the Plan as of December 31, 2023.

2. Summary of Significant Accounting Policies *(continued)*

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the Key Guaranteed Portfolio Fund, which is stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. The funds are deemed to be actively traded. The Key Guaranteed Portfolio Fund is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is January 8, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, qualified institutions.

4. Group Annuity Contract

The Key Guaranteed Portfolio Fund (the “Fund”) is a general account product offered through a group annuity contract and is fully benefit-responsive. Participant principal and interest are fully guaranteed by the entire general account assets of Empower Annuity Insurance Company, the issuer of the Fund. The investment strategy employed for this product seeks to achieve consistent returns to support a competitive credited rate. Bonds invested in the general account segment have an average maturity between three and seven years; are investment grade in quality and are diversified across a range of fixed-income asset classes such as asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgage and private equity. Each quarter an interest rate is established for all money, regardless of when it was deposited. The credited interest rate may stay the same or change each quarter.

Participants may transfer their account balances to any other investment option offered under the Plan with no restrictions or penalties.

The Fund has liquidity restrictions and requires 12 months’ notice to liquidate the fund (the “put period”). The Plan requested to begin the put period and terminate the contract on October 30, 2023.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A+), Moody’s (Aa3), Standard and Poor’s (AA) and Fitch (AA).

5. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect the value of the Plan’s net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2023 are not reflected in these financial statements and future effects on the Plan’s net assets available for benefits cannot be predicted.

6. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype plan document preparer by a letter dated May 21, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

6. Tax Status (*continued*)

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan's investment in certain mutual funds are managed by Empower Trust Company, LLC. Additionally, the group annuity contract is held by Empower Annuity Insurance Company. These transactions qualify as exempt party-in-interest transactions. Participant loans also qualify as exempt party-in-interest transactions. Additionally, certain investment offerings of the Plan pay a quarterly revenue credit to participants holding such investments, with such credit reported as other additions in the accompanying statement of changes in net assets available for benefits.

8. Prohibited Transactions

During 2022 the Company failed to transmit to the Plan certain participants' contributions and loan repayments totaling \$198,701 within the period prescribed by Department of Labor regulations. Of the contributions and loan repayments, \$1,859 related to the 2017 plan year, \$43 related to the 2018 plan year, \$195 related to the 2019 plan year, \$120,403 related to the 2020 plan year, \$41,407 related to the 2021 plan year, and \$34,794 related to the 2022 plan year. Delays in remitting these amounts to the Plan were due to an administrative oversight. The Company made the necessary corrections in 2023 to satisfy both the Department of Labor and IRS guidance for this matter and is in the process of implementing procedures to reduce the time needed to transmit participants' contributions and loan repayments to the Plan.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, effected participants will become 100% vested in their accounts.
