Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter - supplemental schedule required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the AeroTech Corporation Airport Services Savings and Investment Plan (f/k/a John Bean Technologies Corporation Airport Services Division Savings and investment Plan) (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a qualified salary-reduction plan under Section 401(k) of the Internal Revenue Code (the "IRC"), which covers certain employees of the Airport Services business unit of JBT AeroTech Corporation (the "Company" or "Employer" or "Plan sponsor") as well as prevailing wage employees of the Company and employees of LEKTRO, a subsidiary of the Company. Such employees are eligible to participate in the Plan upon completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is administered by the Oshkosh Corporation Investment Review Committee (the "Investment Review Committee"), acting on behalf of the Plan sponsor. The Plan's trustee is Fidelity Management Trust Company (the "Trustee").

Effective January 1, 2023, the Plan was restated to incorporate all the previously effective plan amendments.

On August 1, 2023, through a stock and asset purchase agreement, John Bean Technologies Corporation sold JBT AeroTech Corporation to Oshkosh Corporation. Effective July 31, 2023, the name of the Plan was revised from "John Bean Technologies Corporation Airport Services Division Savings and Investment Plan" to "AeroTech Corporation Airport Services Savings and Investment Plan" and sponsorship of the Plan is transferred from "John Bean Technologies Corporation" to "JBT AeroTech Corporation".

Effective February 1, 2024, the Plan was merged into the Oshkosh Corporation and Affiliates Tax Deferred Investment Plan. Participant balances in the amount of \$16,281,847 were transferred to the Oshkosh Corporation and Affiliates Tax Deferred Investment Plan as part of the merger.

Contributions

Participants may make elective deferrals of their annual compensation up to the IRC annual limit. The aggregate amount of such elective deferrals is contributed to a trust on a pre-tax or Roth basis. Participants may also elect to make after-tax contributions, either as an alternative to pre-tax or Roth contributions, or in addition to the maximum elective deferrals. The aggregate of pre-tax, Roth and after-tax contributions cannot exceed 75% of a participant's total compensation (20% for highly compensated employees). Active employees who meet the following requirements are eligible to make catch-up contributions to the prescribed limit: (1) attain age 50 or older during the year; (2) already contributing at least 5% to the Plan on a pre-tax or Roth basis; and (3) will reach the elective deferral limit for the year. Participants may also make rollover contributions to the Plan.

The Company makes matching contributions for all active participants, except for certain prevailing wage employees. The Company matches 50% of basic contributions of each participant's eligible compensation up to 5% of eligible compensation ("Matching Contribution"). The Company contributes a non-elective contribution ("Non-elective Contribution") to participants who are prevailing wage employees, in accordance with the prevailing wage contribution formula set forth in the applicable prevailing wage contract.

Investment Options

Upon enrollment in the Plan, a participant may direct his or her contributions, plus actual earnings thereon, to be invested in any of the investment options offered by the Plan. Company Matching Contributions to the Plan are allocated to the investment options selected by the participants.

Vesting

Participants are immediately vested in their elective contributions and the Company's Non-elective Contribution plus actual earnings thereon. Vesting in the Company's Matching Contribution and related earnings is determined according to the following graduated schedule based on years of service.

<u>Years of Service</u>	<u>Percent Vested</u>
Fewer than 2	0%
At least 2 but fewer than 3	20
At least 3 but fewer than 4	40
At least 4 but fewer than 5	60
5 or more	100

Participants are immediately vested in the Company's Matching Contribution upon separation from service due to disability, dying while employed by the Company, attainment of age 65 while employed by the Company, or if the Benefits Plan Committee in its discretion fully vests participants in connection with a transaction.

Benefit Payments

Upon termination of service, death, disability or attainment of age 59½, any participant may elect to immediately receive a lump-sum distribution equal to the vested interest of his or her account. Participants may, upon termination, elect to defer their lump-sum distribution or receive annual installments. Any unvested interests are forfeited. Forfeitures are used to restore forfeitures of participants that are rehired within five years, pay for certain administrative expenses of the Plan and reduce future Company contributions to the Plan.

Forfeitures

Forfeited nonvested accounts are used to reduce administrative expenses or future Company contributions. Forfeited nonvested accounts as of February 1, 2024, December 31, 2023 and 2022, totaled \$0, \$8,029 and \$6,464, respectively. There were no forfeitures used to reduce Company contributions for the period from January 1, 2024 through February 1, 2024, nor for the year ended December 31, 2023. There were no forfeitures used to reduce administrative expenses for the period from January 1, 2024 through February 1, 2024, and there were \$10,898 forfeitures used to reduce administrative expenses for the year ended December 31, 2023.

Expenses

Certain administrative expenses of the Plan are paid by the Plan and constitute a charge upon the respective investment funds or upon the individual participants' accounts. Certain other Plan expenses can be paid by the Plan from the forfeitures balance, or by the Company.

Hardship Withdrawals

The Plan allows participants to make hardship cash withdrawals (subject to income taxation and Internal Revenue Service ("IRS") penalties) of some or all of their eligible vested account balances.

Notes Receivable from Participants

Eligible participants may also borrow money from their Plan account in the form of loans. The minimum that may be borrowed is \$1,000. The maximum that may be borrowed is the lesser of \$50,000, or 50% of the participant's vested account balance. Loans, which are secured by the participant's vested account

balance, must be repaid over not more than 60 months with interest at the prime interest rate at the inception of the loan. A participant may have up to two loans outstanding at any one time. Principal and interest are paid ratably through payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan and ERISA. In the event of Plan termination, participants will become 100% vested in their account balances. Effective February 1, 2024, the Plan was merged into the Oshkosh Corporation and Affiliates Tax Deferred Investment Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's Matching and Non-elective Contributions, and an allocation of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations of plan earnings (losses) are based on the participant's account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value as of December 31, 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's interest in the Master Trust as of December 31, 2022 has been determined and reported based on the specific interest that it has in the underlying participant-directed investments of the Master Trust as of December 31, 2022. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized and unrealized gains and losses incurred during the period from January 1, 2024 through February 1, 2024 and the period from August 1, 2023 through December 31, 2023. Net realized and unrealized appreciation (depreciation), along with dividend income and interest income for the period January 1, 2023 through July 31, 2023 and for the year ended December 31, 2022 are recorded in the accompanying statements of changes in net assets available for benefits as Change in Plan's interest in Master Trust.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits

Benefit distributions to participants are recorded when paid.

NOTE C - PARTY-IN-INTEREST TRANSACTIONS

The Plan paid fees to the Trustee for trustee and investment services. In addition, certain Plan and Master Trust investments are shares of funds managed by the Trustee.

The Company pays certain administrative costs of the Plan and provides certain administrative services to the Plan at a charge.

Notes receivable from participants also constitute exempt party-in-interest transactions.

The Trustee provides certain administrative services to the Plan pursuant to a trust agreement between the Company and the Trustee. The Trustee receives revenue from mutual fund and collective fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan. If the revenue received by the Trustee from such fund service providers exceeds the amount owed under the trust agreement, the Trustee remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Company may make a payment to the Trustee for administrative expenses not covered by revenue sharing.

NOTE D - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of February 1, 2024 and December 31, 2023.
- Plan's interest in Master Trust, at fair value and notes receivable from participants, as shown in the statement of net assets available for benefits as of December 31, 2022.
- Change in Plan's interest in Master Trust, as shown in the statement of changes in net assets available for benefits for the for the period from January 1, 2023 through July 31, 2023.
- Investment income, interest and dividend income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the periods from January 1, 2024 through February 1, 2024 and for the period from August 1, 2023 through December 31, 2023.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2023.

NOTE E - INTEREST IN MASTER TRUST

The Master Trust was established for the investment of assets of the Plan and another Company affiliated retirement plans. The assets of the Master Trust are held by the trustee. Use of the Master Trust permits the commingling of assets for the participating plans. Although the assets are commingled in the Master Trust, the Trustee maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating plans. Investment (loss) income and investment expenses relating to the Master Trust are allocated to the individual plans based upon the balances of participant accounts in each plan.

The following table presents the net assets of the Master Trust and the Plan's interest in the Master Trust's net assets as of December 31, 2022:

NOTE F - FAIR VALUE MEASUREMENTS

The fair value framework requires the categorization of assets and liabilities into three levels based upon the assumptions (inputs) used to price the assets or liabilities. Level 1 provides the most reliable measure of fair value; whereas Level 3 generally requires significant management judgment. The three levels are defined as follows:

Level 1 - Unadjusted quoted prices in active markets for identical assets and liabilities.

Level 2 - Observable inputs other than those included in Level 1. For example, quoted prices for similar assets or liabilities in active markets or quoted prices for identical assets or liabilities in inactive markets.

Level 3 - Unobservable inputs reflecting management's own assumptions about the inputs used in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2023 and the investments held within the Master Trust as of December 31, 2022. There have been no changes in the methodologies used on December 31, 2023 and 2022.

Money Market fund and Mutual funds - Valued at the quoted net asset value (“NAV”) of shares held by the Plan at year end traded on an active market.

Collective trust funds - An investment formed from the pooling of investments by institutional investors. The Plan’s interest in the collective trusts is valued by the trustee based on the NAV of shares held by the Plan at year end as practical expedient fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments of the collective trust funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G - TAX STATUS

The Plan received a determination letter from the IRS on November 18, 2013, as to the qualified status of the Plan under Section 401(a) of the IRC. The Company believes that the Plan is currently being operated in compliance with the IRC and, therefore, is qualified, and the related trust is exempt from federal income taxes under Section 501(a) of the IRC. Accordingly, income taxes are not provided for in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of February 1, 2024 and December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE I - SUBSEQUENT EVENTS

The Plan administrator has evaluated subsequent events through February 7, 2025, the date the financial statements were available to be issued. There were no subsequent events that require recognition or additional disclosure in these financial statements.
