To Whom It May Concern:

Today I filed Form 5500 SF for years ending 2021 and 2022. I realize this is quite late for filing these years and I wish to explain why this is the case.


PayChex was the company which handled the 401K for our small business. They always completed and filed the 5500 SF forms for us. I never had anything to do with them. When the business was sold on March 1, 2021, I had no knowledge of the requirements to file a final form. PayChex never gave me any indication that the responsibility was now mine.

When the IRS contacted me in late 2024, they sought the 5500 SF form for 2022. I wrote them that I no longer owned the business in 2022 and told them to contact the new owner. When they responded a month or so later, and I showed their letter to my CPA, it was finally made clear to me what they wanted. I then contacted PayChex to see what had happened to that form. They told me that once we were out of business, they no longer filed forms for us. However, they had prepared the forms and were happy to forward them to me. They also explained that they had done one for 2022 even though the business had been closed the prior year as not all the participants in the plan had withdrawn their money until 2022.

As a very small business owner who did the books myself, I was not knowledgeable in the requirements of the 401K plan, and I depended on PayChex to take care of everything having to do with it. I am very sorry that I had no way of knowing that I was supposed to follow through with the final 5500 filings. I am now 78 years old and have been retired since 2021.

I hope this explanation will help you understand that this tardiness was not due to neglect or deliberate procrastination, but merely due to my ignorance. I was never late filing my business taxes and hope you understand my situation.
