Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the of the accompanying financial statements of Produce Source Partners, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of April 30, 2024 and December 31, 2023 (in liquidation), and the related statements of changes in net assets available for benefits for the period from January 1, 2024 to April 30, 2024 and the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of April 30, 2024 and December 31, 2023, and for the periods then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the Trustees and Plan administrator approved a resolution to terminate the Plan effective November 30, 2023. As a result, the Plan has used the liquidation basis in presenting the financial statements for the period January 1, 2024 to April 30, 2024 and the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Notes to Financial Statements

1. Description of Plan:

The following description of the Produce Source Partners, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement or summary plan description for a more complete description of the Plan's provisions.

During 2023, Produce Source Partners, Inc. and its subsidiaries ("the Company") entered into an agreement to sell certain of its assets, which resulted in the majority of the Company's employees, and the Plan's participants, being terminated from the Plan. This resulted in a partial plan termination during 2023. Affected participants became fully vested in accrued benefits at their termination date. Upon the close of the transaction, the Plan Sponsor terminated its operations.

On September 15, 2023 the Trustees and Plan administrator approved a resolution to terminate the Plan effective November 30, 2023. The Plan termination resulted in distributions to participants. All remaining assets of the Plan were distributed by April 30, 2024. Therefore, the basis of accounting used in presenting the financial statements for the Plan changed from the ongoing basis to the liquidation basis beginning in the year ended December 31, 2023.

General: The Plan was a defined contribution plan covering all eligible employees of the Company who completed three months of service and attained the age of 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: The Plan provided for participant contributions ranging from 1% to 25% of pre-tax annual compensation, as defined in the Plan. The Company contributed as its matching contribution an amount equal to 25% of each participant's 401(k) contribution up to 4% of compensation. Participants who would be 50 years of age by the end of the Plan year could make additional "catch-up" contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company could contribute additional amounts at the option of the Board of Directors. Contributions were subject to certain limitations.

Participant Accounts: Each participant's account was credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and (c) charged with an allocation of administrative expenses. Allocations were based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Investment Options: Participants could direct ADP Retirement Services ("ADP"), the third-party administrator of the Plan, as to the investment of their account balances. Participants could change their investment elections at any time.

1. Description of Plan, Continued:

Vesting: Participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions was based on years of continuous service. Participants were fully vested in Company contributions after attaining six years of credited service.

The Plan was considered a partial plan termination during 2023. Thus, participants affected by the partial plan termination were immediately 100% vested in the Company's discretionary contributions, plus actual earnings thereon. Participants became 100% vested in the Company's contributions once management approved a resolution to terminate the plan.

Plan Administration: Overall responsibility for administering the Plan rests with the Company. Participant accounts were administered by ADP. First Landing Financial served as the investment advisor. Reliance Trust Company was the trustee of the Plan's assets.

Notes Receivable from Participants: Participants could borrow from their Plan accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms could not exceed five years, unless the proceeds were used to acquire a principal residence. The loans were secured by the vested balance in the participant's account and bore interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest were paid ratably through payroll deductions. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary.

Payment of Benefits: Distribution of the vested portion of a participant's account occurred upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant was entitled to receive a lump-sum payment in an amount equal to the vested value of his or her account, or the participant could elect to receive the amount in installments as described in the Plan.

Forfeitures: Forfeited balances of terminated participants' non-vested accounts were used to offset future Company contributions. Forfeitures were \$12,289 for the year ended December 31, 2023. As of December 31, 2023, forfeited balances available to offset Company contributions were \$4,298. Company contributions were reduced by \$18,445 from forfeited non-vested accounts in the year ended December 31, 2023.

2. Summary of Significant Accounting Policies:

Basis of Accounting: The accompanying financial statements were prepared using the liquidation basis of accounting. In accordance with the liquidation basis of accounting, the Plan remeasures its assets and other items it expects to sell that it had not previously recognized, liabilities, and the accruals of disposal or other costs or income to reflect the actual or estimated change in carrying value since the previous reporting date.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net (depreciation) appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Payment of Benefits: Benefits were recorded when paid.

Subsequent Events: Management has evaluated subsequent events through February 7, 2025, the date the financial statements were available to be issued, and has determined that there are no other subsequent events to be reported in the accompanying financial statements.

3. Fair Value Measurements:

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trust: Valued at the NAV of shares held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determinable to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Administrative Expenses:

Although not required by the Plan, a portion of the costs of Plan administration were absorbed by the Company. The Plan paid administrative fees in the amount totaling \$5,613 for the period January 1, 2024 to April 30, 2024 and \$46,492 for the year ended December 31, 2023.

5. Related Party Transactions:

The Plan invested in a fund provided through alliances with ADP and First Landing Financial and its affiliates, SSgA Government Money Market Investment Fund, with a value of \$748,572 as of December 31, 2023. This was a related-party transaction. The Plan paid administrative fees to ADP and First Landing (see Note 4). These fees were included in administrative expenses on the accompanying statements of changes in net assets available for benefits.

6. Tax Status:

The Internal Revenue Service has determined, by letter dated October 6, 2020, that the adopted prototype plan was designed in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since the issuance of the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at April 30, 2024 and December 31, 2023. The Plan is not currently under audit by any tax jurisdiction.
