We have performed audits of the financial statements of Trihydro Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Trihydro Corporation 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

Administration

Trihydro Corporation (the "Company") is the sponsor of the Plan. The 401(k) Retirement Plan Committee, as provided in the plan charter, is the plan administrator and has responsibility for the administration of the Plan. Empower Trust Company, LLC functions as the recordkeeper, custodian, and trustee. Creative Planning Retirement Services functions as the investment manager and plan advisor. Investment management fees are paid by the Company. Trustee fees are paid by the Plan in accordance with the plan agreement.

General

The Plan is a defined contribution plan available for all employees of Trihydro Corporation who are age 18 or older, and employees are immediately eligible to participate upon employment, with plan entry occurring the first day of the payroll period coinciding with or following eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship withdrawals and other in-service withdrawals at age 59½ are also allowed by the Plan if certain criteria are met.

Contributions

The Plan provides for employee salary deferral contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to contribute a percentage of their compensation on an after-tax basis. Participants may make contributions to the Plan in the form of a rollover of funds from another qualified plan if certain criteria are met.

The Company may elect discretionary employer matching contributions and discretionary qualified nonelective contributions. For the year ended September 30, 2024, the Company matched 100 percent of employee contributions up to 6 percent of eligible compensation for eligible participants who met the requirements to receive such contributions for the plan year. The Company did not elect to make discretionary employer matching contributions or discretionary qualified nonelective contributions for the year ended September 30, 2024.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the participant's account balance and bear interest at rates that range from 4.16 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Current notes receivable mature at various dates through January 2046. Principal and interest are paid ratably through biweekly payroll deductions. A participant may not have more than one note outstanding at any time.

Party-in-interest Transactions

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions, and any income or loss thereon. Participants are also immediately 100 percent vested in the discretionary employer match contribution portion of their accounts plus actual earnings thereon. Participants are 100 percent vested in the Company's discretionary qualified nonelective contributions made subsequent to March 1, 2022.

Vesting in the Company's discretionary qualified nonelective contributions made prior to March 1, 2022 is based on years of continuous service beginning at 20 percent after one year of service and increasing 20 percent for each year of continuous service thereafter. A participant is 100 percent vested after five years of service with the Company.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Empower Trust Company, LLC (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Note 5 - Fair Value Measurements (Continued)

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques considering the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
