### **Opinion**

We have audited the financial statements of Brown-Daub, Inc. Health Reimbursement Arrangement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits and in plan benefit obligations for the year ended June 30, 2024, and the related notes to the financial statements.

#### **Note 1. Description of the Plan**

The following brief description of the Brown-Daub, Inc. Health Reimbursement Arrangement Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was formed on August 1, 2009. Effective July 1, 2020, the plan entered in to a consortium to provide health benefits covering all eligible employees of a controlled group of companies including: Brown-Daub Auto Sales, Inc. d/b/a Brown-Daub Kia; Brown-Daub Dodge, Inc. d/b/a Brown-Daub Chrysler-Jeep and Brown-Daub Dodge Ram Truck Center; Brown-Daub of Lehigh Valley, Inc. d/b/a Brown-Daub Volvo of Lehigh Valley and Brown-Daub Hyundai; and Brown-Daub Chevrolet of Nazareth, Inc. d/b/a Solt Chevrolet-Oldsmobile, Inc., which are collectively referred to as "the Company." The Plan is designed as an employee welfare benefit plan and subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended and restated on July 1, 2023.

The Plan is a member of Veris Benefit Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish employee welfare benefit plans for their employees. Some expenses of the health plan are paid through the Veris Benefits Consortium, LLC Trust. The employees are required to pay a portion of the cost of the benefits.

Contributions: The Company deposits into the Plan such amounts necessary for timely payment of all claims and reasonable administrative expenses of the Plan. The Plan is contributory with employees paying a flat rate for coverage for themselves and their dependents. The amount per participant varies based on the selection of individual or eligible dependent coverage.

Employees are able to utilize flexible spending accounts. The account allows an employee to contribute up to \$3,200 per year, on a pre-tax basis, for use on qualified medical, dental and vision expenses. Employees are able to use those funds for 14 ½ months (July 1 – September 15) or it is forfeited. Account balances held on deposit at a third-party provider are reported as flexible spending accounts on the statement of net assets available for benefits.

Benefits: The Plan provides health benefits (medical, and prescription drugs). Benefits are provided to eligible employees, retirees, their spouses and eligible dependents. All regular full-time employees who work at least thirty hours per week are eligible to participate in the Plan after 60 days of employment. The waiting period is waived for former employees of the Company that are rehired within three months of their termination date. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-insured Benefits: Medical and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Despite the Plan's utilization of third-party claim processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

#### **Note 1. Description of the Plan (Continued)**

COBRA - Consolidated Omnibus Budget Reconciliation Act: Generally effective for Plan years beginning on or after July 1, 1986, the Plan was required to offer continuation of benefits for a specified period of time to qualified employees and their dependents that would not otherwise be eligible for continued coverage because of a particular qualifying event as required by law. Each qualifying individual pays his/her premiums to COBRA Serve (a third-party administrator). COBRA Serve forwards the premiums collected from the claim's administrator who, in turn, forwards them to the Plan for deposit into the trust account, which are shown as participant contributions. COBRA claims and other COBRA expenses are paid from the custodial account.

Stop Loss Coverage: The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims in excess of the stop loss deductible, as well as its aggregate exposure for all claims). Premiums for stop loss reinsurance are paid by funds deposited in the Plan.

Administrative Fees: The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claim's administrator. These expenses are reported on the Statement of Changes in Net Assets Available for Plan Benefits and Plan Benefit Obligations. All other administrative expenses, such as professional fees, may be paid by the Company.

#### **Note 2. Summary of Significant Accounting Policies**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting which recognizes income as earned and expenses as incurred.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported claims (IBNR), claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Premiums paid by the plan are recorded as premium payments in the accompanying Statement of Changes in Net Assets Available for Benefits. Claim payments are recorded when paid by the third-party claim processor.

Stop Loss Insurance: The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the company was \$80,000 per covered person for the years ended June 30, 2024, and 2023. Premiums for stop loss insurance are included in premium payments to insurance carriers in the accompanying Statement of Changes in Net Assets Available for Plan Benefits. Stop loss reimbursements of \$248,274 have been netted with claims expense in the accompanying Statement of Changes in Net Assets Available for Plan Benefits for the year ended June 30, 2024.

#### **Note 2. Summary of Significant Accounting Policies (Continued)**

Estimated Liability for Claims Incurred but not Reported: The Plan's liabilities for claims incurred, but not reported as of June 30, 2024, were estimated by the Plan's claims processing administrator actuary. The estimate includes (1) unreported claims; (2) reported but unprocessed claims; and (3) processed but unpaid claims. Claim settlement expense liabilities are not included. A method is used that applies a factor (the reserve factor) to a credible best estimate volume measurement of paid claims. The calculation was performed for medical and prescription drug coverage. Due to the short nature of the reserve liability, time value of money was not used to discount future payments.

Concentration of Credit Risk: The Plan maintains its deposits in one financial institution located in Pennsylvania. This deposit is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, the Plan's cash account may be in excess of the FDIC insurance limit.

Subsequent Events: In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through February 5, 2025, the date the financial statements were available to be issued.

#### **Note 3. Cash, Interest-Bearing**

Cash consists of an interest-bearing money market account with a bank that is used to fund claim payments and insurance premiums. Interest income is recorded on an accrual basis.

#### **Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the remaining assets will be applied in a uniform and non-discriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for any other purpose other than the exclusive benefit of the Plan participants.

#### **Note 5. Related Party Transactions and Party-in-Interest Transactions**

The Plan has administrative arrangements with third-party service providers. These transactions are party-in-interest transactions under ERISA.

#### Note 6. Tax Status

The Plan is not exempt under any current section of the tax code. The Plan is funded through Veris Benefits Consortium, LLC Trust. The Veris Benefits Consortium, LLC Trust is included in the U.S. Income Tax Return for a limited liability Company Form 1065 of the third-party administrator of the plan. Plan management believes the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Risks and Uncertainties

Benefit Obligations: The Plan's estimate of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
