Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pension Plan for Hourly Paid Employees of Delta Star, Inc. (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of November 29, 2024 (in liquidation) and December 31, 2023 (in liquidation), and the related statements of changes in net assets available for benefits for the period from January 1, 2024 through November 29, 2024 (in liquidation) and for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Notes 1, 2, and 7 to the financial statements, Delta Star, Inc. approved a Plan of liquidation effective June 30, 2023, and management determined liquidation is imminent. As a result, the Plan's basis of accounting used in presenting the financial statements is the liquidation basis. The termination of the Plan was finalized on November 29, 2024, and all assets were distributed from the Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1—Description of the Plan

The following description of the Pension Plan for Hourly Paid Employees of Delta Star, Inc. (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a non-contributory defined benefit pension plan. The Plan covers all hourly paid employees of the Lynchburg, Virginia operations of Delta Star, Inc. (the “Plan Sponsor” or “Company”) who were at least 21 years of age, had completed one year of credited service, and were represented by the Union as of December 31, 2005. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All participants are fully vested in the Plan.

Plan Freeze – The Board of Directors of the Plan Sponsor amended the Plan to freeze eligibility and all future accruals under the Plan for all participants, effective as of the close of business December 31, 2005. No one who was not already a participant in the Plan became eligible to participate in the Plan after December 31, 2005, and that benefit a participant had accrued did not increase after December 31, 2005.

Earnings and service after December 31, 2005, are not counted in calculating the amount of pension. However, years of service after December 31, 2005, will continue to count toward vesting in a participant’s benefit and determining whether a participant is eligible for an early retirement pension. No benefits are lost that have already accrued under the Plan as of December 31, 2005, but the amount of a participant’s benefit has been “frozen” as of that date, based on average pay, covered pay, and years of credited service as of December 31, 2005.

Plan Termination – Effective June 30, 2023, the Plan was terminated. See Note 7.

Investments – The Plan Sponsor contributions are made into a trust held by First State Trust Company, the (“qualified institution”) of the Plan. Assets are invested in a diversified portfolio of investments, as directed by Morgan Stanley Smith Barney (“Morgan Stanley”), the investment manager of the Plan.

Benefit Payments – Plan benefits are generally payable to a participant upon the participant’s attainment of normal retirement age (as defined by the Plan) or upon determination of total and permanent disability, or to the participant’s beneficiary upon death of the participant. Plan benefits are generally payable for those eligible under the early retirement age option (as defined by the Plan) after completion of 10 years of credited service. The pension annuity, payable upon the normal retirement of any participant, is computed based on a monthly benefit rate per year of service.

Married participants may elect to receive their allowance under one of three actuarially equivalent payment modes: 1) a reduced allowance during the participant’s life, with a one-half rate allowance payable to the beneficiary after the participant’s death; 2) a reduced allowance during the participant’s life, with the same allowance continuing to the beneficiary after the participant’s death; or 3) a reduced allowance during the participant’s life, and guaranteed to continue to the participant, beneficiary, or the estate of the last to die, for no less than 5 or 10 years after the commencement of the pension.

Plan benefits may be paid to the participant in the case of total and permanent disability or to the participant’s beneficiary in the case of the death of the participant prior to full payment of all benefits.

Funding Policy – Contributions to provide benefits under the Plan are made by the Plan Sponsor. The Plan Sponsor’s funding policy is to make cash contributions to the Plan in amounts as determined by the Plan’s independent actuary using the Unit Credit Cost method. The payments are intended to provide sufficient funds to pay benefits as they become payable under the Plan. The Plan Sponsor met the minimum funding requirements of ERISA for the period from January 1, 2024 through November 29, 2024 and for the year ended December 31, 2023.

Note 2—Summary of significant accounting policies

Basis of Accounting – Plan management determined liquidation of the Plan was imminent during 2023. In accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), the accompanying financial statements have been prepared on the liquidation basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results may differ from those estimates.

Administrative Expenses – The Plan’s administrative expenses, which include primarily custodial, investment management, and professional fees for services provided by parties-in-interest, are paid by the Plan Sponsor or the Plan, as provided in the Plan document.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Cash equivalents are valued at face value, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on the investments bought and sold as well as held during the year.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Fair Value Measurements – The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 2—Summary of significant accounting policies (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Cash and Cash Equivalents – Cash and cash equivalents consist of a money market fund and interest bearing cash comprised of interest bearing deposits with banks or other financial institutions or federal funds sold, and securities purchased under agreements to resell with original maturities less than 30 days. Interest bearing cash is valued at cost, which approximates fair value, and is classified as Level 1 within the valuation hierarchy. The money market fund uses the amortized cost method to determine fair value and is classified as Level 1.

Common Stocks – These investments are publicly-held securities traded on major stock markets. They are classified within Level 1 of the valuation hierarchy.

Debt Securities – Debt securities consist of corporate debt and U.S. government and agency obligations. Corporate debt fair value is estimated using recently executed transactions, market price quotations (where observable), or credit spreads. The spread data used is for the same maturity as the obligations. The fair value of U.S. government and agency obligations is valued using pricing models to maximize observable inputs for similar securities. All bond investments are categorized as Level 2 within the fair value hierarchy.

Common Collective Trust Fund – This investment is a public investment vehicle valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is used as a practical expedient to measure fair value and is exempt from categorization within the fair value hierarchy. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. As of November 29, 2024 and December 31, 2023, there were no changes in methodology.

Note 3—Actuarial present value of accumulated plan benefits

Accumulated plan benefits are those future benefits payments, including lump-sum distributions that are attributable under the Plan's provisions to service rendered by employees as of the valuation date. Accumulated plan benefits include benefits expected to be paid to (1) retired or terminated employees or their beneficiaries, (2) beneficiaries of employees who have died, and (3) present employees or their beneficiaries. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The effect of Plan amendments on accumulated plan benefits is recognized during the year in which such amendments become effective.

Distributions arising from the Plan termination include monthly annuities, lump sum payments for participants who elected a lump sum distribution, and the annuity payment purchases for participants who elected or were already enrolled for annuity payments.

Note 4—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, First State Trust Company, the qualified institution of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value and accrued income receivable as shown in the statements of net assets available for benefits as of November 29, 2024 and December 31, 2023.
- Net appreciation in fair value of investments and interest and dividends as shown in the statements of changes in net assets available for benefits for the period from January 1, 2024 through November 29, 2024 and for the year ended December 31, 2023.
- Schedule of Reportable Transactions – Form 5500, Schedule H, Part IV, Line 4j for the period from January 1, 2024 through November 29, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 6—Related party and party-in-interest transactions

Certain Plan investments were invested in funds managed by the qualified institution, the Plan's investment manager, and affiliates of the Plan's qualified institution. These qualify as party-in-interest transactions. For the period from January 1, 2024 through November 29, 2024 and for the year ended December 31, 2023, the Plan paid \$492 and \$17,365, respectively, for services rendered.

Note 7—Plan termination

In April 2023, the Company began the process of terminating the Plan, which was effective June 30, 2023. Upon the termination date, the accrued benefits of all participants became 100% vested.

The Notice of Intent to Terminate was provided to participants of the Plan on April 28, 2023, notifying them of the Plan's intention to terminate on June 30, 2023. The Notice of Plan Benefit was provided to participants of the Plan on July 21, 2023, notifying them that upon regulatory approval of the termination, they will be offered the option to elect a single lump sum payment, immediate monthly annuity payments, or deferred annuity payments. Participants already receiving benefit payments were notified of the intent to purchase an annuity contract for their benefits.

On January 22, 2024, the Company purchased a group annuity contract with Midland National Life Insurance Company to settle the remaining benefit obligations. Annuities purchased and paid to the insurance company totaled \$3,066,231. As part of the purchase of the group annuity contract, Plan benefit obligations and related annuity administration services for the transferred participants were irrevocably assumed and guaranteed by the insurance company. Payments to annuitants by the insurance company commenced on April 1, 2024.

The liquidation of the Plan was in compliance with the requirements of the Pension Benefit Guarantee Corporation and ERISA. As of November 29, 2024, all assets of the Plan were liquidated.

Note 8—Income tax status

The Internal Revenue Service (“IRS”) has determined and informed the Plan Sponsor by a letter dated February 28, 2023 that the volume submitter plan and the related trust were designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan’s administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of November 29, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

Note 10—Subsequent events

The Plan has evaluated subsequent events for potential recognition and/or disclosure in the financial statements through February 3, 2025, which is the date the financial statements were available to be issued.
