We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2021 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's

ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2021 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2021 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall

presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2021 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

2021 Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule of Delinquent Participant Contributions and Schedule of Assets (Held at End of Year) are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental

schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Other Matter

Auditor's Report on the 2020 Financial Statements

We were engaged to audit the 2020 financial statements of the Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed us not to perform and we did not perform any auditing procedures with respect to the information certified by a qualified institution. In our report dated October 13, 2021, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2020 financial statements, and (b) the form and content of the information included in the 2020 financial statements other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Minamyer Residential MR DD SER 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution 401(k) plan which was established January 1, 2010 for the exclusive benefit of eligible employees of Minamyer Residential MR DD SER (the “Company” or “Employer”), as defined in the Plan document. The amended and restated provisions of the Plan became effective on January 1, 2018.

Contributions—Each year, participants may contribute up to a maximum of 100% of their annual compensation, as defined in the Plan. Roth deferrals are permitted. However, these contributions shall not exceed the maximum amount permitted by the Internal Revenue Code. Employees are eligible to enter the plan on January 1 and July 1, after completing one year of service and 1,000 hours.

The Plan complies with the safe harbor matching contribution formula. The safe harbor formula also intends to satisfy the safe harbor contribution requirement for deemed satisfaction of the Average Contribution Percentage (ACP) and Average Deferral Percentage (ADP) tests. The Employer match consists of 100% of the first 3% of employee compensation and 50% of the next 2% of employee compensation. The safe harbor matching contribution is 100% vested immediately and is made with each pay period. For the year ended December 31, 2021, the Employer contributed \$72,659 in matching contributions to the Plan.

The Plan is allowed to make a discretionary profit sharing contribution. Management has not historically exercised this option for the Plan and did not do so in the current year.

Upon enrollment, a participant may direct employee and employer contributions into any of the Plan’s investment options.

Participant Accounts—Each participant’s account is credited with the participant’s and employer contributions and allocations of Plan earnings or losses. Earnings or losses of the Plan are allocated to individual participant accounts based on the participant’s account balance in the applicable fund. Certain Plan investments are shares of mutual funds owned and managed by Nationwide Trust Company, FSB (Nationwide), the Plan’s custodian.

Notes Receivable From Participants—Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested balance. These borrowings are classified as notes receivable from participants and are carried at cost in the accompanying statements of net assets available for benefits. The loans are secured by the participants’ vested interest in the Plan’s assets and are generally due in semi-monthly payments of principal plus interest at the rate established at the issuance of the loan (ranging from 4.25% to 6.50%), with maturity dates of one to five years, unless the loan is used to acquire the principal residence of the participant. The minimum

amount of any loan is \$1,000. The loans bear interest at a fixed-rate based on the U.S. Bank Prime Loan rate plus one percent as of the loan date.

Vesting—Amounts contributed by participants and earnings or losses thereon become immediately vested. The Employer’s matching contributions and related earnings or losses become 100% vested upon entry into the Plan. The Employer’s discretionary profit sharing contributions and related earnings or losses become vested in accordance to the following schedule:

Withdrawals—Any participant can withdraw all or any portion of their vested account balance as a result of attainment of age 59-1/2.

Benefits Paid to Participants and Beneficiaries—On termination of employment other than death, a participant will receive a lump-sum amount equal to the vested value of their account balance if the participant’s account balance does not exceed \$1,000. Participants with account balances over \$1,000 may also elect to continue to participate in the Plan. Death benefits will be paid to the participant’s designated beneficiary, which generally requires payment by the end of the calendar year following the date of death.

The Coronavirus Aid, Relief and Economic Security Act (the “CARES Act”) was signed into law on March 27, 2020. The Cares Act, as specified, provides relief to Plan participants who have been affected by the novel coronavirus pandemic. The Plan is operating in accordance with the CARES Act and will execute a formal amendment within the timeframe required by law.

Plan Termination—The Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to various provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts, and all unallocated amounts shall be allocated to the accounts of all participants. In 2022, the Company was sold to Beacon Specialized Living (Beacon). Participants that were employed by Beacon were given the option to rollover the participant account to Beacon’s retirement plan. Also, all participants could take a distribution of their account balance, distribute the account to the participant, rollover their account to a Nationwide IRA, or rollover their account to their own IRA. All plan assets were distributed by October 13, 2022.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The financial statements of the Plan are prepared on the accrual basis of accounting.

Administrative Expenses—Administrative expenses of \$24,962 consist of custodian transfer fees and asset management fees which were paid by the participants and allocated to each participant based on their proportion of Plan assets. Additionally, the Company provides certain accounting and administrative services at no cost to the Plan.

Benefits Paid to Participants and Beneficiaries—Distributions to plan participants or beneficiaries are recorded in the statement of changes in net assets available for benefits when paid. At December 31, 2021 and 2020, there were no unpaid amounts due to participants who had elected to withdraw from the Plan.

Use of Estimates—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Nationwide does not record dividends or interest income from mutual funds directly to participants. Nationwide owns all mutual funds shares directly and allocates units to each participant. Nationwide records all investment activity (dividends, interest, appreciation/depreciation) as earnings or losses to each applicable participant. The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation or depreciation which includes dividends and interest income in the fair value of investments, realized gains or losses, and the unrealized appreciation or depreciation on those investments.

Notes Receivable from Participants—Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses as they are incurred. No allowance for credit losses has been recorded as of December 31, 2021 and 2020. Delinquent notes receivable from participants that are deemed to be in default are reduced and a benefit payment is recorded.

Subsequent Events—The Plan has evaluated subsequent events through December 13, 2024, the date the financial statements were available to be issued. In 2022 the Company was sold to Beacon. Participants that were employed by Beacon were given the option to rollover the participant account to Beacon’s retirement plan. Also all participants could take a distribution of their account balance, distribute the account to the participant, rollover their account to a Nationwide IRA, or rollover their account to their own IRA. All plan assets were distributed by October 13, 2022. Other than the sale, there were no transactions or events that required disclosure through the report date.

3. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The following is a summary of the unaudited information regarding the Plan, which was prepared by or derived from information prepared by Nationwide, the custodian of the Plan, and furnished to the plan administrator. The plan administrator has obtained certification from the custodian that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, and Level 3 inputs consist of significant unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Group annuity: Value is determined solely by Nationwide. Account only earns interest, per quarter, as determined by Nationwide but will never go below 0.5%.

5. TAX STATUS

The IRS has determined and informed the Company by a letter dated April 10, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan was updated with the IRS requirement to restate plan documents every six years. The amendment and restatement of the plan is effective January 1, 2018.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTIES-IN-INTEREST

Certain Plan investments are shares of mutual funds owned and managed by a Nationwide affiliate related to the Plan's custodian, and the Plan makes loans to participants. These transactions qualify as party-in-interest transactions. The custodian owns and manages the

mutual funds in the Plan for which they receive management fees. These management fees are part of the annual operating expenses of each fund and range from 0.39% to 0.43% of the value of the investment. These fees result in a reduction of earnings from investments. In addition asset management fees of \$24,962 were paid to Nationwide during 2021 and these fees are included in administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with various investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. PROHIBITED TRANSACTIONS

During 2021, the Company failed to remit contributions for twelve pay periods to the Plan in a timely manner, as defined by ERISA. The prohibited transaction was not corrected under the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) during 2021. As of the date the 2021 financial statements were available to be issued, the Company corrected the prohibited transaction outside of the VFCP in accordance with the advice of its ERISA counsel. During 2020, the Company failed to remit the contribution for one pay period to the Plan in a timely manner, as defined by ERISA. The prohibited transaction was not corrected under the Department of Labor's VFCP during 2020 but was corrected outside of VFCP as of the date the 2020 financial statements were available to be issued.
