We have performed audits of the financial statements of Z & Z Holding Company, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1 – Description of Plan**

The following description of Z & Z Holding Company, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**Plan Merger**

Effective January 1, 2024, Z & Z Holding Company, Inc. became an adopting employer of the Johnstone Supply, LLC Employee Retirement Plan. On May 22, 2024, a certificate of company resolutions was signed by Johnstone Supply, LLC, merging the Z & Z Holding Company, Inc. 401(k) Profit Sharing Plan into the Johnstone Supply, LLC Employee Retirement Plan. As a result of the merger, assets and liabilities in the amount of \$16,108,695 were transferred from the Z & Z Holding Company, Inc. 401(k) Profit Sharing Plan on May 31, 2024 and received by the Johnstone Supply, LLC Employee Retirement Plan on June 3, 2024, in accordance with Code Section 414(1) and regulations thereunder. As stated in the company resolution, the Z & Z Holding Company, Inc. 401(k) Profit Sharing Plan merged with the Johnstone Supply, LLC Employee Retirement Plan effective June 3, 2024.

**General**

The Plan was a defined contribution plan established by Z & Z Holding Company, Inc. (the Plan Sponsor and Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Company and any participating affiliates were subject to the following eligibility requirements:

- Age: 19
- Service: 3 months for employee deferrals, 1 year for employer contributions
- Status Exclusions:
  - a. Members of collective bargaining agreement
  - b. Residents of Puerto Rico
  - c. Non-resident aliens with no U.S. earned income
  - d. Part-time, temporary, or seasonal employees

Upon satisfying the eligibility requirements, employees participated in the Plan on the first day of the next month.

**Contributions**

The Plan was funded through employee elective deferrals and Company contributions. Each year, participants could elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants were permitted to deposit or “roll over” into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The following contribution types were allowed by the Plan:

- Elective deferrals
- Employer matching
- Employer profit sharing
- Rollover contributions
- Roth deferrals

The Plan had an automatic enrollment provision (4% salary deferral with 1% increases annually on the first day of the plan year until reaching a maximum of 15%) whereby employees must have elected out of the Plan if they did not wish to participate.

The Company could have made discretionary matching and non-elective employer contributions on behalf of eligible employees and are made at the discretion of the Company. The discretionary matching contribution was made in an amount equal to either a percentage of compensation or a dollar amount as it relates to elective deferrals made by eligible participants during the plan year. Participants must have been employed on the last day of the plan year and have earned 1,000 hours of service to be eligible to receive discretionary matching contributions. The Company matched 50% of up to 6% of each participants' compensation for the year ended December 31, 2023. The Company made no contributions to the Plan in 2024.

The Company could have made discretionary profit-sharing contributions which were allocated in accordance with the plan document provisions. Participants must have been employed on the last day of the plan year and have earned 1,000 hours of service to be eligible to receive discretionary profit-sharing contributions. The profit-sharing contribution totaled \$0, for the years ended May 31, 2024 and December 31, 2023.

**Participant Accounts**

Each participant's account was credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that were paid by the Plan. Allocations were charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting**

Participants were immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for Company matching and profit sharing contributions was based on vesting periods of service. Participants were credited with a period of service for 1,000 hours earned. If participants were employed on or after their Normal Retirement Age or if they terminate employment on account of death or disability, they were 100% vested in their Company matching and profit sharing contributions.

**Forfeited Accounts**

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allowed forfeitures of non-vested Company contributions to be used as follows:

- Pay Administrative Expenses
- Reduce Company Contributions
- Reallocated As Company Contributions

As of May 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$11,153, respectively. During the year ended May 31, 2024, forfeited non-vested accounts of \$0 were used. \$10,582 was withdrawn by the Company on May 31, 2024.

**Investment Options**

Upon enrollment in the Plan, a participant directed the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant could change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

**Notes Receivable from Participants**

Participants who were active employees borrowed against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, were secured by the balance in the participant's account, and accrued interest at reasonable rates, which were commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions and generally repaid within 5 years. 2 loans could be outstanding at one time.

**Benefits Paid to Participants**

Upon termination of service, disability, or retirement, a participant was entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account would be made to the designated beneficiary.

Participants with a vested account balance less than \$1,000 automatically received a lump-sum distribution. Participants with a vested account balance between \$1,000 and \$5,000 who did not elect a form of distribution had their vested account balance rolled over to an individual retirement account selected by the Plan.

As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 72 or 73 if the participant is not 72 prior to January 1, 2023, or (ii) the year in which the participant retires.

The following types of distributions were also allowed by the Plan:

- In service
- Hardship
- Termination partial withdrawal
- Rollover source withdrawal at any time

**Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their non-vested accounts. See Note 1 regarding the Plan's merger on June 3, 2024.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 31, 2024 and December 31, 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan are recorded as deductions in the accompanying statement of changes to net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events**

The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. Management has evaluated

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at May 31, 2024 and December 31, 2023.

*Mutual Funds*

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market prices.

The methods described above may produce a fair value valuation that may not be indicative of net realized value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Fully Benefit-Responsive Investment Contracts**

The Plan invested in the Empower Investment Fixed Account, which is a fully benefit-responsive guaranteed investment contract (GIC). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract that was held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established in a contract between the Plan and the contract issuer, which will not fall below 0%. The crediting rate is reviewed semi-annually for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**Note 6 – Related Party Transactions and Transactions with Parties-in-Interest**

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended May 31, 2024, the Plan made direct payments of \$28,700 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**Note 7 – Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 – Tax Status**

The Plan sponsor adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service dated November 14, 2022, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan was required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of May 31, 2024 and December 31, 2023 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.
