## Independent Auditors' Report

We have performed audits of the financial statements of the Swanson Industries, Inc. ## 1. Description of Plan

The following description of the Swanson Industries, Inc. Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a noncontributory defined benefit plan established effective July 1, 1988, as restated July 1, 2018. The Plan covers all employees of Swanson Industries, Inc. (the Company) who have completed 1,000 or more hours of service in a 12 consecutive month period and are age 21 or older, except employees that are part of the Steelworkers Union at Swanson Manufacturing, Swanson Plating and Morgantown Machine and Hydraulics. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Management is responsible for oversight of the Plan as well as determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

On September 30, 2014, the Plan was amended to freeze all participation and accrued benefits effective November 15, 2014. As such, no new employees will be eligible to participate in the Plan and pension benefits disclosed below will not be subject to change as of November 15, 2014.

### Funding Policy

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. The minimum funding requirements of ERISA were met in 2024.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### Pension Benefits

Plan participants are entitled to their plan benefits after terminating employment with vested rights. Participants become vested in the Plan upon completion of at least five years of service or attainment of the normal retirement age (65), although the Plan does allow for early retirement at the age of 60. If employees terminate before rendering the required years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Company's contributions. Upon becoming vested, participants are entitled to (1) .65% of average annual compensation multiplied by service from date of hire until normal retirement (maximum 35 years) plus (2) 1.30% of average annual compensation in excess of covered compensation provided by social security multiplied by service from date of hire until normal retirement (maximum 35 years), subject to the plan amendment disclosed above. The form of a participant's benefit payment at normal retirement can be a qualified joint and survivor annuity, life annuity, or lump sum payment.

### Death and Disability Benefits

The surviving spouse of a married participant who dies prior to the deceased participant's annuity commencement date will receive a qualified pre-retirement survivor annuity, as defined by the Plan.

A participant who becomes disabled will be entitled to a disability retirement benefit. The amount of the disability retirement benefit will be equal to the vested portion of the participant's accrued benefit as of the date disability is established.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits payments to participants are recorded upon distribution.

### Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the Statement of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

### Subsequent Events

Subsequent events were evaluated through February 7, 2025, the date the financial statements were available to be issued.

### 3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, such as retirement, death, disability, and termination of employment, are included, to the extent they are attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits were made as of June 30, 2024 and 2023. The significant actuarial assumptions used in the valuations were:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Money market funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 5. Concentrations

As of June 30, 2024 and 2023, the Plan had investments of \$8,028,544 and \$7,952,452, respectively, that were concentrated in four funds.

## 6. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, United Bank, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of June 30, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of June 30, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended June 30, 2024 and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended June 30, 2024.

## 7. Related-Party and Party in Interest Transactions

The Plan's investments are administered under a contract with United Bank, the Trustee of the Plan. Contributions are held and managed by United Bank, who invests cash received, interest and dividend income and makes distributions to participants. These transactions are party in interest transactions under ERISA.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. These transactions are party in interest transactions under ERISA.

## 8. Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

## 9. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated April 25, 2012, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

10. Funding Method:

**Traditional Unit Credit**

The actuarial cost method used in the valuation was the unit credit cost method.

The normal cost is the sum of all the individual normal costs for each participant. For active participants, the individual normal cost is the present value of the benefit earned during the year being valued. For active participants whose credited service equals or exceeds the plan maximum, if any, and for non-active participants, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all participants. The individual accrued liability for an active participant is the present value of the accrued benefit as of the valuation date. The unfunded liability is the actuarial accrued liability less the valuation assets.

The total annual cost of the plan is the normal cost plus the shortfall amortization charge.

**Projected Unit Credit**

The actuarial cost method used in the development of the maximum contribution and the at-risk liabilities was the projected unit credit cost method.

Under this method, the normal cost is the sum of the individual normal costs for all participants. For an active participant, the individual normal cost is the present value at the current age of the projected benefit at the assumed retirement age, based on the actuarial assumptions, divided by the participant's expected years of credited service at that age. For a non-active participant, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all plan participants. For an active participant, the individual accrued liability is the product of the normal cost and the total years of credited service at the current age. For non-active participants, the individual accrued liability is the present value at the current age of future benefits. The unfunded actuarial accrued liability equals the actuarial accrued liability less the valuation assets.

The following is a summary of the major provisions of the above plan as of the valuation date. Please refer to the plan document for a more complete description of the most recent plan provisions.

A. General

1. Effective Date: Original Effective Date July 1, 1988
2. Plan Year: 12-month period beginning July 1st and ending June 30th.

B. Participation: Any employee whose employment is not governed by a collective bargaining agreement, as well as any employee whose employment is governed by the terms of a collective bargaining agreement if the agreement specifies participation in this plan, is eligible on the first entry date which coincides with or next follows the later of the completion of one Year of Continuous Service and age 21. Entry dates are July 1 and January 1. Participation was frozen effective November 15, 2014.

C. Retirement Requirements

1. Normal: The first of the month coincident with or next following the employee's 65th birthday or if later, 5th anniversary of initial participation date.
2. Early: After attainment of age 60 with completion of 5 years of service.
3. Deferred Vested: A participant will be fully vested in his Accrued Benefit after 5 years of Continuous Service.

D. Retirement Benefits

1. Normal: A monthly benefit equal to:
  - a. .65 percent of Average Monthly Compensation multiplied by service from date of hire until Normal Retirement (maximum 35 years), plus
  - b. .65 percent of Average Monthly Compensation in excess of Covered Compensation provided by Social Security multiplied by service from date of hire until Normal Retirement (maximum 35 years).
2. Early: The Actuarial Equivalent of the participant's Accrued Benefit.
3. Late: Participant's Normal Retirement Benefit calculated as of the participant's Late Retirement Date.

Death Benefits: Qualified Pre-Retirement Survivor Annuity: The surviving spouse of a married participant who dies prior to the participant's Annuity Commencement Date under the Plan and after completion of 5 years of Continuous Service shall receive a Qualified Pre-Retirement Survivor Annuity. Participant becomes 100% vested at time of death.

F. Definitions

1. Accrued Benefit: Normal Retirement Benefit multiplied by a ratio of completed years of service divided by possible years of service at Normal Retirement. For determination of the accrued benefit ratio, years of service does not include the year of service during which the Normal Retirement Date falls. The ratio cannot exceed one.

Effective June 30, 1993, the Accrued Benefits of all participants in the Industrial Plating and Machine division were frozen.

Effective November 13, 2003, employees at MM&H of West Virginia no longer accrue benefits.

Effective October 28, 2004, employees of the PACE Union at Swanson Plating no longer accrue benefits.

Effective November 15, 2014, benefits were frozen for all participants.

2. Compensation: Participant's annual W-2 wages. The compensation limit for determination periods beginning before January 1, 2002 will be \$200,000. For determination years beginning after January 1, 2002, the compensation limit will be \$200,000 adjusted for cost-of-living increases per section 104(a)(17)(B) of the Code.
3. Average Compensation: Based upon highest 5 consecutive Plan Years out of the final 10 Plan Years, during which he/she was a participant. If a participant has less than 5 years of Active Participation, however, Compensation is averaged over all months during which the Employee was an Active Participant.
4. Normal Form of Payment: Life Only Annuity

5. Years of Service: Over 1000 hours in a Plan Year equals one Year of Service. Vesting Service excludes service prior to July 1, 1988.

Employee: Any person who is employed by the employer, except that the term will not include any individual whose employment is governed by the terms of a collective bargaining agreement with the Employer under which retirement benefits were the subject of good faith bargaining, unless such agreement specifically provides for participation in this Plan. Also, the term "Employee" will not include any individual who is a Leased Employee. Finally, the term "Employee" will not include any individual who is characterized as an independent contractor by the Employer.
7. Actuarial Equivalence:
  - a. Lump Sums: 417(e) applicable lump sum mortality table and 417(e) applicable interest rates for the fourth month prior to the beginning of the plan year.
  - b. Early/Late Retirement: An immediate benefit as calculated for Normal Retirement but reduced 0.00555 for each of the first 60 months and 0.00277 for each of the next 60 months that the Early Retirement Date precedes the Normal Retirement Date.
  - c. Optional Forms: Commissioners' Standard Table and 30-Year Treasury Rate for fourth month prior to the beginning of the plan year.
8. Covered Compensation: Based upon Social Security Table II in effect at date of termination, death or retirement. Beginning in 1989, Covered Compensation will be developed using a 35-year average of the taxable wage bases preceding Social Security Retirement Ages
