## Notes to Financial Statements

July 1, 2023 and December 31, 2022

### **1. Description of the Plan**

The following description of the Acorn Health 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan available to eligible employees of Acorn Health and affiliates (collectively, the Employer) who have three months of eligible service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 1, 2023, the Plan merged, and Plan assets were transferred into the Choice Pooled Employer Plan I (Choice Plan), a pooled employer plan.

The Employer was responsible for the administration of the Plan and had entrusted the maintenance of records and the day-to-day administration to TAG Resources (TAG), who processed transactions through Transamerica Financial Life Insurance Company (Transamerica), the custodian.

#### **Contributions**

Each year, participants could contribute up to 90% of their pre-tax annual compensation, as defined in the Plan. In addition, participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants could direct the investment of their contributions into various investment options offered by the Plan. Participants could change the investment options previously elected at any time.

The Employer could make discretionary matching, nonelective and qualified nonelective contributions to the Plan. For 2023 and 2022, no discretionary matching or nonelective contributions were made to the Plan. During 2022, the Employer made a qualified nonelective contribution to the Plan totaling \$3,203.

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account was credited with the participant's contributions, the Employer's discretionary matching, nonelective and qualified nonelective contributions and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Vesting

Participants were immediately vested in their voluntary contributions and discretionary qualified nonelective contributions plus actual earnings on these contributions. Vesting in the Employer's discretionary matching contribution and discretionary nonelective contribution portion of their accounts plus related earnings thereon was based on years of vesting service in which the participants completed 1,000 hours of service, as follows:

##### Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

##### Payment of Benefits

On termination of service due to death, disability or early retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age could choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permitted in-service and hardship withdrawals under certain conditions.

##### Forfeitures

Forfeitures were created when participants terminated employment before becoming entitled to their full benefits under the Plan and were considered nonparticipant-directed investments. Forfeitures could be used to pay administrative expenses and to reduce future Employer contributions.

### Notes to Financial Statements (continued)

#### **2. Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments were reported at fair value except for its benefit-responsive investment contract, which was valued at contract value (Note 6). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determined the Plan's valuation policies utilizing information provided by the custodian. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred. No allowance for credit losses had been recorded as of July 1, 2023, December 31, 2022 or 2021. If a participant ceased to make scheduled repayments and the Plan administrator deemed the note receivable to be in default, the note receivable balance was reduced and a benefit payment recorded.

##### **Benefits Paid to Participants**

Benefits were recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through February 6, 2025, the date the financials were available to be issued.

**3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of July 1, 2023, December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest income from stable value core account, interest income on notes receivable from participants and transfer to Choice Plan for the period ended July 1, 2023 and year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

**4. Concentrations**

The Plan has two investments representing greater than 20% of net assets available for benefits as of December 31, 2022 and 2021.

**5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan can access.
- Level 2 Inputs to the methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### 5. Fair Value Measurements (continued)

The fair value measurement level within the fair value hierarchy for assets and liabilities is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled separate accounts:* Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

*Common/collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 6. Group Annuity Contract

The Plan invested in a fully benefit-responsive investment contract with Transamerica totaling \$42,727 and \$37,764 as of December 31, 2022 and 2021, respectively. Transamerica maintained the contributions in a general unallocated account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The effective rate of interest was established every January 1 and July 1 and was based on the daily balance, at a rate that was the daily equivalent of the effective annual rate of interest applicable for the six-month period. There were no guaranteed minimum or maximum interest rates under this contract, no unfunded commitments, and redemption frequency and notice period could occur daily.

The contract met the fully benefit-responsive investment criteria and therefore was reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts, because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represented contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations was affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included amendments to the Plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Employer or other Employer events that caused a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract.

#### **6. Group Annuity Contract (continued)**

Even though the Employer elected to join the Choice Plan, this event did not limit the ability of the Plan to transact at contract value with the contract issuers or limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation or a material amendment to the agreement without consent of the issuer.

#### **7. Related Party Transactions and Party-in-Interest Transactions**

Plan investments were in accounts of Transamerica; therefore, these transactions qualified as party-in-interest transactions. Notes receivable from participants and participant contributions were also considered to be party-in-interest transactions. Employer contributions, if any, were considered to be both party-in-interest and related party transactions.

#### **8. Tax Status**

The Plan adopted non-standardized pre-approved profit sharing plan which had received an opinion letter dated August 17, 2021, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan had been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believed the Plan was designed and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believed the Plan was qualified, and the related trust was tax-exempt.

#### **9. Risks and Uncertainties**

The Plan invested in various investment securities, which were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term, and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

#### **10. Delinquent Employee Deferral Transmittals**

During 2023, the Employer failed to remit certain Plan participant contributions totaling \$8,800 within the period prescribed by the DOL regulations. Delays in remitting contributions to the custodian were due to administrative errors, and the Employer has made contributions to the affected participants' accounts subsequent to July 1, 2023, to compensate those participants for potential lost income due to the delays.
