We have performed audits of the accompanying financial statements of the **VonLehman & Company, Inc. (1) **DESCRIPTION OF PLAN**

The following description of the **VonLehman & Company, Inc. Employee's Savings Plan** (the "Plan") provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by VonLehman & Company, Inc. ("Company") effective as of October 1, 1985, covering substantially all employees of the Company. To be eligible for the employer discretionary profit sharing contribution an employee must be 21 years of age, complete 1,000 hours of service during the plan year, and be employed by the Company on the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

See Note 5 for discussion of the plan merger with the Dean Dorton Allen Ford, PLLC Retirement Plan ("DDAF Plan") in April 2024.

**Contributions**

Participants may make pre-tax and after-tax Roth elective salary deferrals up to 100% of total compensation, as defined in the plan document, subject to limitations imposed by Internal Revenue Code ("IRC") regulations. Eligible participants are permitted to make special catch-up contributions in accordance with IRC regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit plans, defined contribution plans or individual retirement accounts. The employer may also make discretionary profit sharing or matching contributions when authorized by management.

Effective January 1, 2024, all employee salary deferral contributions not previously accrued as receivables made on behalf of the Company's employees were contributed to the DDAF Plan.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan offers various mutual funds and common/collective funds as investment options for participants. Participants may also elect to have their accounts invested in discreet segregated accounts managed by independent financial advisors selected by the participants (referred to as participant-directed brokerage accounts). Participants may change their investment elections at any time.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of plan earnings, and charged with an allocation of plan losses and administrative expenses. Allocations are based on participant compensation, account balances or specific transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their salary deferral and rollover contributions, plus actual earnings thereon. Vesting in employer contributions is based on years of continuous service as defined in the plan document. Participants are 100% vested in their employer contributions after six years of credited service. As a result of the plan merger discussed in Note 5, participants became 100% vested in their employer contributions as of April 1, 2024.

**Notes Receivable from Participants**

Participants may borrow from their accounts. The minimum amount of a note is \$1,000 and the note must charge a reasonable rate of interest. The term generally cannot exceed 60 months. Adequate collateral, as defined in the plan document, is required for the note and the note cannot exceed 50% of the participant's vested interest in their account. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, participants may elect to receive either a lump sum amount equal to the value of their vested account balance or any form of payments agreed upon by the plan administrator and the participant. The Plan also provides for in-service distributions for participants that have attained age 59½. Separated participants with vested account balances exceeding \$5,000 may elect to defer benefits until reaching normal retirement age.

**Forfeited Accounts**

Participants forfeit employer contribution accounts when terminating service prior to vesting in their employer contributions. These accounts are used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested accounts of \$8,465 and \$32,035 were used to pay Plan expenses for the period ended April 30, 2024 and the year ended December 31, 2023, respectively. Employer contributions receivable at December 31, 2023 and employer contributions for the year ended December 31, 2023 were reduced by forfeited nonvested accounts of \$55,695. At December 31, 2023, forfeited nonvested accounts totaled \$60,154.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. See Note 3 for additional discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Capital gain distributions from mutual funds are included in dividend income. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Investment Valuation and Income Recognition – continued**

Management fees and operating expenses charged to the Plan for investments in mutual funds and common/collective funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for these investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of April 30, 2024 and December 31, 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. The interest rates on notes receivable from participants outstanding at December 31, 2023 and prior to the merger with the DDAF Plan ranged from 4.50% to 9.25%.

**Administrative Expenses**

Some administrative expenses are paid by the Company and some are paid by the Plan. Those that were paid by the Plan are reflected in the accompanying financial statements. Employees of the Company perform certain administrative functions for the Plan. Neither the Company nor its employees receive compensation from the Plan.

**Payment of Benefits**

Benefits are recorded when paid. At April 30, 2024 and December 31, 2023, there were no allocated amounts to participants who had elected to withdraw from the Plan, but had not yet been paid.

**Subsequent Events**

Management has evaluated whether any subsequent events that require recognition or disclosure in the accompanying financial statements and related notes thereto have taken place through February 4, 2025, the date these financial statements were available to be issued.

(3) **FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observed for the asset; or inputs that are derived principally from or can be corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are used only if Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation techniques and related inputs used for assets measured at fair value at April 30, 2024 and December 31, 2023.

**Mutual Funds**

The fair value of mutual funds is based on the quoted NAV of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the United States Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Participant-Directed Brokerage Accounts**

Participant-directed brokerage accounts consist of various investments. Cash and money market funds, corporate stocks, mutual funds and real estate investment trusts are valued at quoted market prices. U.S. government and agency bonds and corporate bonds are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing the value on yields currently available on comparable securities of issuers with similar credit ratings. Unit investment trusts are valued at the fair value of the underlying assets in the trust. Investments in participant-directed brokerage accounts consisted of the following at December 31, 2023:

**Common/Collective Funds**

Investments in the common/collective funds are valued at the NAV of the shares or units held by the Plan based on the fair value of the assets underlying the funds, as reported by the fund manager. NAV is used as a practical expedient for fair value. The practical expedient would not be used if it is determined to be probable that the Plan will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily, and there were no redemption or frequency restrictions on the common/collective funds as of December 31, 2023. There were no unfunded commitments related to the common/collective fund investments at December 31, 2023.

Gains and losses included in changes in net assets available for benefits for the period ended April 30, 2024 and year ended December 31, 2023 are reported in net appreciation in fair value of investments.

**(4) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fees paid by the Plan to the trustees, service providers or affiliates of the trustees or service providers for the administration of the Plan are reflected in the statements of changes in net assets available for benefits. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

**(5) PLAN MERGER**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

Effective April 1, 2024, the Plan was merged into the DDAF Plan. All participants became 100% vested in their employer contributions effective April 1, 2024, and plan assets totaling \$25,157,253 were transferred to the DDAF Plan in April 2024.

**(6) TAX STATUS**

The Plan is based on a pre-approved plan that has received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the IRC. The plan sponsor has not separately applied for a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**(7) RISKS AND UNCERTAINTIES**

The Plan invests in mutual funds, common/collective funds and various other investments through participant-directed brokerage accounts that are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**(8) INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Charles Schwab Trust Bank as of and for the period ended April 30, 2024 and as of and for the year ended December 31, 2023, stating that the certified investment information is complete and accurate. The following is a summary of the information included in the Plan's financial statements that was obtained from data prepared and certified to as complete and accurate by the trustee.

**(9) STABLE RETURN FUND**

The Plan's investment options at December 31, 2023 included the Galliard Stable Return Fund C, formerly the Wells Fargo Stable Value Fund C ("Stable Return Fund"). The Stable Return Fund invests in fully benefit-responsive investment contracts and security-backed contracts. The Stable Return Fund allows for earnings stability regardless of the volatility of the financial markets. Participants will receive the principal and accrued earnings credited to their accounts on withdrawal for allowed events. These events include transfers to other Plan investment options, and payments because of retirement, termination of employment, disability, death and in-service withdrawals as permitted by the Plan. Certain events, such as Plan termination or a Plan merger initiated by the Plan sponsor, may permit the issuer to temporarily delay withdrawal from the funds in order to ensure that securities liquidations are carried out in an orderly business manner.

The Stable Return Fund is recorded at fair value in the accompanying financial statements using NAV as a practical expedient. See Note 3 for additional discussion. The Stable Return Fund's net assets include fully benefit-responsive investment contracts that are accounted for at contract value in the determination of NAV.

Interest is credited to the funds at interest rates that reflect the performance of the underlying portfolio. There are no reserves for credit risk of the contract issuer or otherwise. The credited interest rate resets quarterly. The average yield on actual earnings for the Stable Return Fund was 2.93% for 2023, and the average yield credited to participants was 4.92% for 2023.
