Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Unitek College Utah, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of April 10, 2024 and December 31, 2023, and the related statement of changes in net assets in liquidation for the period from January 1, 2024 through April 10, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Unitek College Utah, LLC 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan was established on January 2, 2014 and most recently amended on February 1, 2024. The Plan was sponsored by Unitek Learning Education Group Corp (the Company). Substantially all employees of the Company, who had completed one month of service, were eligible to participate in the Plan and could enter the Plan immediately following the completion of eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Transfer of Plan Assets

In connection with a Plan amendment effective February 1, 2024, the governing body of the Plan determined that the Plan would be merged into an affiliated plan. On April 10, 2024, total participant balances of \$3,914,016 were transferred to the affiliated plan.

Administration

The Plan was administered by the Company and C-Ben Group. Among other duties, it was the responsibility of the administrators to interpret the Plan, decide on questions of eligibility, determine the amount and manner of benefit payments and maintain administrative records of the Plan. All Plan assets as of December 31, 2023 and for period from January 1, 2024 through April 10, 2024 were held by Empower Trust Company, LLC (Empower).

Trustee

The trustee of the Plan was Great-West Trust Company, LLC. The primary duties of the trustee were to authorize investments and monitor payment of contributions, loans and benefits as directed by the Plan administrators.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The outstanding notes were secured by the balance in the participant's account and bore interest at the prime rate at the time of the borrowing plus one percent. Principal and interest was paid ratably through bi-weekly payroll deductions.

Forfeitures

Forfeitures were created when a participant terminated employment before becoming entitled to 100 percent of the amounts derived from the employer's contributions. The Plan provided for 100 percent vesting at all times and therefore no forfeitures were expected to arise under the Plan. During the period from January 1, 2024 through April 10, 2024, no forfeitures were utilized to fund administrative expenses. As of December 31, 2023, there were no forfeitures to be utilized to fund administrative expenses.

Contributions

Participants – The Plan permitted each participant, at their option, to elect to contribute up to 100% of annual compensation, not to exceed the Internal Revenue Service (IRS) limitations. For the period from January 1, 2024 through April 10, 2024, the maximum pretax salary deferral was limited to \$23,000. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also permitted to make Roth contributions to the Plan, not to exceed IRS limitations, and contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered mutual funds, common/collective trusts and a fixed annuity as investment options for participants. Participants were vested immediately in their contributions plus actual earnings thereon.

Employer – The Company made fully-vested safe harbor matching contributions that were equal to 100 percent of participant contributions up to 3 percent of the participant's eligible compensation and 50 percent of participant contributions that exceed 3 percent of the participant's eligible compensation up to 5 percent of the participant's eligible compensation. The Company could also make discretionary nonelective contributions. During the period from January 1, 2024 through April 10, 2024, no discretionary nonelective contributions were made by the Company.

All contributions made by the Company were fully-vested immediately.

Payment of Benefits

Participants were able to receive distributions from their accounts upon attainment of age 59½, retirement as a result of disability, incurrence of a financial hardship (as defined), termination of their employment with the Company, death, qualified in-service distributions, or termination of the Plan. The participant could elect to receive a lump-sum amount equal to the vested value of the participant's account balance, or installments over a period not to exceed the participant's life expectancy. For eligible participants receiving a required minimum distribution, the vested balance would be paid in installments over a period not to exceed the participant's assumed life expectancy.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

Accounting records of the Plan were historically maintained on the accrual basis of accounting. As a result of the Plan's termination discussed in Note 1, the accompanying financial statements have been prepared and presented on the liquidation basis.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan did not have any fully benefit-responsive investments.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value, as determined by Empower. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the cash basis. Dividends were recorded on the ex-dividend date. Net increase in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and expensed when incurred. No allowance for credit losses had been recorded as of December 31, 2023. If a participant ceased to make loan repayments and the Plan administrators deemed the participant's loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Administrative Expenses

Plan investments were subject to certain investment fees based on a percentage of invested assets. Such fees are included within net increase of the respective investments in the accompanying statement of changes in net assets in liquidation. Fees incurred for the administration of the Plan and participant requested services are reflected as administrative expenses in the accompanying statement of changes in net assets in liquidation.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through the date of the auditors' report, February 10, 2025, which is the date the accompanying financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Financial Accounting Standards Board's *Accounting Standards Codification (ASC) 820* are described as follows:

- a) Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- b) Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- c) Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for the Plan's investment measured at fair value at December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

Fixed annuity: The reported values for fixed annuity options are reported daily base on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s investments measured at fair value as of December 31, 2023. Classification within the fair value hierarchy table is based on the lowest level any input that is significant to the fair value measurement.

NOTE 4 – TRUST CERTIFICATION

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2023, net increase in fair value of investments, dividend and interest income from investments and notes receivables from participants for the period from January 1, 2024 through April 10, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

During the period from January 1, 2024 through April 10, 2024, the Plan paid administrative and recordkeeping fees of \$4,549 to Empower, which have been included within administrative expenses in the accompanying statement of changes in net assets in liquidation.

NOTE 6 – TAX STATUS

The IRS has determined and informed the Company that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving its last communication from the IRS, the Plan administrators believe that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust was tax-exempt.

NOTE 7 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The delinquent participant loans of active participants as of December 31, 2023 are included within notes receivable from participants in the accompanying 2023 statement of net assets in liquidation. These delinquent participant loans are shown as deemed distributions on participant loans on the Form 5500.
