Phoenix Aircraft Services, Inc correct address was 1501 Morris Road Wilmington, NC 28405. The Company address associated with the IRS EIN is this address, not the one the IRS sent the notice. Original 5500-SF was filed with this address. The Company did not file a 5500-SF form for Plan Year ending December 31, 2022 as the Company ceased operations on May 1, 2021 and filed a Final 1120-S Tax Return with the IRS for tax year ending December 31, 2021, there were no employees post May 1, 2021.

The original plan was set up by our payroll company Paychex. Paychex stopped providing services when operations ceased. We were not aware a Final 5500-SF was not submitted by Paychex when the Company ceased operations. We apologize for Paychex not closing this out at that time. We have been told the 5500-SF must be filed electronically on EFAS. We do not have access to EFAS we need to find access to get it filed. We request that no penalties be assessed as the Company has not existed for over three (3) years. Thank you.
