Dear Mr. Albert,

This letter serves as a formal response to your recent email regarding a missing Form 5500/5500-SF for the company and plan referenced above. After immediate review and investigation on the matter with ADP Retirement Services, our Plan's service provider, we have discovered that the filing was queued for submission on 11/8/2023 through FIS Relius Government Forms, but there was a system issue that prevented the electronic filing from being submitted. We have been timely in all prior years' filings that were submitted through ADP Plan's portal. Our company took proactive measures to ensure compliance with all regulations and filing deadlines. This filing was different because in January 9, 2023, Revolution 401(k) Plan went through a merger with another Plan and a final Form 5500-SF was prepared for submission. Since the original Plan was closed with ADP, we could not submit the filing through the traditional method. ADP Retirement Services established an account for us through FIS Relius Government Forms to e-file with the Department of Labor. Unfortunately, the system had issues and was unable to submit the filing. We were not notified of the issue and believed the final Form 5500 was completed and submitted.

We respectfully request that the Department of Labor consider the facts and circumstances when evaluating our case and please allow us to file it now without incurring DOL civil penalties. We have demonstrated good faith and have been timely in all prior filings. This was simply a system issue on the part of FIS Relius Government Forms that was immediately addressed when you brought it to our attention.
